I. High Seas Drift Net (HSDN) Enforcement

There were no HSDN enforcement activities conducted during the reporting period.

II. U.S./Russian Maritime Boundary Line (MBL) Enforcement

There was low activity along the MBL from January through April with an average of 1 vessel detected within 20 miles of the MBL then in May activity increased with an average of 7 vessels detected within 20 miles of the MBL. There have been 2 detected incursions of up to 2 NM into the U.S. EEZ this season, both from the same vessel. D17 (dre) notified the Russian Boarder Guard, which issued administrative violations to the vessel.

III. U.S./Canadian EEZ Boundary (Dixon Entrance) Enforcement

There was light fishing activity during the reporting period along the U.S.-Canadian EEZ boundary in the vicinity of Dixon Entrance. All Canadian fishing vessels sighted were south of the A-B line and no incursions into U.S. waters were detected.


IV. Marine Protected Resources and Critical Habitat Enforcement

The Coast Guard monitors more than 151 critical habitat areas around Alaska each month as part of routine cutter and aircraft patrol activity. There were no requests or flights in support of marine protected resources during the reporting period.

V. Commercial Fishing Vessel Boarding Statistics


Figure 1. Fisheries Boardings By Year

There were 100 domestic fisheries and fishing vessel safety boardings conducted by the U.S. Coast Guard during the reporting period. These boardings resulted in a total of 9 safety violations onboard 8 vessels, and 4 fisheries violations onboard 4 vessels. Figures 1 and 2 show the historic trends for boardings and violations. Appendices B and C list the boardings which occurred during the reporting period.

VI. Halibut and Sablefish Enforcement

Coast Guard patrols completed 29 boardings on fishing vessels targeting halibut and sablefish during the reporting period. There were 16 boardings of IFQ halibut vessels, detecting 1 safety violation and 0 fisheries violations. There were 10 boardings of IFQ sablefish vessels, with 2 fisheries violations detected. There were 3 boardings of vessels targeting both IFQ halibut and sablefish, with no violations detected. There was 1 boardings on a charter vessel targeting halibut, with no violations detected. There were 31 boardings on recreational vessels targeting halibut, with 1 termination for significant safety concerns, 1 safety violation, and no fisheries violations detected.

VII. Crab Fisheries

Air Station Kodiak deployed an MH-60 and air crew to Cold Bay for the Bering Sea crab season. The MH-60 and air crew remained in Cold Bay from 15 January 2020 through 16 March 2020 for increased activity in the Bering Sea and Aleutian Island crab and trawl fisheries.

The CGC ALEX HALEY and DOUGLAS MUNRO conducted 5 boardings on fishing vessels targeting crab.

VIII. Continuing Operations During COVID-19

In the early onset of the Coronavirus epidemic, there was a significant decrease in boarding activity due to early risk assessments in conjunction with medical and industry measures. Based on efforts in industry, abiding by the Alaska State Health Mandates, and the Coast Guard's own safety and health guidance and policy, the Coast Guard has resumed all enforcement efforts and patrols with the exception of circumstances that arise on a case by case basis. The Coast Guard has taken very measured precautions to ensure the safety of its members and the public while carrying out its mission sets. Out of state Coast Guard cutters self-quarantine on board the ship for 14 days prior to interacting with the public. Any public interaction from boarding teams is done in accordance with CDC guidelines with social distancing and personal protective equipment. Boarding teams are also screened for high temperatures prior to leaving the ship to conduct a boarding.


Multiple Coast Guard members participate in the weekly AFISHC and Alaska Industry calls to mesh best practices and work with State and Industry to build a safe working environment. Swift and decisive measures taken by the fishing industry and the State of Alaska have all assisted with Coast Guard actions to maintain operational readiness.

IX. Commercial Fishing Vessel Safety/Search and Rescue Cases

During the reporting period, 14 safety violations were detected on 8 vessels. There were 4 voyage terminations due to expired survival craft, expired hydrostatic releases, expired visual distress signals, and not having buoyant apparatus. A comprehensive list of violations can be found in Appendix C.

There were 12 search and rescue (SAR) cases involving fishing vessels in U.S. waters. January-June there were 3 lives saved, 10 lives lost, and one vessel lost. Appendix A provides a comprehensive list of SAR cases involving fishing vessels over the reporting period.


Figure 3. Historical Overview of CFVS Statistics



Figure 5. Annual Major Cutter Days





Figure 6. Annual H60/65 Hours










Figure 8. Jan-Jun Major Cutter Days

1/1/2020	SCANDIES ROSE	COMDET Kodiak received a MAYDAY from F/V SCANDIES ROSE. Coast Guard C130, MH60, and cutter searched over 1,400 sqnm recovering two persons from a life raft.
1/27/2020	BOUNTIFUL	D17 received a medevac request for an injured crewmember. A Coast Guard MH60 evacuated the member and transferred them to St Paul.
2/10/2020	INDEPENDENCE	Sector Anchorage received a report of vessel taking on water. The Coast Guard diverted a cutter and a MH60. The MH60 lowered rescue swimmers and a pump to help control flooding. Cutter escorted vessel to Kodiak for repairs.
3/14/2020	ALASKAN DREAM	D17 received a medevac request for an injured crewmember. Member was hoisted by an MH60 and transferred to Kodiak.
3/16/2020	RASCAL	Sector Juneau received an overdue report for vessel. A Coast Guard MH60 located the vessel and confirmed no distress but loss of propulsion. AWT transported member to Petersburg.
3/19/2020	ALASKA MIST	D17 received a report of an unaccounted for person. Coast Guard utilized a MH65, Cutter, Small boat, and multiple good sam vessels in the search, with no results.
3/19/2020	SEA WOLF	D17 received a medevac request for a heart attack. A MH65 was diverted, member passed shortly after and MEDEVAC request was rescinded.
3/28/2020	TAMARACK	Sector Juneau received a report of a vessel taking on water. A Coast Guard MH60 lowered a pump to the vessel and a good sam assisted. Cutter escorted the vessel to Sitka.
4/16/2020	MARIA SA	Sector Anchorage received a report of vessel without propulsion. A Cutter and good sam diverted to assist the vessel.
4/19/2020	GOLDEN CHALICE	Sector Juneau received a report of a vessel run aground. A Coast Guard cutter arrived on scene, contacted the vessel and stayed on scene until vessel was able to refloat and verify no further assistance
