#### I. IUU Fishing & High Seas Drift Net (HSDN) Enforcement

The Coast Guard supported Operation North Pacific Guard during this period with three 6-day C-130 deployments from Japan, totaling 42 hours of air patrol. The flights detected at least 5 potential violations, two of which were serious shark finning violations, and referred them to the Regional Fisheries Management Organization and flag state for disposition. A two-person Coast Guard boarding team supported Fisheries and Oceans Canada (DFO) aboard the Atlantic Condor, conducting 19 boardings under North Pacific Fisheries Commission (NPFC) and Western and Central Pacific Fisheries Commission (WCPFC) authorities. The 58 day deployment of Atlantic Condor identified 20 potential violations of Conservation Management Measures pertaining to shark finning, pollution, transshipment and vessel markings requirements. There were no detected HSDN fishing activities during this period.

#### II. U.S./Russian Maritime Boundary Line (MBL) Enforcement

The increased FF/V activity along the MBL continued it's increasing trend through the summer. Over the period of this report, there were seven detections of FF/V's suspected to be fishing across the MBL in the U.S. EEZ. Due to the increased FF/V activity near the MBL, Coast Guard District 17 has continued surface and air patrols along the MBL to deter and detect incursions. Coast Guard District 17 informed the Russian Border Guard of the suspected incursions.

#### III. U.S./Canadian EEZ Boundary (Dixon Entrance) Enforcement

There was light fishing activity during the reporting period along the U.S.-Canadian EEZ boundary in the vicinity of Dixon Entrance. All Canadian fishing vessels sighted were south of the A-B line and no incursions into U.S. waters were detected.

#### **IV. Marine Protected Resources and Critical Habitat Enforcement**

The Coast Guard monitors 151 critical habitat areas around Alaska each month as part of routine cutter and aircraft patrol activity. June 2<sup>nd</sup>, 13<sup>th</sup>, 19<sup>th</sup>, July 11<sup>th</sup>, 17<sup>th</sup>, August 1<sup>st</sup>, and 29<sup>th</sup>, all had NOAA marine protected resource sorties scheduled with aircraft from Air Station Kodiak and Aviation Support Facility Cordova.

#### V. Commercial Fishing Vessel Boarding Statistics

There were 31 boardings conducted on commercial fishing vessels by the U.S. Coast Guard during the reporting period. These boardings resulted in a total of nine fisheries violations onboard eight vessels. Appendices B and C list the boardings with violations that occurred during the reporting period.

#### VI. Halibut and Sablefish Enforcement

Coast Guard patrols completed 180 boardings on commercial, charter, and recreational vessels targeting halibut and sablefish during the reporting period. Of these boardings, 19 were commercial IFQ halibut or sablefish vessels resulting in three fisheries violations on two vessels. Charter halibut vessels constituted 47 boardings resulting in three fisheries violations. Recreational vessels targeting halibut constituted 105 boardings resulting in two fisheries violations.

#### VII. Forward Operating Locations (FOL)

Air Station Kodiak completed the deployment of one MH-65 to Cordova on September 30<sup>th</sup> for Gulf of Alaska/Prince William Sound SAR coverage. FOL Kotzebue was open July 1<sup>st</sup> through September 30<sup>th</sup> with two MH-60 for Arctic and Bering Sea SAR coverage.

#### VIII. Crab Fisheries

Coast Guard units conducted no boardings on fishing vessels targeting crab in the Bering Sea during this period.

#### IX. Commercial Fishing Vessel Safety/Search and Rescue Cases

There were 21 search and rescue (SAR) cases involving fishing vessels in U.S. waters, resulting in eight lives saved and two vessels lost during the reporting period. Appendix A provides a comprehensive list of SAR cases involving fishing vessels over the reporting period.

During the reporting period, 84 safety violations were detected on 29 commercial fishing vessels, six resulted in voyage terminations. A comprehensive list of safety violations can be found in Appendix B.





Figure 1. Historical Overview of CFVS/SAR Statistics




#### Figure 2. Annual HC-130 Hours



#### Figure 3. Annual Major Cutter Days







#### Figure 5. Annual Patrol Boat Hours to date
