REPORT TO THE NORTH PACIFIC FISHERIES MANAGEMENT COUNCIL
CONCERNING COAST GUARD FCMA ENFORCEMENT

1. Recent FCMA Infractions. Since the last Council meeting, two reports of violations (civil penalty procedures) and six citations (written warnings) have been issued. A brief summary of each infraction is as follows:

- a. 21 August. The Japanese longliner EBISU MARU No. 88 was issued a citation by USCGC MORGENTHAU for failure to properly maintain cumulative catch log by not logging discards.
- b. 9 September. The South Korean trawler DONGSAN HO was issued a citation by USCGC MORGENTHAU for failure to log cumulative catch by area.
- c. 10 September. The Japanese Danish seiner AKATSUKI MARU No. 1 was issued a citation by the USCGC MORGENTHAU for failure to provide a safe boarding ladder and for not having its IRCS clearly legible on the hull.
- d. 10 September. The Soviet trawler KORENGA was issued a citation by USCGC MORGENTHAU for failure to submit an area shift report and for failure to log daily and cumulative catch.
- e. 10 September. The Soviet trawler SAKHALIN was issued a report of violation by USCGC MORGENTHAU for failure to return prohibited species to the sea in a timely manner. (King crab and Tanner crab).
- f. 11 September. The Soviet trawler MYS BELKINA was issued a citation by USCGC MORGENTHAU for failure to log daily cumulative catch to the nearest tenth of a metric ton.
- g. 11 September. The Soviet trawler TYMLAT was issued a report of violation by USCGC MORGENTHAU for failure to return incidental catch of prohibited species (Tanner crab) to the sea in a timely manner.
- h. 15 September. The South Korean trawler DAE SUNG HO was issued a citation by USCGC MORGENTHAU for failure to maintain a continuous cumulative catch log for catches this year.
