I. IUU Fishing & High Seas Drift Net (HSDN) Enforcement

The Coast Guard kicked off Operation North Pacific Guard (NPG) 2022 and began conducting FF/V boardings on the High Seas under North Pacific Fisheries Commission (NPFC) and Western and Central Pacific Fisheries Commission (WCPFC) authorities. There were no detected HSDN fishing activities during this period. The Coast Guard conducted ten FF/V boardings finding eleven violations, and seven Peoples' Republic of China fishing vessel refused a boarding, which is a serious violation of NPFC Conservation and Management Measures.

II. U.S./Russian Maritime Boundary Line (MBL) Enforcement

Foreign F/V activity along the MBL increased dramatically in May. In April, there was less than one vessel per day along the MBL, increasing to an average of 15 vessels per day at the end of May. There have been numerous detections of Russian Longline fishing vessels briefly crossing into the U.S. EEZ, but no clear evidence that they were fishing in U.S. waters. There is strong evidence that one Russian Trawl vessel repeatedly entered the U.S. EEZ. As a result, the Coast Guard increased surface and air presence along the MBL to deter future incursions. Additionally, the Coast Guard communicated these incursions to the Russian Border Guard for further action.

III. U.S./Canadian EEZ Boundary (Dixon Entrance) Enforcement

There was light fishing activity during the reporting period along the U.S.-Canadian EEZ boundary in the vicinity of Dixon Entrance. All Canadian fishing vessels sighted were south of the A-B line and no incursions into U.S. waters were detected.

IV. Marine Protected Resources and Critical Habitat Enforcement

The Coast Guard monitors 151 critical habitat areas around Alaska each month as part of routine cutter and aircraft patrol activity. On May 6, 2022 Air Station Kodiak conducted a scheduled Copper River Marine Mammal Survey flight in support of NOAA Protected Resources Division (PRD). On May 10, 2022 Air Station Sitka conducted a scheduled Marine Mammal Survey flight in support of NOAA PRD. On May 17 and 19, 2022 Air Station Sitka conducted two flights for NOAA PRD to search for a reported deceased humpback whale in Sitka Sound. On May 19, 2022 NOAA PRD sent a request for a Broadcast Notice to Mariners for an entangled whale. Due to a communications breakdown, the Broadcast Notice to Mariners was not made. On May 13, 2022 Air Station Kodiak conducted a marine mammal carcass survey flight at NOAA PRD's request.

V. Commercial Fishing Vessel Boarding Statistics





Figure 2. Fisheries Violations by Year

There were 167 federal fisheries boardings conducted by the U.S. Coast Guard during the reporting period. These boardings resulted in a total of four fisheries violations onboard four vessels. Figures 1 and 2 show the historic trends for boardings and violations. Appendices B and C list the boardings that occurred during the reporting period.

Figure 1. Fisheries Boardings By Year

VI. Halibut and Sablefish Enforcement

Coast Guard patrols completed 159 boardings on commercial, charter, and recreational vessels targeting halibut and sablefish during the reporting period. 65 boardings were of IFQ halibut or sablefish vessels resulting in four fisheries violations on four vessels. Five boardings were of Charter halibut vessel resulting in zero fisheries violations. 89 boardings were of recreational halibut vessels targeting halibut resulting in zero fisheries violations.

VII. Forward Operating Locations

Air Station Kodiak deployed one MH-60 to Cold Bay on 06 May for Bering Sea SAR coverage and law enforcement for 26 days. Air Station Kodiak deployed one MH-60 and/or one MH-65 to Cordova on 14 April for Gulf of Alaska/Prince William Sound SAR coverage and law enforcement for 47 days.

VIII. Crab Fisheries


Coast Guard units conducted one boardings on a fishing vessel targeting Tanner crab in the Bering Sea.

IX. Commercial Fishing Vessel Safety/Search and Rescue Cases

During the reporting period, 16 safety violations were detected on 10 vessels. A comprehensive list of violations can be found in Appendix C.

There were five search and rescue (SAR) cases involving fishing vessels in U.S. waters, resulting in one lives saved, no lives lost, and no vessels lost during the reporting period. Appendix A provides a comprehensive list of SAR cases involving fishing vessels over the reporting period.

Figure 4. Annual HC-130 Hours





Figure 5. Annual Major Cutter Days

Figure 6. Annual H60/65 Hours




Figure 7. Annual Patrol Boat Hours




Figure 8. April - May Major Cutter Days





Figure 9. April - May Patrol Boat Hours
