Operational Highlights



Multi-agency observer focused Pulse Operation in early March in Dutch Harbor by OLE, CBP, Unalaska PD, AWT, and USCG.

Enforcement Officers partnered with the USCG onboard the cutters MELON and SHERMAN to conduct two at sea patrols totaling over three weeks.



An EO conducted a 10-day joint enforcement patrol in January onboard the Alaska Wildlife Trooper PV Stimson. Two Grand Jury subpoenas served, six vessels boarded, and a processing plant in Sand Point inspected

Multi-Agency Observer Operations

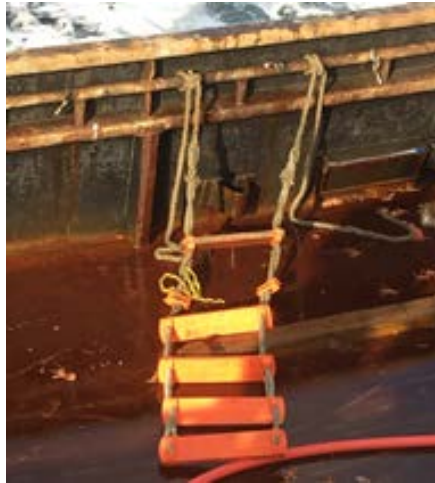
AKD conducted two observer focused patrols in March. The first took place in Dutch Harbor and Akutan assisted by the USCG, Unalaska Police Department, and CBP.

- 313 separate observer incidents, involving 98 different vessels.
- 153 incidents resolved through compliance assistance or enforcement action.
- 103 not addressed because vessel or individual not encountered during the operation.

Second observer patrol was with AWT aboard the P/V Stimson - 5 remote ports visited, 3 federal shoreside processors inspected, 24 vessels boarded, two of which were foreign vessels.

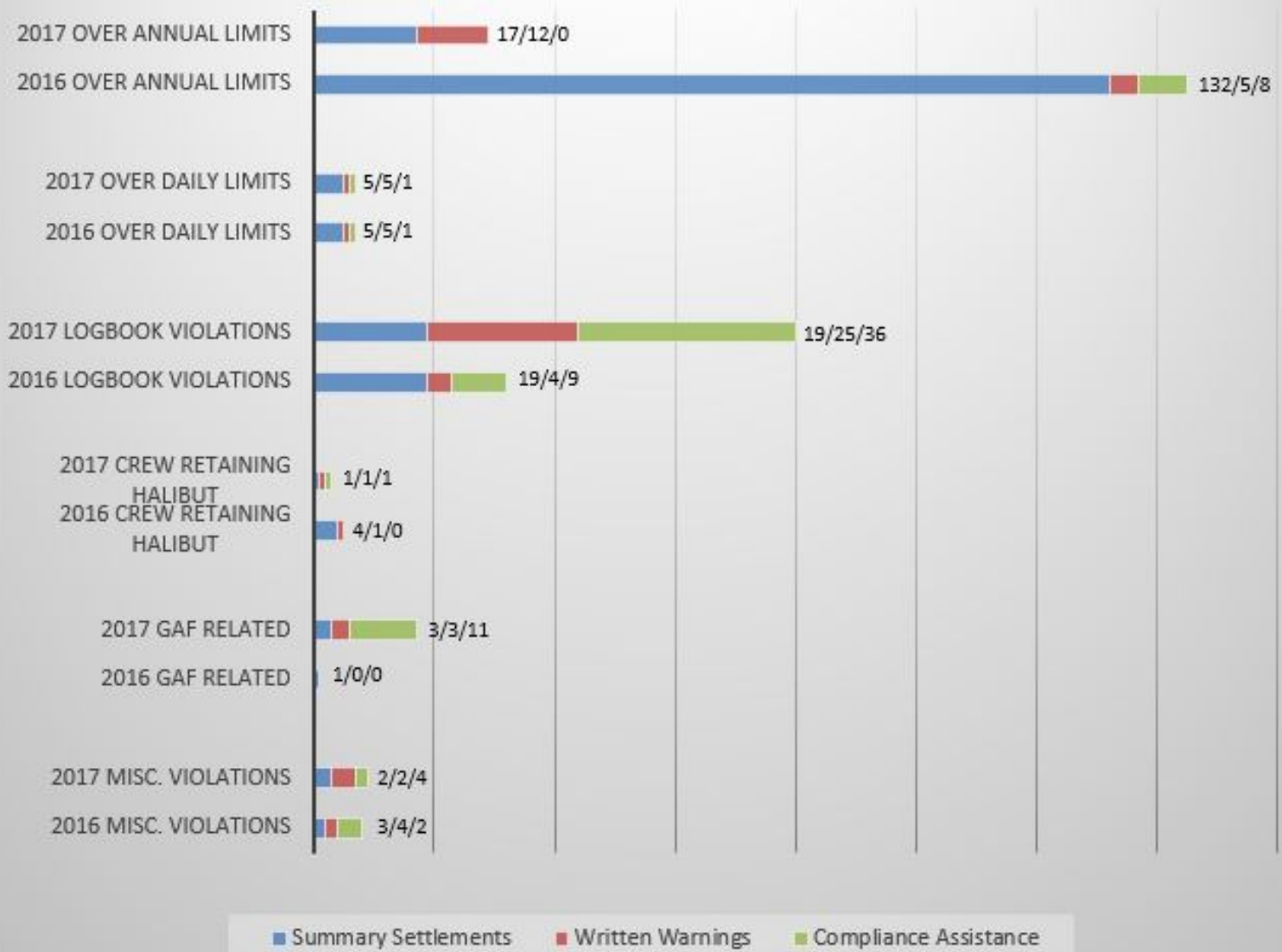


Joint Enforcement Agreement

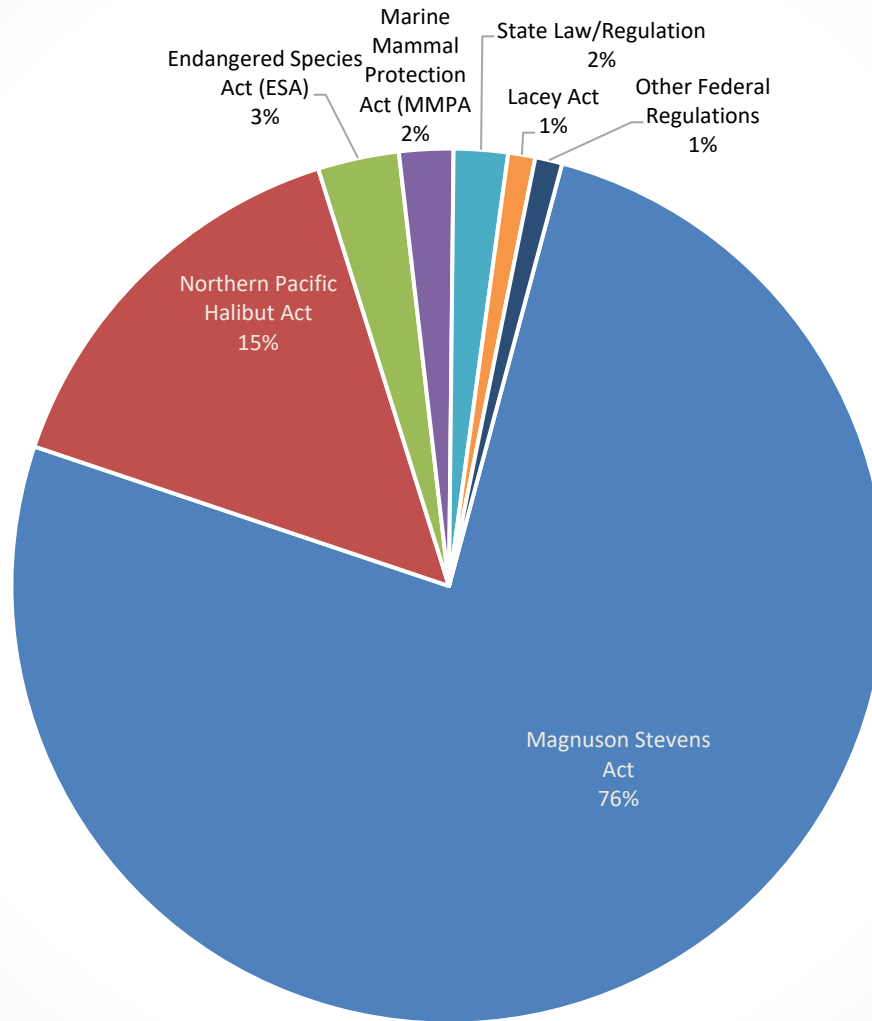

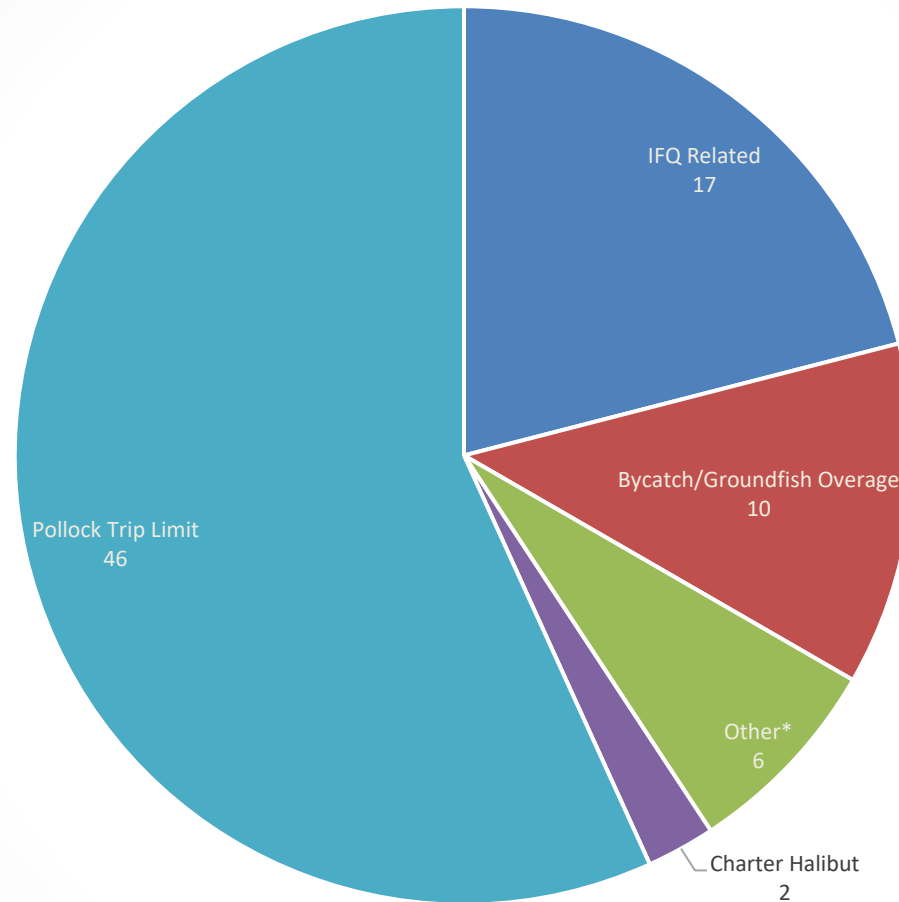
Charter Halibut Enforcement Actions CY 2016 v. 2017



Incidents by Law/Program/Regulation

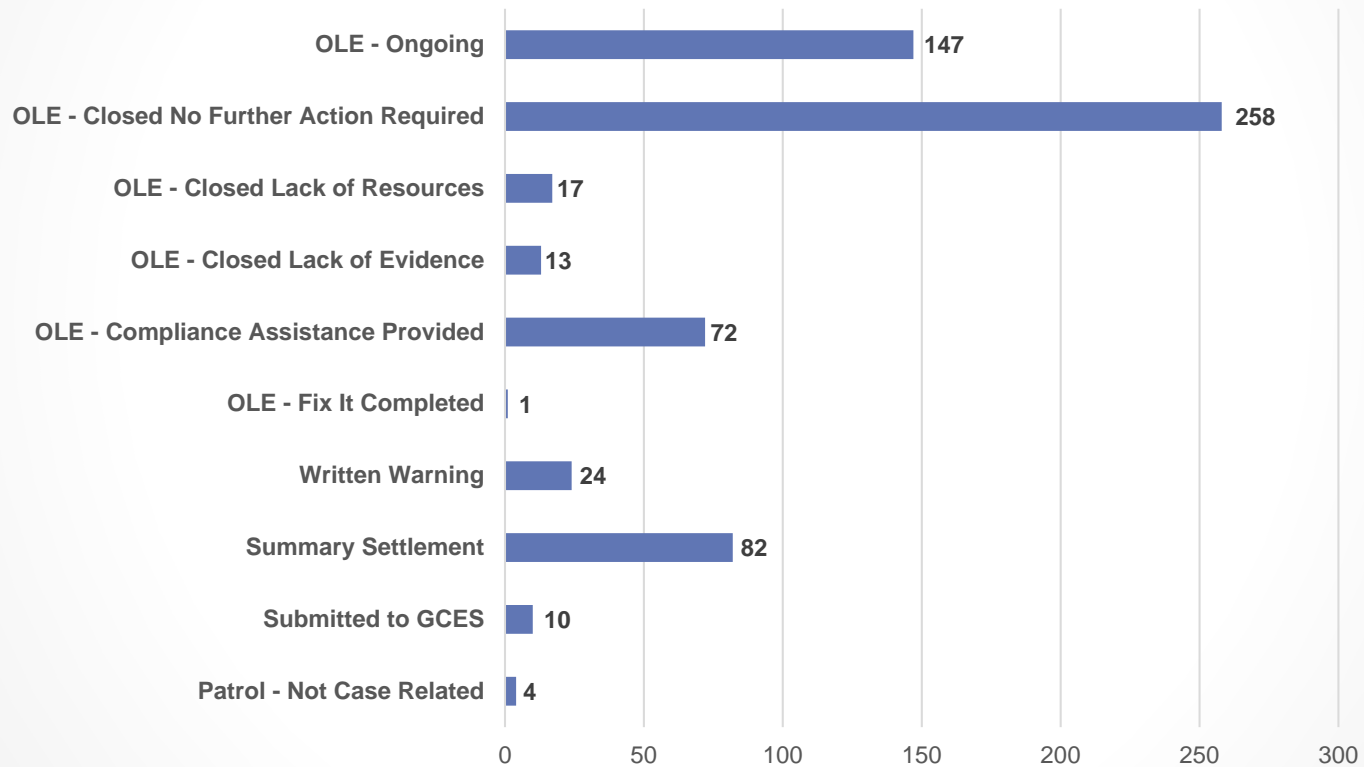
