Mr. Sullivan (for himself, Ms. Cantwell, and Ms. Murkowski) introduced the following bill; which was read twice and referred to the Committee on Commerce, Science, and Transportation

A BILL

To establish the American Fisheries Advisory Committee to assist in the awarding of fisheries research and development grants, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "American Fisheries
- 5 Advisory Committee Act".
- 6 SEC. 2. AMERICAN FISHERIES ADVISORY COMMITTEE.
- 7 (a) Establishment.—Section 2 of the Act of Au-
- 8 gust 11, 1939 (15 U.S.C. 713c-3), is amended by adding
- 9 at the end the following:

| 3 | "(A) COMMITTEE.—The term 'Committee' |
| 4 | means the American Fisheries Advisory Com- |
| 5 | mittee established under paragraph (2). |
| 6 | "(B) FISHING COMMUNITY.—The term |
| 7 | 'fishing community' means harvesters, market- |
| 8 | ers, growers, processors, recreational fishermen, |
| 9 | charter fishermen, and persons providing them |
| 10 | with goods and services. |
| 11 | "(C) Marketing and Promotion.—The |
| 12 | term 'marketing and promotion' means an ac- |
| 13 | tivity aimed at encouraging the consumption of |
| 14 | seafood or expanding or maintaining commer- |
| 15 | cial markets for seafood. |
| 16 | "(D) Processor.—The term 'processor' |
| 17 | means any person in the business of preparing |
| 18 | or packaging seafood (including seafood of the |
| 19 | processor's own harvesting) for sale. |
| 20 | "(E) Seafood.—The term 'seafood' |
| 21 | means farm-raised and wild-caught fish, shell- |
| 22 | fish, or marine algae harvested in the United |
| 23 | States or by a United States flagged vessel for |
| 24 | human consumption. |

| 1 | "(2) Establishment.—Not later than 90 days |
|----|---|
| 2 | after the date of the enactment of the American |
| 3 | Fisheries Advisory Committee Act, the Secretary |
| 4 | shall establish 6 regions within the American Fish- |
| 5 | eries Advisory Committee as follows: |
| 6 | "(A) Region 1 shall consist of Alaska, Ha- |
| 7 | waii, the Commonwealth of the Northern Mar- |
| 8 | iana Islands, and the Territories of Guam and |
| 9 | American Samoa. |
| 10 | "(B) Region 2 shall consist of Maine, New |
| 11 | Hampshire, Massachusetts, Rhode Island, and |
| 12 | Connecticut. |
| 13 | "(C) Region 3 shall consist of Texas, Ala- |
| 14 | bama, Louisiana, Mississippi, Florida, Arkan- |
| 15 | sas, Puerto Rico, and territory of the Virgin Is- |
| 16 | lands. |
| 17 | "(D) Region 4 shall consist of California, |
| 18 | Washington, Oregon, and Idaho. |
| 19 | "(E) Region 5 shall consist of New Jersey, |
| 20 | New York, Delaware, Maryland, Virginia, |
| 21 | North Carolina, South Carolina, and Georgia. |
| 22 | "(F) Region 6 shall consist of Michigan, |
| 23 | Minnesota, Wisconsin, Illinois, Indiana, Ohio, |
| 24 | and Pennsylvania. |

| 1 | "(3) Membership.—The Committee shall be |

| 2 | composed of the following members: |
| 3 | "(A) REGIONAL REPRESENTATION.—Each |
| 4 | of the regions listed in subparagraphs (A) |
| 5 | through (F) of paragraph (2) shall be rep- |
| 6 | resented on the Committee by 3 members— |
| 7 | "(i) who are appointed by the Sec- |
| 8 | retary; |
| 9 | "(ii) who reside in a State or territory |
| 10 | in the region that the member will rep- |
| 11 | resent; |
| 12 | "(iii) of which— |
| 13 | "(I) one shall have experience as |
| 14 | a seafood harvester; |
| 15 | "(II) one shall have experience as |
| 16 | a processor; and |
| 17 | "(III) one shall have experience |
| 18 | as a recreational fisher; and |
| 19 | "(iv) that are selected so that the |
| 20 | members of the Committee have experience |
| 21 | or expertise with as many seafood species |
| 22 | as practicable. |
| 23 | "(B) AT-LARGE MEMBERS.—The Secretary |
| 24 | shall appoint to the Committee at-large mem- |
| 25 | bers to ensure that the Committee fairly re- |

| 1 | flects the expertise and interest of the fishing |

| 2 | community located in each region, as follows: |
| 3 | "(i) One individual with experience in |
| 4 | mass market food distribution. |
| 5 | "(ii) One individual with experience in |
| 6 | mass market food retail or food service. |
| 7 | "(iii) One individual with experience |
| 8 | in the marketing of seafood. |
| 9 | "(iv) One individual with experience |
| 10 | in growing seafood. |
| 11 | "(v) One individual with experience as |
| 12 | a recreational fisher. |
| 13 | "(vi) One individual who is an em- |
| 14 | ployee of the National Marine Fisheries |
| 15 | Service with expertise in fisheries research. |
| 16 | "(vii) One individual that represents |
| 17 | the fisheries science community. |
| 18 | "(4) Member terms.—The term for a member |
| 19 | of the Committee shall be 3 years, except that the |
| 20 | Secretary shall designate staggered terms for the |
| 21 | members initially appointed to the Committee. |
| 22 | "(5) Responsibilities.—The Committee shall |
| 23 | be responsible for— |

| 1 | "(A) identifying needs of the fishing com- |

| 2 | munity that may be addressed by a project |
| 3 | funded with a grant under subsection (c); |
| 4 | "(B) developing the request for proposals |
| 5 | for such grants; |
| 6 | "(C) reviewing applications for such |
| 7 | grants; and |
| 8 | "(D) selecting applications for approval |
| 9 | under subsection $(c)(2)(B)$. |
| 10 | "(6) Chair.—The Committee shall elect a chair |
| 11 | by a majority of those voting, if a quorum is |
| 12 | present. |
| 13 | "(7) QUORUM.—A simple majority of members |
| 14 | of the Committee shall constitute a quorum, but a |
| 15 | lesser number may hold hearings. |
| 16 | "(8) Meetings.— |
| 17 | "(A) Frequency.—The Committee shall |
| 18 | meet not more than 2 times each year. |
| 19 | "(B) Location.—The meetings of the |
| 20 | Committee shall rotate between the geographic |
| 21 | regions described under paragraph (2). |
| 22 | "(9) Staff.—The Committee may employ staff |
| 23 | as necessary. |
| 24 | "(10) Per diem and expenses and fund- |
| 25 | ING.— |

| 1 | "(A) IN GENERAL.—A member of the |

| 2 | Committee shall serve without compensation, |
| 3 | but shall be reimbursed in accordance with sec- |
| 4 | tion 5703 of title 5, United States Code, for |
| 5 | reasonable travel costs and expenses incurred in |
| 6 | performing duties as a member of the Com- |
| 7 | mittee. |
| 8 | "(B) Funding.—The reimbursements |
| 9 | made under subparagraph (A) shall be paid |
| 10 | with the funds made available for grants under |
| 11 | subsection (c). |
| 12 | "(11) Conflict of interest.—The conflict of |
| 13 | interest and recusal provisions set out in section |
| 14 | 302(j) of the Magnuson-Stevens Fishery Conserva- |
| 15 | tion and Management Act (16 U.S.C. 1852(j)) shall |
| 16 | apply to any decision by the Committee and to all |
| 17 | members of the Committee as if each member of the |
| 18 | Committee is an affected individual within the mean- |
| 19 | ing of such section 302(j), except that in addition to |

the disclosure requirements of section 302(j)(2)(C)

of such Act (16 U.S.C. 1852(j)(2)(C)), each member

of the Committee shall disclose any financial interest

| 4 | (b) Role in Approval of Grants.—Section |
| 5 | 2(c)(3) of the Act of August 11, 1939 (15 U.S.C. 713c- |
| 6 | 3(e)(3)), is amended to read as follows: |
| 7 | "(3)(A) No application for a grant under this sub- |
| 8 | section may be approved unless— |
| 9 | "(i) the Secretary is satisfied that the ap- |
| 10 | plicant has the requisite technical and financial |
| 11 | capability to carry out the project; |
| 12 | "(ii) the Secretary evaluates the proposed |
| 13 | project as to— |
| 14 | "(I) the selections of the Committee |
| 15 | established in subsection (f); |
| 16 | "(II) soundness of design; |
| 17 | "(III) the possibilities of securing pro- |
| 18 | ductive results; |
| 19 | "(IV) minimization of duplication with |
| 20 | other fisheries research and development |
| 21 | projects; |
| 22 | "(V) the organization and manage- |
| 23 | ment of the project; |

| 10 | "(B) Justification.—If the Secretary fails to |
| 11 | provide funds to a grant selected by the Committee, |
| 12 | the Secretary shall provide a written document to |
| 13 | the Committee justifying the decision.". |
| 14 | SEC. 3. PUBLIC AVAILABILITY OF GRANTS PROPOSALS. |
| 15 | Section 2(e) of the Act of August 11, 1939 (15 |
| 16 | U.S.C. 713c-3(c)), is amended by adding at the end the |
| 17 | following: |
| 18 | "(6) Any person awarded a grant under this |
| 19 | subsection shall make publicly available a title and |
| 20 | abstract of the project to be carried out by the grant |
| 21 | funds that serves as the public justification for fund- |
| 22 | ing the project that includes a statement describing |
| 23 | how the project serves to enhance United States |
| 24 | fisheries, including harvesting, processing, mar- |

- 1 keting, and associated infrastructures, if applica-
- 2 ble.".
