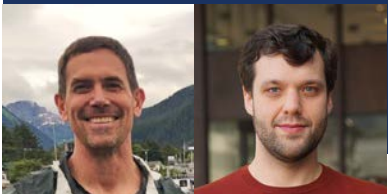

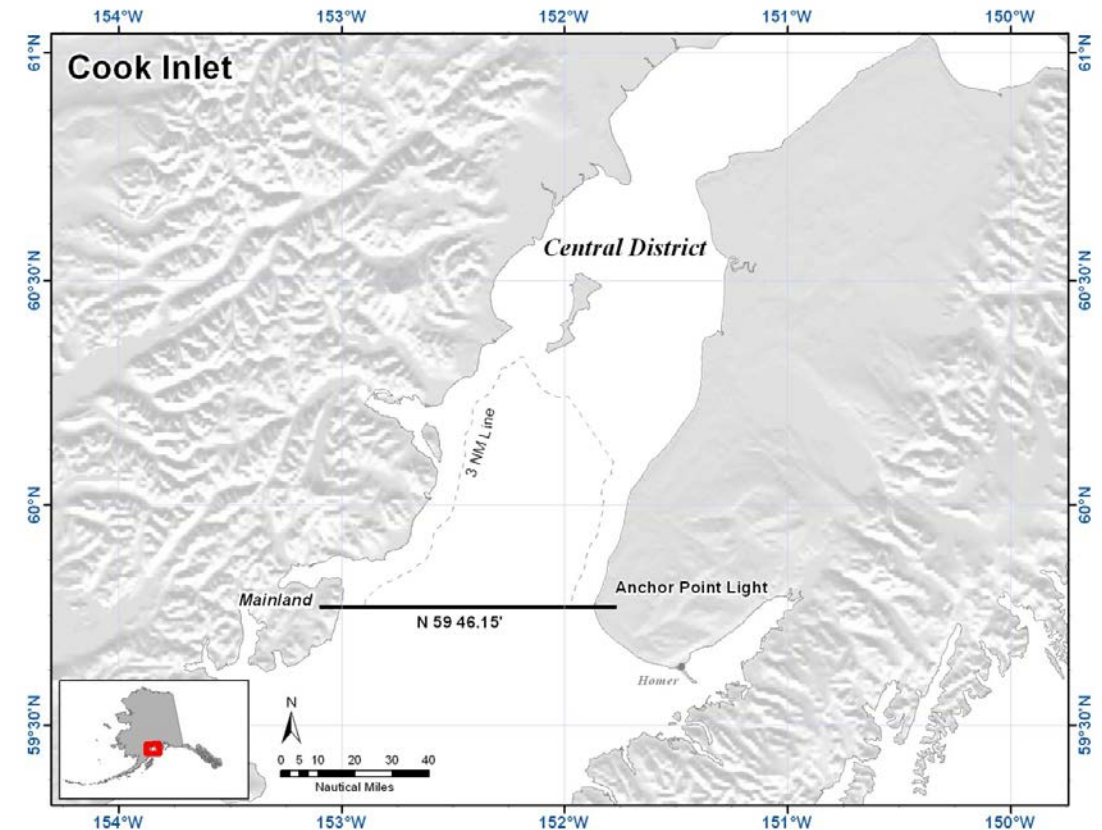

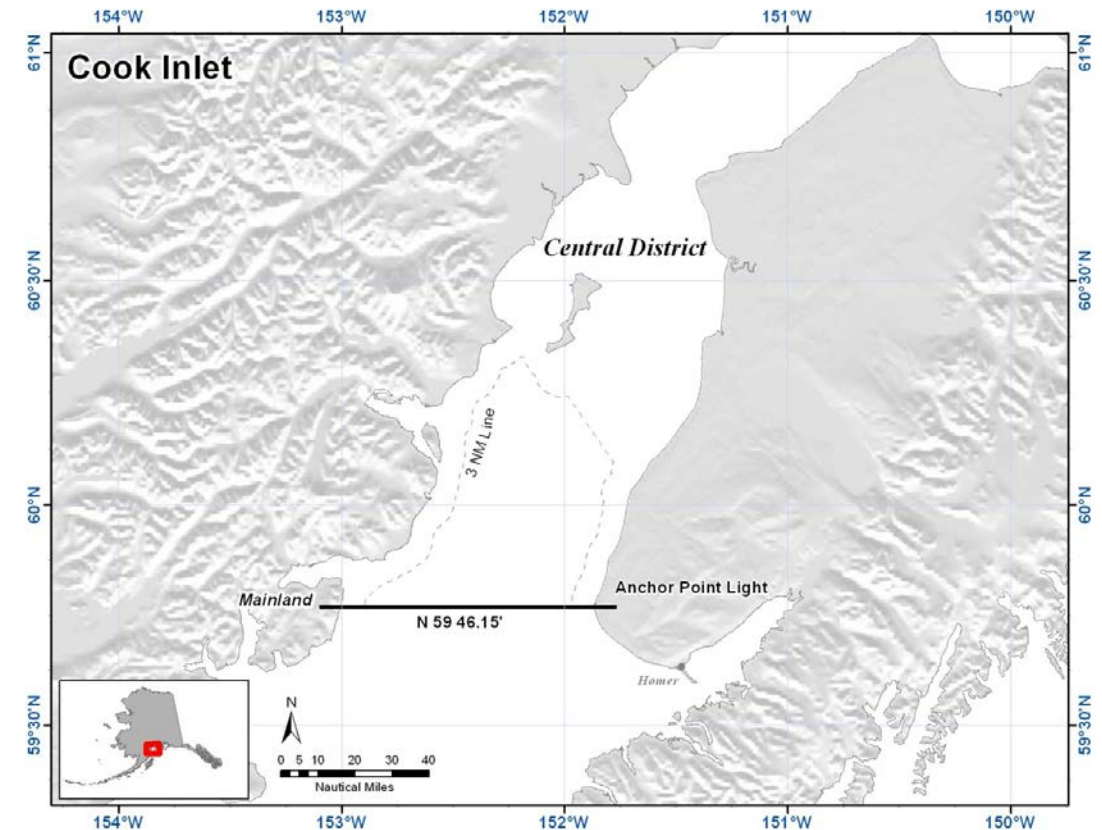
PRELIMINARY REVIEW ACTION

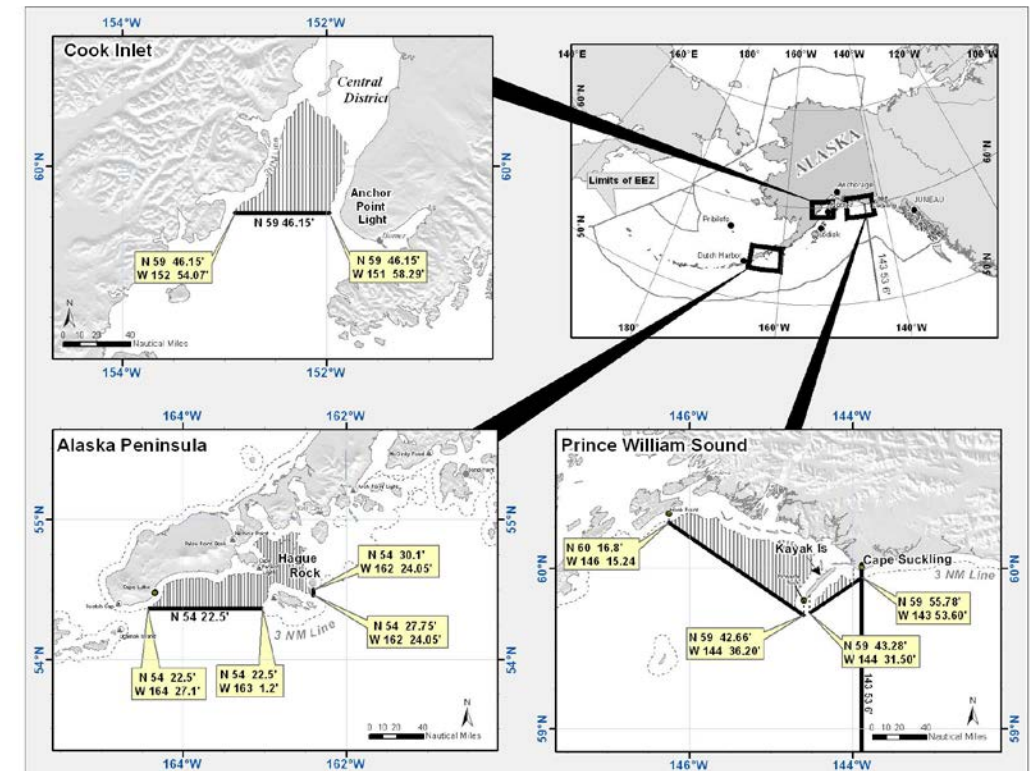

BACKGROUND

- Dec 2012 Amendment 12
 - Updated FMP to comply with the MSA
 - Removed Cook Inlet, PWS, S.AK Pen.
- Jan 2013 UCIDA Lawsuit
- Sep 2016 9th Circuit rules in favor of Plaintiffs
- Apr 2017 Council initiates action
- Jan 2020 Court orders Dec 31, 2020 deadline



DRAFT PURPOSE AND NEED (DEC 2019)

*The Council intends to amend the Salmon FMP to **manage the traditional net fishing area that occurs in Federal waters of Cook Inlet**. Federal management in an FMP must meet the Magnuson-Stevens Act required provisions for an FMP in section 303(a) and related Magnuson-Stevens Act provisions. This proposed action is necessary to bring the Salmon FMP into compliance with the Magnuson-Stevens Act consistent with the recent Ninth Circuit ruling and the Judgement of the District Court in UCIDA et al., v. NMFS.*



DRAFT ALTERNATIVE I

- **Alternative I: No Action.**
 - *No amendment to the Salmon FMP. This alternative would maintain status quo. Alternative I is not a viable alternative given the Ninth Circuit decision, however, NEPA requires that Federal agencies analyze a no action alternative.*



DRAFT ALTERNATIVE 2

- **Alternative 2:** *Federal management with specific management measures delegated to the State.*
 - *Amend the Salmon FMP to include the Cook Inlet EEZ in the FMP's fishery management unit in the West Area and establish a Federal management regime for these salmon fisheries that delegates specific management measures to the State of Alaska, to use existing State salmon management infrastructure, in compliance with the Magnuson-Stevens Act and Ninth Circuit ruling. Alternative 2 would identify the management measures that would be managed by the Council and NMFS, the management measures that would be delegated to the State to manage with Federal oversight, and the process for delegation and oversight of management.*



DRAFT ALTERNATIVE 3

- **Alternative 3: Federal management.**
 - *Amend the Salmon FMP to include the Cook Inlet EEZ in the FMP's fishery management unit in the West Area and apply Federal management to those portions of the fisheries that occur in the EEZ.*

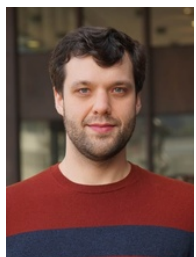
ACTION

- The Council is reviewing Cook Inlet Salmon Committee recommendations and finalizing Alternatives



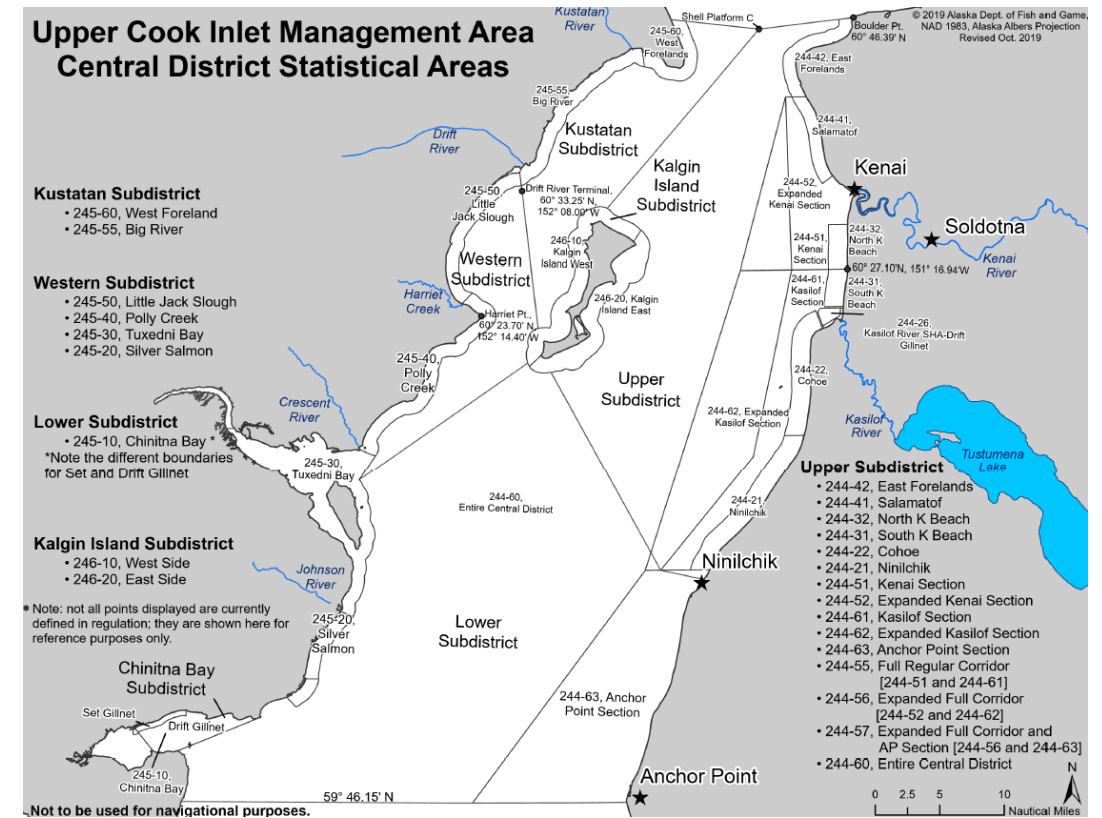
ALTERNATIVES AND PRELIMINARY ANALYSIS

- Alternative 1 – status quo – management deferred to the state
 - Alternative 2 – management measures delegated to the state
 - Alternative 3 – federal management

- Draft EA focuses on preliminary information under existing conditions. Additional information and analysis provided after alternatives selected.



GENERAL IMPACTS

- Overall salmon removals (state and federal waters)
- Spawning escapement
- Salmon availability as prey and ecosystem considerations
- Location/timing of fishery
- Potential for gear interaction with marine mammals and seabirds

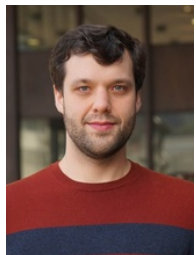

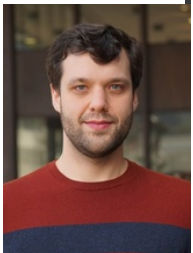

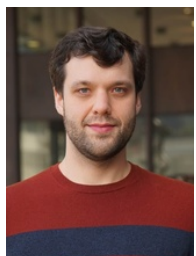


ESSENTIAL FISH HABITAT (3.7, PAGE 129)

- Drift gillnet gear in Cook Inlet has minimal to no contact with EFH substrates
- Recreational troll gear has minimal to no contact with EFH substrates
- No Habitat Area of Particular Concern overlap
- Minimal, temporary, or no effect expected
