### Research priorities

- SSC requested Plan Team input on 3-4 research priorities
- FEP Team wanted to reflect priorities from the action modules:
  - LK and TK data collection.
  - Climate change: Develop predictive tools to inform management options related to resilience and adaptation.
  - Conduct an assessment of the Council's Bering Sea management with respect to EBFM best practices.

- 2019: recommended development of an Ecosystem Health Report
  - Organized around the Council's 6 ecosystem goals and the 17 ecosystem objectives
  - Should be developed in partnership between the FEP Team and other Plan Teams, the ESR team, the SSC, the Council process generally
  - FEP Team workgroup (led by Ebett Siddon) to work on an initial framework proposal

• 2019: recommended development of an Ecosystem Health Report

- Draft Ecosystem Health Report Card available for FEP team meeting May 2021.
- SSC, Eco Committee, AP, Council feedback in June or October 2021.
- Completed by end of 2021.
- Rollout in Feb 2022 (part of Council ecosystem workshop?)

#### BS FEP Team timeline 2021-2022

Jan/Feb 2021: Taskforce and FEP Team chairs report to Ecosystem Committee/Council bodies on progress to

date.

**May 2021:** FEP team meets. Check-in on progress with Taskforces, and workshop on the Health Report

Card. Brainstorm on emerging issues that might be future action modules (but no "new"

deliverables).

**Jun - Dec 2021:** Complete draft health report card by end of 2021, with potential check-ins with Council bodies

in June or October. Taskforces working on products in parallel.

**Feb 2022:** Possibly in coordination with Council workshop, review progress of FEP team overall, and get

stakeholder/Council body input on new action modules or other new activities in a workshop

setting.

Mar-May 2022: FEP 2022 annual meeting, monitor existing tasks and develop plans for new tasks arising from

workshop or other Council body recommendations.
