I. High Seas Drift Net (HSDN) Enforcement

There were no HSDN enforcement activities conducted during the reporting period.

II. U.S./Russian Maritime Boundary Line (MBL) Enforcement

There was low activity along the MBL from April through 15 May with an average of less than one vessel detected within 20 miles of the MBL. The Russian "B" season pollock opener occurred on 15 May and since then there has been a significant increase in activity, with an average of 15 vessels detected within 20 miles of the MBL. There have been no detected incursions by FFVs into the U.S. EEZ this season.

On 23 May 2019, the USCGC ALEX HALEY and the Russian Border Guard Directorate Cutter SAKHALIN conducted a joint patrol of the MBL which included rendering honors, formation steaming, a USCG C-130 flyover, and a flag signaling exercise that lasted two hours.

III. U.S./Canadian EEZ Boundary (Dixon Entrance) Enforcement


There was light fishing activity during the reporting period along the U.S.-Canadian EEZ boundary in the vicinity of Dixon Entrance. All Canadian fishing vessels sighted were south of the A-B line and no incursions into U.S. waters were detected.

IV. Marine Protected Resources and Critical Habitat Enforcement


The Coast Guard monitors more than 151 critical habitat areas around Alaska each month as part of routine cutter and aircraft patrol activity. Between 16-19 May 2019, a MH-60 sighted and collected tissue samples of a dead gray whale carcass on a barrier island near Cordova. On 22 May, the same MH-60 crew flew two NMFS Protected Resources Division biologists on a Copper River Delta carcass survey flight where they sighted and took tissue samples from a harbor seal and sea otter.

V. Commercial Fishing Vessel Boarding Statistics

There were 164 domestic fisheries and fishing vessel safety boardings conducted by the U.S. Coast Guard during the reporting period. These boardings resulted in a total of 21 safety violations and 2 fisheries violations onboard 13 vessels. Figures 1 and 2 show the historic trends for boardings and violations. Appendices B and C list the boardings which occurred during the reporting period.

VI. Halibut and Sablefish Enforcement

Coast Guard patrols completed 124 boardings on fishing vessels targeting halibut and sablefish during the reporting period. There were 47 boardings of IFQ halibut vessels, detecting 3 safety violations and no fisheries violations. There were 13 boardings of IFQ sablefish vessels, with no violations detected. There were 37 boardings of vessels targeting both IFQ halibut and sablefish, with no violations detected. No voyages were terminated for significant safety concerns.

There were no boardings on charter vessels targeting halibut. There was one boarding on recreational vessels targeting halibut, detecting no fisheries violations. No voyages were terminated for significant safety concerns.

VII. Forward Operating Location


Air Station Kodiak deployed an MH-60 to Cordova on 01 May to support the increase in fishing vessel activity in the Gulf of Alaska. There is a helicopter crew staged there from 01 May through 30 September each year to increase Search and Rescue coverage and support Law Enforcement and Protected Living Marine Resources.

VIII. Commercial Fishing Vessel Safety/Search and Rescue Cases

During the reporting period, 21 safety violations were detected on 12 vessels. There were 2 voyage terminations due to expired life rafts and expired EPIRBs on both vessels. A comprehensive list of violations can be found in Appendix C.

There were 6 search and rescue (SAR) cases involving fishing vessels in U.S. waters, resulting in 14 lives saved, zero lives lost, and two vessels lost. Appendix A provides a comprehensive list of SAR cases involving fishing vessels over the reporting period.





Figure 4. Annual HC-130 Hours

Figure 6. Annual H60/65 Hours




Figure 8. Apr-May Major Cutter Days




Figure 7. Annual Patrol Boat Hours





Figure 9. Apr - May Patrol Boat Hours

The H65 located the vessel and crew in a zodiac. The H65 landed on the beach and directed the zodiac to land and members were transported to Adak.
