

### **Groundfish Harvest Limits**

- GOA Pacific Cod TAC reduced 80% to 18,000 t.
  - Warm blob (2014-16) in GOA increased metabolism of Pacific cod, which increased mortality and production, and caused drastic declines in the stock.
  - Council set arrowtooth TAC above 2017 catch to provide some offset to loss of revenues, but kept halibut PSC apportionments restrictive. Thus, some halibut PSC may go unused.
- Halibut discard mortality rates applied to fisheries were unchanged from last year.
- Smaller changes in BSAI TACs.

# Recommended Halibut Charter Measures for 2018, Area 2C

- If the charter fishery allocation is 0.69 million pounds: One fish per day with a reverse slot limit U35:O80. No annual limit.
- If the allocation is <u>below</u> 0.69 million pounds: one fish per day with a reverse slot limit U35:O80. Four-fish annual limit, or if necessary to remain within the allocation, three-fish annual limit. [Recording requirement if an annual limit is implemented]
- If the allocation is <u>above</u> 0.69 million pounds: one fish per day with a reverse slot limit. Adjust the lower slot limit as allowed to remain within the allocation, upper slot limit remains O80. No annual limit.

# Recommended Halibut Charter Measures for 2018, Area 3A

<u>Status quo (2017) measures</u>: Two-fish daily bag limit, including one fish of any size and 28-inch maximum size limit on one fish. Four-fish annual limit, one trip per Charter Halibut Permit per day, one trip per vessel per day, Wednesdays closed all year, three Tuesdays closed between July 24 and August 7.

- Recommendation:
   Status quo measures
   plus close 7 additional
   Tuesdays (i.e., June 19
   – August 21).
- If the allocation is <u>higher or lower</u> than 1.70 million pounds: <u>increase or decrease</u> <u>Tuesday closures</u> to remain within the allocation

## Halibut Charter Permits (CHPs)

- The Council took <u>NO ACTION</u> on a proposal to reduce latent capacity by establishing annual CHP trip limit categories and restricting effort by category.
- Would have created inequities, and limited entry, flexibility, and opportunities without providing business stability or personalized choices to adapt.
- The Council <u>POSTPONED</u> an action to reduce capacity and effort in the fishery by allowing the RQE to purchase and hold up to 30% of the CHPs in each Area 2C and 3A.
- RQEs not yet approved; so not yet established or funded.



## Self-guided Rental Boats

- Council directed staff to develop a discussion paper further exploring an unguided rental boat registration requirement.
- Less restrictive regulations in the unguided sector may result in increased harvest and negatively impact other sectors. To address this, the Council intends to:
  - 1) establish a registration requirement for vessels affiliated with charter operations, remote lodges, or businesses that require annual saltwater fishing guide licenses, and
  - 2) estimate halibut catch for the self-guided vessels affiliated with guided operations.
- Registration information will help the Council determine whether additional management measures are necessary for this segment of the fishery.

### Response to IPHC Requests

### <u>IPHC Proposal IPHC-2017-IM093-PropC3</u>

- The Council decided not to address the proposal to require logbook-style record keeping and reporting requirements for unguided anglers fishing from self-guided rental boats until after the IPHC meeting (if necessary).
- At this point, the Council is considering a registration requirement for self-guided rental boats to collect catch and effort data from this sector, rather than through individual angler logbooks.

#### IPHC & Council meeting dates: December 2019

- The Council meeting is scheduled December 4-10, and the Interim IPHC meeting is scheduled for December 3-4, 2019.
- The IPHC staff requested that the Council consider shifting dates to accommodate their meeting. In response, the Council agreed to delay the start of the Council meeting by a day, so that the Council meeting would begin on Thursday, December 5. This would potentially allow staff and members of both bodies to fly to Anchorage the evening of the 4<sup>th</sup> and attend both meetings.
- To provide additional travel time, the IPHC could also consider shifting the IPHC Interim meeting a day earlier (i.e., December 2 and 3).
- Concern = adequate time to recommend Charter measures from preliminary catch tables.
