I. High Seas Drift Net Enforcement

There has been no HSDN activity detected during the reporting period. Members of the Coast Guard 17th District enforcement staff participated in several meetings with our international enforcement partners to plan for the upcoming HSDN/IUU season. Topics included joint enforcement efforts, aircraft patrols, and deployment of Chinese Fisheries Law Enforcement Command Officers on board U.S. Coast Guard Cutters operating in the HSDN high threat areas. Coast Guard C-130s from Air Station Kodiak patrolled the HSDN high threat areas for more than 24 flight hours over the reporting period, including one flight in April and several in early and May. While no IUU activity was detected, the high threat season typically extends through the end of June for salmon, but can extend beyond this for other species targeted by HSDN fishermen.

II. US/Russian Maritime Boundary Line (MBL) Enforcement

Activity along the far southern portion of the MBL, south of the Donut Hole, picked up in late April and throughout May with approximately 10 vessels operating on the Russian side of the MBL. In late May activity along the northern portion of the MBL, just north of the Donut Hole began to pick up with as many as 6 vessels noted operating on the Russian side of the line following the opening of the Russian Pollock season on 15 May. Over the reporting period, there was one C-130 patrol of the MBL with no vessels detected within 20 NM of the line. At the beginning of April, the USCG hosted a delegation from the Russian Northeast Border




Figure 1: Historical MBL Vessel Density

Guard Directorate in Juneau and Kodiak, AK. During these meetings, discussions focused on further enhancing cooperative efforts for MBL and HSDN enforcement.

III. Donut Hole Activity

There has been no activity noted in the Donut Hole over the reporting period.

IV. Steller Sea Lions and Critical Habitat Enforcement

Coast Guard Cutters and Aircraft are tasked with monitoring more than 151 critical habitat areas around the state each month. During the reporting period, assets monitored critical habitat areas on a near daily basis, looking for fisheries or transit violations in these locations a total of 870 different times between 11 March and 22 May. Over the reporting period, there were no violations detected of critical habitat areas.




Figure 2: SSL Critical Habitats

V. Fishing Vessel Boarding Statistics





Figure 4. Fisheries Violations By Year

There were 118 domestic fisheries and fishing vessel safety boardings during the reporting period. These boardings resulted in a total of 23 safety violations on 13 vessels and seven fisheries violations on seven vessels. Figures 3 and 4 show the historic trend for boardings and violations.

Figure 3. Fisheries Boardings By Year

VI. IFO Enforcement

There have been 24 halibut and 7 Sablefish boardings since the fishery opened on 17 March with no fisheries violations detected in this fleet. There have been two halibut vessels issued safety violations during the period for their survival craft and expired hydrostatic releases. In early May, the Coast Guard and NOAA focused on identification of vessels fishing along the 3A/3B line to determine whether any vessels were misreporting location fished. While there was only minor activity detected, 8 vessels in all, these vessels all



reported their fishing locations appropriately in their landing reports. The Coast Guard continues to pass all IFQ vessel sighting information to NOAA to cross reference the area fished with landing reports. One vessel was noted setting their longline anchor at the end of a skate without seabird avoidance gear deployed and this is currently being investigated by NOAA.

VII. Crab Fisheries Enforcement

The Coast Guard continues to monitor the Bering Sea Snow Crab fishery, and will actively monitor vessels through the scheduled 15 June closure date. USCGC MUNRO patrolled the Bering Sea throughout much of the reporting period, and USCGC ACTIVE will be took over as our primary LE and SAR asset in the Bering as of 31 May. There have been no boardings on this fleet over the reporting period.

VIII. Commercial Fishing Vessel Safety/Search and Rescue Cases

During the reporting period, 13 vessels with a total of 23 safety violations were detected. There were three *voyage terminations* during the reporting period. Safety violations for the reporting period were for expired hydrostatic releases on EPRIBs and liferaft, expired liferaft inspections, expired EPIRBs, insufficient firefighting equipment, visual distress signals, insufficient PFDs, failure to conduct safety drills, and a missing first aid kit.

There were 26 SAR cases, resulting in 15 lives saved, one life lost, and one vessel lost. Table 1 below provides a comprehensive list of search and rescue cases involving fishing vessels over the reporting period.




Figure 5. Historical Overview of CFVS Statistics (05 Mar)

DFS interviewed patient via SAT phone and concluded that he was suffering from bad heart burn. Vessel was placed on 6hr communications schedule and arrived at Dutch Harbor 061030U Apr 12. Closed.
10-Apr-12	INVICTUS	District 17 Command Center received a SARSAT unlocated first alert for the F/V INVICTUS. INVICTUS answered VHF CH 16 call-out and said that the EPIRB was no longer onboard, but instead disposed of in the trash at Eliason Harbor in Sitka on Saturday night 07 Apr 12. When beacon continued to transmit, D17 CC shifted SMC to Sector Juneau for resolution. Sector Juneau requested Sitka Mountain Rescue ground team attempt to locate the transmitter using hand-held DF equipment. The signal ceased before SMR could acquire it. SMR reports that the trash from Eliason Harbor was loaded into containers this morning which will be barged to Seattle. SARSAT continues to pick up the beacon transmissions intermittently. Launched CGR-6005 fm Air Station Kodiak. Pation was hoisted and transported to Cold Bay where Guardian MEDEVAC acft was waiting, and further transported the patient to Anchorage for medical care. 03-May-12	26' Gillnetter IVO Whittier	Sector Anchorage received a report of a 54YOM operating a 26ft bow picker alone and experiencing extreme abdominal pain. D17 consulted the Duty Flight Surgeon who recommended MEDEVAC. Sector Anchorage assumed SMC, issued UMIB, and launched Station Valdez's 45ft RBM. Good Sam vessel responded to UMIB; their crewmember embarked the 26ft vsl and is taking it to Whittier with the 54YOM on board, ETA 1600U. Station Valdez stood down.
03-May-12	Unknown (Shelikof	Sector Anchorage received a broken VHF Channel 16 call to the Coast Guard on the Cape Gull high site. A relay vessel passed that they heard the call and that the subject vessel was not in distress but they were losing battery power. Communication was lost between the relay and the vessel making the call. Sector Anchorage made callouts and D17 granted approval to launch CGR-6005 to seek the vessel and reestablish communications. The H60 search and subsequent C-130 search saturated the Southern end of Shelikof Strait but did not find any signs of distress. ACTSUS granted.

O4-May-12	IGLOO	F/V IGLOO (O.N. 219787) grounded IVO Sitka Airport on Friday afternoon 04 May. IGLOO is a 42 foot wood hull salmon troller with 150 gallons diesel. The two POB were removed by Sitka SAR response. O/O began coordination with local diver to salvage vessel that night. He reportedly salvaged 150 gallons of fuel that had been onboard and plugged vents. On Saturday 05 May, the vessel could not be located and O/O did not return phone calls. He was out fishing on another vessel. Monday 07 May Sector Juneau confirmed that while towing the vessel to a beach for dismantling, O/O's friends unintentionally sank the vessel 200 yards off the beach at Cannon Island, which is 400 yards from the environmentally sensitive Sitka Nat'l Historical Park, a culturally and fish (salmon) sensitive location. The vessel rests in 50 feet of water and is sheening in 3 foot bubbles which are dissipating and not detectable from shore to date. O/O is placing boom IVO the stream and historical park after Sector consulted with NPS and ADEC. Owner has limited resources. Sector considered opening the fund, but O/O is meeting objectives to date. Sector has also contacted tribal, state, ADEC, DOI and NPS. ANT Sitka is evaluating nav hazard potential and MSD Sitka is continuing to monitor sheen, validate potential and assess best course of action given sensitive area. Situation Pends.
06-May-12	10' Green Skiff	D17 CC received a report of an overdue P/C skiff w/ two adult male POB which departed Grant Point, 9 NM NW of Cold Bay, bound for beach combing at Cape Glazenap and/or Operl Island in Izembek Lagoon. The subjects had departed Sunday at 1330U and should have arrived back at Grant Point by 2100U. Their vehicle was still parked at the launch point. D17 assumed SMC and issued UMIB. Subsequently, the reporting source, located at Grant Point, reported a hand-held flare activation coming from the area of Cape Glazenap. D17 launched CGC MUNRO's H65 to investigate. CG-6529 located a beach fire and the subjects of the search and confirmed that they had activated a flare. They were hoisted aboard and brought to Cold Bay in good condition. They declined medical attention. Their boat was swept away after they had beached it on a barrier island. Case Closed.

15-May-12	BERING HUNTER	COMMSTA Kodiak received notification that a 38YOM crewmember potentially suffered a seizure. D17 CC conferenced the Duty Flight Surgeon into the call who provided medical advice for the vessel's three hour transit to St Paul. The crewmember remains in stable condition and will be transferred to the St Paul clinic at approximately 0530U. Case Pends.

17-May-12	GORDON JENSEN	District 17 Command Center received a report from the fish processor GORDON JENSEN of a 44 YOM who suffered a severe fall on board. Crewmembers found him unconscious and began CPR. After 20 minutes of continuous CPR crewmembers called Coast Guard for assistance. DFS was briefed and conference called with reporting source. During this call reporting source added crewmember had stopped breathing and was still unresponsive. Crewmembers on board provided ample oxygen and first aid techniques in accordance with DFS recommendations. After no response to all applicable on scene medical resources and 40 minutes of CPR, DFS recommended to discontinue CPR. Crew on vessel will make arrangements at first light to have 44 YOM flown off vessel by civilian helicopter to Dillingham. Closed.
18-May-12	WOODY	180540U Sector Anchorage received a report of the 54' F/V WOODY soft aground and suffering light damage in Alitak Bay, Kodiak. Vessel plans to attempt to refloat at high tide, 190100U, and transit one mile to the Ocean Beauty cannery with a landing craft from the cannery acting as an escort. The master temporarily repaired the vessel, and got underway while on a 4 hour communications schedule with Sector Anchorage. Vessel safely moored on 22 May. Case Closed
18-May-12	NANBELLIS JO	181300U D17CC received a 406 EPIRB alert for the F/V NANBELLIS JO approximately IVO of Haines, AK. EPIRB's last registration update was 1991. NANBELLIS JO was last boarded in Feb 2012 and was cited for its EPIRB decal expiring in 2009. Vessels in the vicinity of the EPIRB location report no vessels in visible distress. Alaska RCC has launched Juneau CAP to try to DF the signal. The beacon was located in the Haines dump and disabled by the Juneau CAP ground team.



19-May-12	13' Boston Whaler	181840U Sector Juneau received a report of a 26YOM who left South Harbor, Petersburg at 1300U in a 13Ft Boston Whaler to transit to a nearby cannery. The R/P stated it was the first time this year the vessel had been in the water after storage for the winter and was concerned that he might have had engine trouble and drifted out into Fredrick Sound due to the tidal currents. Petersburg's Harbor Security was out searching and CG AUX 272308 was launched to assist in the search. At 2050U the R/P was able to make contact with the 26YOM and confirmed he was not in distress. The vessel was caught in a creek during the outgoing tide and got stuck. Case Closed.
20-May	Uncorrelated MAYDAY	201031U May 12: A single MAYDAY was heard by a boater in Carroll Inlet, 06 NM east of Ketchikan, with no other information. USCG and CCG high sites did not receive the call. Sector Juneau assumed SMC. Subsequently, STA Ketchikan received a report of a man overboard IVO Fish Creek cabin in Thorne Arm, which is approximately 10 NM NE from the uncorrelated MAYDAY's reporting source. STA Ketchikan launched an RBS to Thorne Arm. CG-25773 arrived on scene and located persons ashore, one of which was a male victim hypothermic from falling out of kayak while fishing. CG25773 transported victim to awaiting EMS at Ketchikan. Persons o/s confirmed that they had transmitted the MAYDAY call. Ketchikan General Hospital reported victim was treated and released. Case Closed.
21-May-12	XTREME	Sector Anchorage received a report of the F/V XTREME, with two POB, taking on water from unknown source. Sector assumed SMC, issued UMIB and diverted CGC LONG ISLAND and CG-6044. Good Sam F/V POLAR STAR was able to tow XTREME to sandy shore. XTREME isolated the source of the flooding to the jet drive, made repairs and resumed fishing with no further assistance needed. MSU Valdez has issued XTREME a verbal COTP order to return to Cordova for inspection. Case Closed.

HFP concurred and recommended ALASKA JURIS make preps to disembark patient in Dutch Harbor for convalescence. At 1300U, the vessel is IVO Dutch Harbor, finishing fish processing, and the patient will go to the clinic this evening. Case closed
22-May-12	POLARIS	COMMSTA Kodiak received a report from the F/V POLARIS, approximately 12NM W. of Chirikof Island of a patient with severe abdominal pain, and requesting a MEDEVAC. DFS recommended MEDEVAC. A/S Kodiak 6010 arrived on scene, conducted hoist, and successfully transported patient in stable condition to awaiting commercial services in Kodiak. Case closed.

IX. Coast Guard Resource Summary






Figure 7. Annual Major Cutter Days

Figures 6 and 7 show the historical and projected *annual* HC-130 aircraft law enforcement hours and Medium and High Endurance Cutter days used in the Seventeenth District. With the several major cutters decommissioned over the last couple years, and two of our cutters being tasked to head to the Arctic this summer, our available major cutter days for enforcement are reduced by approximately **19%** for the year. Figures **8** and **9** show the same information over the last three years for the *reporting period only*.

Figure 8. APR-MAY HC-130 Hours







Major Cutter & C-130 Effort
