## **Exempted Fishing Permit Purpose**

EFPs are used to allow fishing that would:

- > otherwise be prohibited under 50 CFR part 679
- support projects that could benefit fisheries & the environment



## **Exempted Fishing Permitting Process**

- EFP Application
  - Development & Review
- EFP Permit
  - > Development, Review & Issuance
- EFP Permitting Timeline
- EFP Fishing Activities
- EFP Reporting Requirements
- EFP Modifications



## **EFP Application Development**

- Contact NMFS AK Region at earliest point to indicate application is under development
  - ➤ Assuming applicant has considered experimental design & contacted AFSC to discuss
- AK Region staff will develop a timeline for processing the permit issuance
  - Usually 8-12 months depending on complexity of project
- Applicant and AK Region staff determine what regulatory exemptions may be needed



## **EFP Application Development**

Applicant consults EFP application check list & submits draft application

- AK Region staff will review the draft application for completeness and clarity
  - ➤ will work with the applicant to finalize the application
- Final draft application submitted to NMFS AK Region



## **EFP Application Review**

- NEPA analysis: Environmental Assessment or Categorical Exclusion
  - ➤ Draft EA must be complete before FR Notice published
  - Categorical Exclusion is more typical; EFP has designated CE category
- ESA Consultation
  - ➤ If ESA-listed species may be affected by EFP activities in a manner not previously consulted on, new ESA consultation would be required
- Alaska Fishery Science Center
  - ➤ AFSC review & approval; revisions must be complete prior to publication of Federal Register Notice & Council consultation



## **EFP Application Review**

- Federal Register Notice of Receipt of Application; request for public comments
  - ➤ Public comment period (15-30 days) will end last day of Council meeting in which Council consultation occurs
  - > Request for public comments on EA, if drafted
- Council Consultation
  - ➤ No later than October Council meeting for issuance of EFP by January 20<sup>th</sup>
- Notification of USCG, ADFG, and IPHC (as appropriate)
- If NMFS decides not to issue an EFP, the applicant will be notified in writing



#### **Standard EFP Contents**

- Permit Holder(s) and contact information
  - Principal Investigator
- Dates for which permit is valid
- Permitted Vessels: selection, requirements, data sheets
- Rationale for EFP
- Terms and Conditions
  - Target species
  - Harvest TAC and PSC issues
  - Timing of exempted fishing
  - Areas of exempted fishing
- Notification requirements
- EFP Administrators
- Sampling requirement details
- Sanctions for failure to comply w EFP terms & conditions
- List of Exemptions from Federal Regulations
- Results: analysis and reporting requirements



## **EFP Development & Issuance**

- The new EFP will be assigned an ID number (YYYY- ##)
- AK Region staff will develop draft permit & distribute to applicant and key NMFS staff (OLE, Observer Program)
  - ➤ Permit details and language are tweaked & agreed upon by applicant and NMFS
- EA or CE is finalized with AK Region NEPA Coordinator clearance



## **EFP Development & Issuance**

- AKR Regional review and clearance
- NOAA Fisheries General Counsel, General Counsel for Enforcement & OLE review and clearance
- Permit applicant signs final permit
- Alaska Regional Administrator reviews and signs final permit
- Final permit transmitted to permit holder

## **Exempted Fishing Activities**

Notification to NMFS of begin/end EFP fishing

Notification to NMFS of non-performance

Notification to NMFS of any issues impacting EFP activities



## **EFP Reporting Requirements**

- Interim and Final Reports
  - > Due dates and general content requirements will be included in EFP
- Presentation of results to the Council
  - ➤ If requested



#### **Modifications to EFPs**

- Minor changes may be approved without new application
- Major change to terms & conditions require a new application
  - ➤ Determination of whether request is a major change is up to the discretion of the agency
    - > Target species
    - ➤ Request for additional TAC or PSC allowance
    - Change in area or timing
- Modified EFP would need to be signed & issued by Regional Administrator
