2008-2010. Program Coordinator, Yukon River Drainage Fisheries Association. In this position, oversaw and coordinated annual research projects, developed and implemented new projects. Assisted in planning and implementation of yearly board of directors meeting, including content and travel arrangements. Maintained organization’s membership materials and database.

- Working as a co-Principal Investigator in a project assessing the resilience and adaptive capacity of the community of Yakutat through the lens of resilience.
- Designing and implementing research projects concerning all aspects of subsistence practices, including local knowledge of wolves and wolf populations on Prince of Wales Island and salmon harvest pattern of Hoonah residents.

- Leading and co-leading research teams conducting comprehensive subsistence harvest and use household surveys in the communities of Sitka, Angoon, Hydaburg, Hoonah, Haines, and Whale Pass.
- Training and coordinating local research assistants in various Southeast Alaska communities, providing direct oversight of their work during field sessions.
- Developing research projects to apply for external funds for the continued documentation, study, and analysis of Alaska residents' subsistence harvests and uses of wild resources.
- Analyzing and providing written agency response materials to the Board of Fisheries and to the Board of Game.
- Representing the Division of Subsistence at the Board of Fisheries, Southeast Regional Advisory Council meetings, the Juneau Douglas Advisory Committee and Sitka Advisory Committee meetings.
