Recommended changes to Charter of the Advisory Panel North Pacific Fishery Management Council Recommended by Advisory Panel December 2, 1976

Page 5 of the Charter, Section El, last sentence, should be changed from "the Panel shall meet at least six times a year" to "the Panel shall meet at least two times a year."

Page 4, Section D3, first sentence, change the fourth word to read "Panel" so that the first sentence of Section D3 reads "members of the Panel shall be appointed by the Council for a period of two years--."
