The North Pacific Fishery Management Council will meet in the Old Federal Building, 605 W. 4th Avenue, Anchorage, Alaska, September 25-28. The Council will convene at 9:00 a.m. on Tuesday, September 25, along with the Council's Advisory Panel, to hear reports on domestic and foreign fisheries, Coast Guard enforcement, joint venture operations and to elect Council officers for the They will also receive staff reports, public testimony and agenda items C-6 (Advisory Panel Operations), C-2 (Fishery Management Goals and Objectives), C-4 (Joint Venture and Permit Policies), C-7 (Habitat Policy), and C-8 (Joint Venture Permit Restrictions). However, the Council does not expect to make decisions on these agenda items until Thursday or Friday when they will have recommendations from the Advisory Panel and SSC available to them. Persons wishing to testify on those subjects will be able to do so on Tuesday before the Council and the Advisory Panel and need not be present on Thursday or Friday when the Council reaches a decision.

The agenda is structured so that the AP and the SSC will be together on Monday afternoon to hear staff reports and public testimony on crab and groundfish matters. The AP will be together with the Council to hear all of the agenda items scheduled for Tuesday. The Advisory Panel will then meet separately on Wednesday to formulate their advice to the Council on those subjects.

On Wednesday, September 26, the Council will meet with the Alaska Board of Fisheries to discuss Tanner crab management. On September 27 & 28, Thursday and Friday, the Council is expected to make decisions on their options for halibut management, on draft comprehensive fishery management goals, joint venture policy, joint venture permit restrictions, habitat policy, and Advisory Panel operations. They will also hear staff and public testimony on Thursday and Friday on herring in the Bering Sea, Gulf of Alaska and Bering Sea/Aleutian groundfish matters, and ongoing financial matters.

The Council will review several permit applications from Portugese ships to engage in joint ventures and directed fisheries in the Bering Sea and Gulf of Alaska. Four of the Portugese ships have applied for permission to use bottom gillnets for Pacific cod.

The current status of stocks for groundfish in the Gulf of Alaska and the Bering Sea will be reviewed and that information, along with preliminary harvest levels and their apportionments to domestic and foreign fishermen for 1985, will be sent to the public at the conclusion of this meeting for comment with final action by the Council scheduled for the December meeting.

The Council will also consider extension of an emergency closure for sablefish in Southeast Alaska federal cul-de-sacs and emergency regulations to raise the bycatch limit on halibut by domestic trawlers in the Central and Western Gulf of Alaska, as well as review previous Council action banning the use of pots for sablefish in parts of the FCZ off Southeast Alaska.

The Council's Scientific and Statistical Committee and Advisory Panel will meet separately beginning at 10:00 a.m. on Monday, September 24, in the Old Federal Building and will meet together that day at 1:00 p.m. There will be a meeting of the Council's Permit Review Committee at 7:00 a.m. on Wednesday morning and its Finance Committee at 7:00 a.m. on Friday. Other plan team and workgroup meetings may be held on short notice during the Council meeting. They will be announced at the Council offices.

The Council and Scientific and Statistical Committee may announce closed sessions during the week to discuss personnel matters. All meetings, with the exception of the announced closed sessions, are open to the public.
