Council Chairmen's Meeting June 21 - 24, 1981 Homer, Alaska

Regional fishery management council chairmen will meet in Homer, Alaska from June 22 through June 24 with the Assistant Administrator for Fisheries - NMFS and NOAA/NMFS legal and administrative representatives. The meeting will start at 9 a.m. on June 22 in the Elks Hall, Homer, Alaska and run through approximately 5 p.m. on Wednesday, June 24. The meeting may be lengthened or shortened depending on the progress of business.

Executive directors of the regional fishery management councils, with such council staff and council members as wish, will meet with NOAA/NMFS administrators and legal counsel at the Land's End beginning at 1 p.m. on June 21 and will adjourn that day when business is completed, probably 7 to 9 p.m.
