June 2022

### Action Memo

#### Welcome to Sitka

## NOAA Fisheries Regional Action Plans for Public Comment

NOAA Fisheries has invited public comment on seven draft 2022-24 Climate Regional Action Plans (RAPs) released in April. The draft RAPs are designed to provide decision-makers with tools and actionable information to prepare for and respond to climate-related changes in marine and coastal ecosystems. NOAA is specifically interested in input on the draft RAPs, including comments on the clarity of the goals and activities, ways to strengthen the plans, and what additional goals and activities need to be addressed. Submitted comments will be considered in development of the final RAPs. Note that there are 3 RAPs for the Alaska Region:

## NOAA Fisheries Invites Public Comment on New Draft Equity and Environmental Justice Strategy

On May 4, 2022, NOAA Fisheries released its [Draft Equity and Environmental Justice Strategy](#) and invited public comments to be submitted [online](#) through August 19. In 2021, President Biden signed Executive Orders 13985 and 14008 to promote equity and environmental justice (EEJ) within the federal government and its external-facing efforts. In response, the FY22-26 Department of Commerce's Strategic Plan revised its mission, "to create the conditions for economic growth and opportunity for all communities," and published its Equity Action Plan. NOAA Fisheries responded by convening an EEJ Working Group to improve information sharing, coordinate internal expertise, and to inform implementation of EEJ.

The NOAA Fisheries EEJ Working Group developed this Draft EEJ Strategy to provide guidance for incorporating and prioritizing EEJ in ongoing and future activities in support of NOAA Fisheries' mission. NOAA Fisheries' three overarching EEJ goals are to: 1) prioritize identification, equitable treatment and meaningful involvement of underserved communities; 2) provide equitable delivery of services; and 3) prioritize EEJ in the agency's mission and work. The Draft EEJ Strategy (page 8) states that "To achieve these goals, each national program (e.g., Office of Protected Resources, Office of Habitat Conservation, etc.) and geographic region (e.g., Southeast, Pacific Islands, etc.) will create an EEJ step-down implementation plan (possibly as part of their NOAA Fisheries Geographic Strategic Plans for FY 2023-2028) that is specific and responsive to the needs of underserved communities and allows for the input of underserved communities. Each program, science center, and regional office will set EEJ as Priority Areas or milestones in annual strategic planning starting in FY 2023."

Through this call for public comment, NOAA Fisheries is seeking assistance in several areas to help identify:

- Who the agency's underserved communities are
- How the agency can reduce barriers to underserved communities
- How the agency can better incorporate equity and environmental justice into our daily activities
- How we can improve equity in our programs and policies now, with our current resources, and in the future
- Help evaluating whether the draft recommendations for action are on target

## Reflections on the Council Process

The Council requested an update on priority issues stemming from the staff paper on “Reflections on the Council Process” from February (see: <https://tinyurl.com/councilreflection>). A progress report on the five ideas that the Council prioritized is attached; some ideas are potentially ready for Council action at this meeting (AP/SSC nominations, B reports), while others are still being explored and we will report back in October (harvest specifications timing, meeting schedule). I envision that the Council will receive this report as part of the B-1 presentations, hear public testimony under both B-1 and E-1, and potentially take some action during Staff Tasking.

## MREP

Ms. Lauren O'Brien from the Marine Resource Education Program (MREP) is attending the Council meeting this week. She is interested in speaking with attendees about launching a MREP workshop in the North Pacific. There has been growing interest among some in Alaska to develop an MREP workshop series in the region, and funds are available to develop the program. MREP aims to hold the initial training sessions in the region beginning in 2023. The following is a summary from Ms. O'Brien:

“The Marine Resource Education Program (MREP) is a 2-part workshop series which offers fishermen education in the basic elements of fishery science and effective participation in the fishery management process. It was launched 2 decades ago by a group of fishermen in New England, and it has been very effective in developing new leaders in the fishing industry across six Council regions spanning the U.S. Eastern seaboard and continental U.S. West coast. MREP staff have recently been asked if a similar program could be developed as an offering to fishermen in the U.S. North Pacific region, and have secured funding to do so. The success of MREP in other regions is, in large part, because it is "by fishermen for fishermen," guided by a regional Steering Committee of industry stakeholders, in close collaboration with the council and NMFS. To this end, MREP Senior Program Manager Lauren O'Brien will be at the June NPFMC meeting to meet with industry, as well as Council and NMFS staff, and other stakeholders, to discuss building an MREP in the North Pacific council region. ## **BBRKC Request for Information (RFI)**

In April, the Council's [motion](#) on Bristol Bay red king crab (BBRKC) requested that “each sector with crab mortality” confer and bring information about voluntary measures that could reduce crab mortality in non-directed fisheries and reduce discard mortality in crab fisheries, and could be implemented as soon as 2023. In addition, sectors were also requested to describe research that could inform development of more flexible and effective spatial management measures, gear modifications to reduce impacts on BBRKC, or to evaluate unobserved crab mortality in the trawl sector.

Given the formality of the request, the Council has noticed a Request for Information (RFI) in the Federal Register. Responses to this request are voluntary and will be received in a written format prior to the October 2022 Council meeting where the Council will review responses and also receive an expanded staff discussion paper on various topics related to management and research that could affect the BBRKC stock (see also [April motion](#)). Responses may be submitted via the Council's eAgenda portal. The page for submission – *Bristol Bay Red King Crab – Request for Information (RFI)* – can be accessed at <https://meetings.npfmc.org/Meeting/Details/2941>. The deadline for submission is Friday, September 23, 2022.

Responses may be voluntarily submitted by any fishery participant that is described by the Council's motion. Responses need not be aggregated at the “sector level”. Individuals, companies, or organizations who would like to address the Council on this topic may do so as part of the Council's typical agenda process. In other words, submission of a written comment in response to this RFI is not required. Any individual, company, or organization that wishes to give oral testimony may sign up on the in-meeting agenda as customary, and written comments may be submitted to the Council's October meeting agenda by any member of the public until the customary deadline, which is the Friday before the meeting begins (September 30, 2022). The Council is aware that written comments submitted to the RFI and comments on the October Council agenda may be duplicative in some cases. Responding to the RFI does not preclude written or oral testimony at the Council meeting in any way.

## **National SSC meeting (SCS7)**

The Scientific Coordination Subcommittee will convene the 7th national meeting of the CCC's Scientific Coordination Subcommittee (SCS7) in person this summer. The North Pacific Fishery Management Council will host this meeting August 15-17, 2022 in Sitka Alaska, and representatives of all the RFMC SSCs will attend. The meeting, “Adapting Fisheries Management to a Changing Ecosystem,” is focused upon various aspects of addressing Ecosystem-Based Fishery Management (EBFM), including ecosystem indicators, multi-species modeling and addressing distributional shifts in managed stocks. The three primary themes of this meeting are: 1. How to incorporate ecosystem indicators into the stock assessment process? 2. Developing information to support management of interacting species in consideration of EBFM. 3. How to assess and develop fishing level recommendations for species exhibiting distributional changes?

Former SSC Chair Dr. Anne Hollowed will chair the meeting, and Council vice-Chair Bill Tweit will provide opening remarks. The meeting will be broadcast for those who are interested. ## Council Coordination Committee meeting
