SUBJECT: U.S. and USSR port call privileges: fishing vessels

## Clarence/Larry:

Under the terms of the U.S.-USSR Mutual Fisheries Agreement (MFA) of May 1988, both the U.S. and the USSR agreed to reciprocal access arrangements for fishing and fishing support vessels in four U.S. and four USSR ports. Under the MFA those ports open to U.S. fishing vessels in the Soviet Union include Murmansk, Korf, Oktyabrski, and Provideniya, while those ports open to USSR fishing vessels in the U.S. include Dutch Harbor, Astoria, Portland, and Boston.

The Soviets have recently proposed that their fishing vessels also be allowed access to the following eight U.S. ports: Kodiak, San Francisco, Los Angeles, Hilo, Portland (Maine), Seattle, New York, and Baltimore. As the agreement we have with the Soviets is based on reciprocity, we are now in a position to propose that additional Soviet ports be open to U.S. fishing vessels. Through the NMFS Seattle Office, we have obtained several suggestions from U.S. industry reps as to ports we should try to get in the USSR in response to the SOviet request for additional ports in These include Vladivostok, Ust'Kamchatsk, the U.S. Petropavlovsk, Magadan, and Korsakov.

If you know of any additional ports that we could request from the Soviets or if you know of any reasons why we would have any problems with the new U.S. ports that the Soviets have requested in your area, such as Kodiak (in the NPFMC area) or Los Angeles, San Francisco, Seattle (all in the PFMC area), I would appreciate hearing from you by Tuesday, April 26.
