Executive Director's Report

New Deputy Director

I am proud to announce the selection of Chris Oliver as the Council's new Deputy Director. He brings to the position experience with the Gulf of Alaska groundfish plan, and just about every North Pacific fishery issue that you have had before you in the past two years. He has been a real self-starter and work horse on the Council staff, and before that, was involved with bycatch issues in the Gulf of Mexico shrimp fishery. I am looking forward to working with him and aging him in his new position.

Magnuson Act Hearings

<u>B-1(a)</u> is the witness list for a hearing held on September 9, 1992 before the National Ocean Policy Study of the Senate Committee on Commerce, Science, and Transportation. That hearing was the first of several that may be held in 1993 as the Congress considers reauthorization of the Magnuson Act. I have made copies of the testimony for all Council members so you will know what others are saying about NMFS, the Councils, and fisheries management in general after 15 years under the Act. The Council may want to begin thinking about changes it would like to advance. I'm certain that other Councils will be doing so and they will be seeking consensus.

Inspector General Nationwide Council Review

<u>B-1(b)</u> is a request from the Office of Inspector General concerning our Council's views about the strengths and weaknesses of the current fishery management process. I will be drafting a letter shortly after this meeting and would welcome any comments you might have. Four Councils are being visited by the Inspector General's Office: the New England, Pacific, Gulf of Mexico, and North Pacific. The Inspector General will be providing input to the reauthorization process.

Committees

The next few months might be a good time to review committee memberships. <u>B-1(c)</u> lists the Council's currently active committees. You should let Chairman Lauber know which committees you want to be on. It has been suggested that the Council consider establishing an enforcement committee. B-1(d) has information from other Councils on their enforcement committee activities.

Just a reminder that there will be a call for AP and SSC nominations in the next newsletter. The Council will need to make those appointments at the December meeting.




The SAFMC has a Law Enforcement Committee currently composed of six Council members and a Law Enforcement Advisory Panel composed of ten individuals, most of whom are or were affiliated with state or federal law enforcement agencies. I have enclosed lists of these memberships. The SAFMC SOPPs define the role of the Law Enforcement Committee and I have also enclosed this.

The Law Enforcement Committee meets during a Council meeting on an as needed basis, generally to review a draft FMP or amendment prior to public hearings or submission to the Secretary. It will also convene to address specific enforcement issues. The Committee generally convenes jointly once a year in a one or two day separate meeting with the Law Enforcement AP to review a draft FMP or amendment prior to public hearings. The AP is composed of members of State marine fisheries enforcement agencies, NOAA Enforcement, the Coast Guard, U.S. Fish and Wildlife, and others. The items discussed mostly concern the enforceability of specific management options in an FMP or amendment. I have enclosed the agendas from the last few meetings.

This is response to your FAX on the subject. John is on vacation, so I will answer.

We have had an Enforcement Committee off and on since 1978.

The current Committee is made up of 3 voting Council members (1 a State Director), the Council's Coast Guard representative, NOAA General Counsel Northeast, and the NMFS Special Agent in charge of the Northeast Region.

Historically the Committee has worked on measures to reduce conflicts between fixed and mobile gear (with no real success) and to prepare penalty schedules for some of the FMPs (with some success, NOAA GC keeps this pretty much to themselves).

The latest project was to consider whether the Council wants to license commercial fishermen and party and charter boat operators. The concept has developed to the point that the Council directed the staff to include such a provision in all FMPs and amendments. Each fishermen (not sport fishermen) would be issued a license similar to a driver's license (complete with photograph). Applicants would be required to certify they were familiar with the regulations of whatever fisheries they were to be licensed in. Licenses could be suspended for certain violations. The concept follows a system operating with some success in Georgia for more than a year.

Finally, several years ago the Committee organized a workshop on enforcement. Among others, we had Coast Guard, NMFS, and State enforcement personnel and the Administrative Law Judge that handles the Magnuson Act cases. Enclosed please find a copy of the proceedings.

CHAPTER: Council Operating Procedure Number 21

PURPOSE

Provide advice to the Council concerning the feasibility of proposed management measures from an enforcement standpoint.

Membership

Oregon State Police U.S. Coast Guard Washington Department of Fisheries California Department of Fish and Game National Marine Fisheries Service, Northwest Region National Marine Fisheries Service, Southwest Region

Organization

- 1. Each agency will have one voting member.
- 2. A chairman will be elected by majority vote to serve a two-year term. The term will run from October 1 of the first year through September 30 of the second year.
- 3. The vice chairperson's position will be permanently filled by the U.S. Coast Guard representative.
- 4. Additional representatives on an agency may attend meetings but may not vote.
- 5. Other agencies and Council groups wishing to attend the Enforcement Consultants meetings will be welcome but will not participate unless invited to do so by the chairperson.

Meeting Attendance

- 1. The chairperson will attend all Council meetings. In the event the chairperson is unable to attend, another Enforcement Consultant member will be delegated to attend.
- 2. The chairperson will ensure that he/she is kept abreast of Council developments by maintaining close contact with Council staff. The chairperson will be responsible for seeing that attendance is provided for at all pertinent Enforcement Consultant meetings. The person attending such meetings shall provide the necessary information on the meeting to the chairperson for dissemination.

3. The chairperson will call a meeting of the Enforcement Consultants, as authorized by the Council executive director, prior to or at Council meetings when issues affecting enforcement are to be addressed. Items members wish discussed, in addition to Council initiated matters, will be submitted to the chairperson far enough in advance to permit inclusion on the Enforcement Consultants agenda. Travel expenses for state agency personnel will be reimbursed in accordance with the Council travel rules.

Reporting Procedures

- 1. The chairperson of the Enforcement Consultants will represent the consensus position of the group to the Council. In the event of the absence of the chairperson, the vice chairperson will act in his/her place.
- 2. Group consensus on positions to be presented to the Council will be established by majority vote.
- 3. Any member agency having an agency position differing from that of the group may present their position to the Council. Such a position must be given separately from the group report and clearly stated that theirs is a minority report and does not represent the view of the group.
- 4. Items to be presented to the Council will be reduced to writing and given to the Council in addition to the oral report. Copies will be provided to Enforcement Consultant members.

We do not have any written material on this Committee, except for a statement as to its existence in our SOPPs.

Enforcement Standing Committee

77th Council Meeting

The Enforcement Standing Committee met at the Hawaii Maritime Center on 30 June 1992 at 8:25 am. The Coast Guard presented its report of patrols and enforcement activity, highlighting the increase in surface and air surveillance. The Committee recommends that the Coast Guard include, in its quarterly report to the Council, a summary of all of its activities, not just enforcement. The Committee felt that inclusion of these other actions wold help the public better understand the Coast Guard's multi-mission role.

The NMFS Office of Enforcement then presented their report. They later clarified that none of the interactions with endangered species were related to fishing vessels, and that the Fish and Wildlife Service was not included in the recently-signed enforcement agreement because they have separate agreements of their own.

Ensuing discussions highlighted several discrepancies between federal and state laws. First, the recent case of the state fining a driftnet vessel only \$500 points to the need for the federal regulations to include a "no possession" rule, rather than the "no fishing" rule now in place. The Committee recommends that this provision be studied, and that enforcement present recommendations to the Council at its next meeting. The Committee also noted that the issue of non-permitted vessels fishing outside the EEZ and not being allowed to enter the EEZ has risen again, and may need to be revisited.

The cooperative enforcement agreement has also highlighted the inconsistency between state and federal logbooks in several fisheries. For the benefit of fishermen and state/federal enforcement agents, the Committee recommends that the Pelagics, Crustaceans and Bottomfish Plan Teams each work with HDAR and NMFS biologists and enforcement representatives to determine the feasibility of (and begin to develop) a compatible logbook format and for protocol overlapping fisheries, and report to the Council as soon as practicable.

Regarding the marking of longline gear, NMFS agents presented a proposal that would (a) extend the marking requirement to any gear, not just that deployed, (b) require uniform lighting and

radar reflection on all gear, and (c) allow the confiscation of unclaimed or abandoned gear. Ensuing discussions noted that the costs associated requiring lights and radar reflectors would burden fishermen, especially in light of the fact that most Hawaii-based fishermen have abandoned reflectors and lights in favor of radio beacons. The Committee recognizes that more discussions with fishermen may be required before a decision can be made on paragraph (b) of the proposal. In any event, the Committee recommends that the Council staff work to incorporate the recommended regulatory language into the rules for the Pelagics FMP.

The Committee had no further recommendations.
