We have 20 member Tribes and are directed by a Board consisting of the Presidents of the Tribes, two Elder representatives, and a representative of the regional healthcare organization. Kawerak is an organization that provides programs and services to western Alaska communities.

Mr. Raymond-Yakoubian has been affiliated with, and collaborating with, Kawerak for over 5 years on a variety of social science issues and projects, including federal fisheries related work. He has represented Kawerak at NPFMC meetings, including at the SSC, Ecosystem Committee, FEP Team, and other Council-related meetings. Brenden is intimately familiar with the concerns, issues and knowledge of the Tribes and communities of the Bering Strait region, as well as other parts of the state, as relates to fisheries, the marine environment, research and social science. He has, among other efforts, co-led Kawerak social science research projects about Traditional Knowledge of fish and marine mammals in the region. Brenden has also led the facilitation of a coalition of indigenous organizations and communities in the development of extensive comments to the Council's Fisheries Ecosystem Plan Team. He has worked extensively with Tribes, Tribal members and communities.

Mr. Raymond-Yakoubian has undergraduate and graduate degrees in Anthropology and extensive knowledge of and practical experience with anthropological method and theory and its application to fisheries-related topics. Among other topics, he has written and published on the issues of Traditional Knowledge, community engagement, and the use of social science in fisheries management. Brenden has also worked extensively across the state of Alaska, in dozens of communities, on other Traditional Knowledge and social science projects outside of the Bering Strait region.

Statement of Qualifications

My educational background is mainly in anthropology; I have a BA, MA, and am currently a PhD Candidate, all in anthropology. I have worked on social science projects spanning over two decades in over four dozen communities across Alaska. I am considered an expert in areas relating to Local and Traditional Knowledge, natural resource policy and management, subsistence, and the relationship between research and communities. I have been published on the topic of integrating Traditional Knowledge (TK) into Alaska federal fishery management, and have been the lead facilitator for a partnership of indigenous communities and organizations making inputs related to indigenous concerns, perspectives, and knowledge (including TK) to the Council's Bering Sea Fishery Ecosystem Plan team. Over roughly the past five years, I have worked extensively on projects with Alaska Native communities and organizations across western Alaska, with a particular though not exclusive focus on the Bering Strait and Norton Sound regions. This has included work on TK of walrus, TK of salmon and environmental change, the incorporation of TK into federal fishery management, the integration of TK in ecological mapping, and the relationships between research processes and indigenous communities. In addition to having worked with many Alaska Native organizations, tribes and communities, during my career I have performed work that was with, in, or funded by the National Science Foundation, National Park Service, Bureau of Land Management, US Forest Service, US Fish and Wildlife Service, Alaska Army National Guard, University of Alaska, North Pacific Research Board, Audubon Alaska, Pew Charitable Trusts, and the Arctic-Yukon-Kuskokwim Sustainable Salmon Initiative.
