Executive Director's Report

Magnuson-Stevens Act Update

Not a lot has happened since October on this front, but there are a few things which merit an update/status report, as we approach an interim meeting of the Council Coordination Committee (CCC) with NOAA leadership January 8-9 in Washington DC. Many of us are eagerly waiting to see who will be named to replace Dr. Hogarth as head of NMFS, as that could also affect the implementation trajectory of some of the MSA issues under development.

Also during the week of January 8-10 NOAA Fisheries is holding a workshop with NOAA personnel, Council staff, and some former members of the Ecosystem Principles Advisory Panel to discuss the MSA requirement that "NMFS, in consultation with the Councils, undertake and complete a study on the state of science for advancing the concepts and integration of ecosystem considerations in regional fishery management". One member from each Council staff has been invited to participate in this workshop. Diana Evans will be attending from our Council. NMFS expects to proceed with development of the required report following this workshop.

NMFS is still in the process of drafting regulations to implement the annual catch limit provisions of the amended MSA. These are apparently under review at OMB and hopefully will be released soon, though not likely in time for our interim CCC meeting. We also are hoping of course that our comments on this issue will be addressed in the proposed regulations, and that our successful process in this regard will not be unnecessarily and negatively affected in their attempts to apply this requirement to other regions of the U.S.

Regarding limited access privilege programs (LAPPs), I submitted general comments as described in October (essentially recommending they be careful about putting specific guidelines in regulation, which could compromise Council flexibility). I am uncertain as to the timing of further development of these regulations.

On November 27th the subcommittee of the CCC (Chris Oliver, Bob Mahood, and Dan Furlong, as well as Don McIsaac) met via teleconference to discuss progress on the revised NEPA procedure. Recall that NOAA was directed to prepare a revised NEPA procedure, "in consultation with CEQ and the Councils". Our subcommittee originally developed a strawman proposal this past February which was premised on significant changes to current NEPA application to fisheries management actions. Since that time NOAA Fisheries and CEQ have been working on an 'agency' proposal (including a draft proposed rule), without further Council input, which they intend to publish in the form of revised regulations. We were given a 'concept paper' on their proposal on November 26th. While we had some general discussions about NOAA's draft revised procedure on November 27th, we were unable to provide meaningful input in my opinion due to the lack of specificity in the concept paper. I can tell you that it appears to be a substantially different approach from our strawman proposal and raised numerous questions and a few major concerns. However, we need to be able to review the actual draft proposed regulations for any meaningful input – hopefully we will be afforded that opportunity prior to these regulations being published as a proposed rule.

We plan to have further discussions of these and a number of other MSA reauthorization issues (including the status of the stipend issue for you AP and SSC members!) at our January 2008 CCC meeting. <u>Item B-1(a)</u> is an MSA reauthorization status of tasks summary taken from the NOAA Fisheries website.

Joint Protocol Committee update

Along with Chairman Olson, I recently met with Board of Fish (BOF) Chairman Mel Morris and Executive Director Jim Marcotte to discuss the status and timing of the Joint Protocol Committee, as well as a potential full meeting of the Council and BOF. Based on those discussions I will be working with Jim to schedule a meeting of the Joint Protocol Committee for mid-March 2008, and a full meeting of the Council and BOF in conjunction with our April Council meeting, likely Tuesday April 1. We determined that relevant issues between now and then can be coordinated via exchange of information/letters and staff interaction as necessary.

Electronic monitoring workshop

At the last meeting I reported to you on a request from the North Pacific Research Board that the Council consider sponsoring a workshop on electronic monitoring (as an alternative to observers or for other purposes). I have been discussing this with NOAA Fisheries representatives as they would necessarily be a key player in such a workshop. We have also been assessing other key participants and their availability. Additionally, there is an exempted fishing permit (EFP) project in the GOA that we want to have the results of before proceeding. Based on Council direction in October we would also at some point involve our Observer Committee in evaluating the feasibility of electronic monitoring options. I have commitment from both NOAA Fisheries and the NPRB to co-sponsor a workshop with the Council, but we have not yet determined the optimal timing for such a workshop. It is unlikely that it will happen before next summer.

State Department invite

<u>Item B-1(b)</u> is an invitation I recently received from the U.S. State Department to participate in a meeting later this month in Washington, D.C., to provide them information as they are developing U.S. foreign policy related to the Arctic. I will make a presentation on general North Pacific fisheries issues, and specifically on our Arctic FMP efforts, and participate in discussions with other presenters and State Department personnel.

Events this week

It's looking like a fairly quiet week, but there are a couple evening events later in the week I want to alert everyone to. On Sunday evening the 9th, there will be a short reception from 5:30 pm to 7:00 pm in the Chart Room to honor departing Council member Ed Rasmuson. Next week, on Tuesday the 11th and Wednesday the 12th the second annual Young Fishermen's Summit is being hosted by Sea Grant, with additional sponsorship from the NPFMC and others. The Summit is being held at the Sheraton Hotel a few blocks from here. On Monday the 10th there will be an evening reception, from 6:00 to 7:30 pm, in the Alaska Room here in the Hilton Hotel for Council members to have the opportunity to meet and mingle with Summit participants. Your Executive Director is also on the slate of speakers for the Summit on Wednesday. A copy of the draft program is under <u>B-1(c)</u>.

Dear Chris,

Further to our discussion yesterday, I would like to invite you or another appropriate representative of the North Pacific Fisheries Management Council to participate in a meeting in Washington, DC in mid-December to assist the U.S. Government in a review of Arctic Policy.

More specifically, the United States Government is engaged in a review of federal Arctic policy with a focus on international issues. As part of that process, which involves all U.S. agencies with international Arctic responsibilities, the U.S. Government plans to hold a series of stakeholder outreach sessions in Washington, D.C. The goal of these sessions is for the government to receive input from those knowledgeable in these areas who can help inform the federal government so that it can develop sound policies.

We would like to invite you to participate in a session that would include representatives of key U.S. industries with Arctic interests and representatives of the environmental community. Your role would be to make a presentation to federal officials on aspects of federal Arctic policy as it relates to international matters that you think should be considered by the U.S. Government as part of its review. Particular areas of interest to federal agencies include international governance, scientific cooperation, shipping, energy, environmental protection and sustainable development. Your comments need not address all of these matters, however. Indeed, I would hope that the representative of the North Pacific Council might focus on recent actions that the Council has taken or proposed with respect to fisheries in that part of the U.S. Exclusive Economic Zone that lies in the Arctic. It would be helpful if the representative could make a twenty-minute presentation, and then participate in a discussion with others that we anticipate would last two-to-three hours overall.

The Department of State is leading this outreach effort, and will convene this session at the Harry S Truman Building, 2100 C Street, N.W., Washington, DC, on December 20, 2007 starting at 2:00 p.m.

Please let me know if you will be able to participate. I would be pleased to answer any questions you may have.
