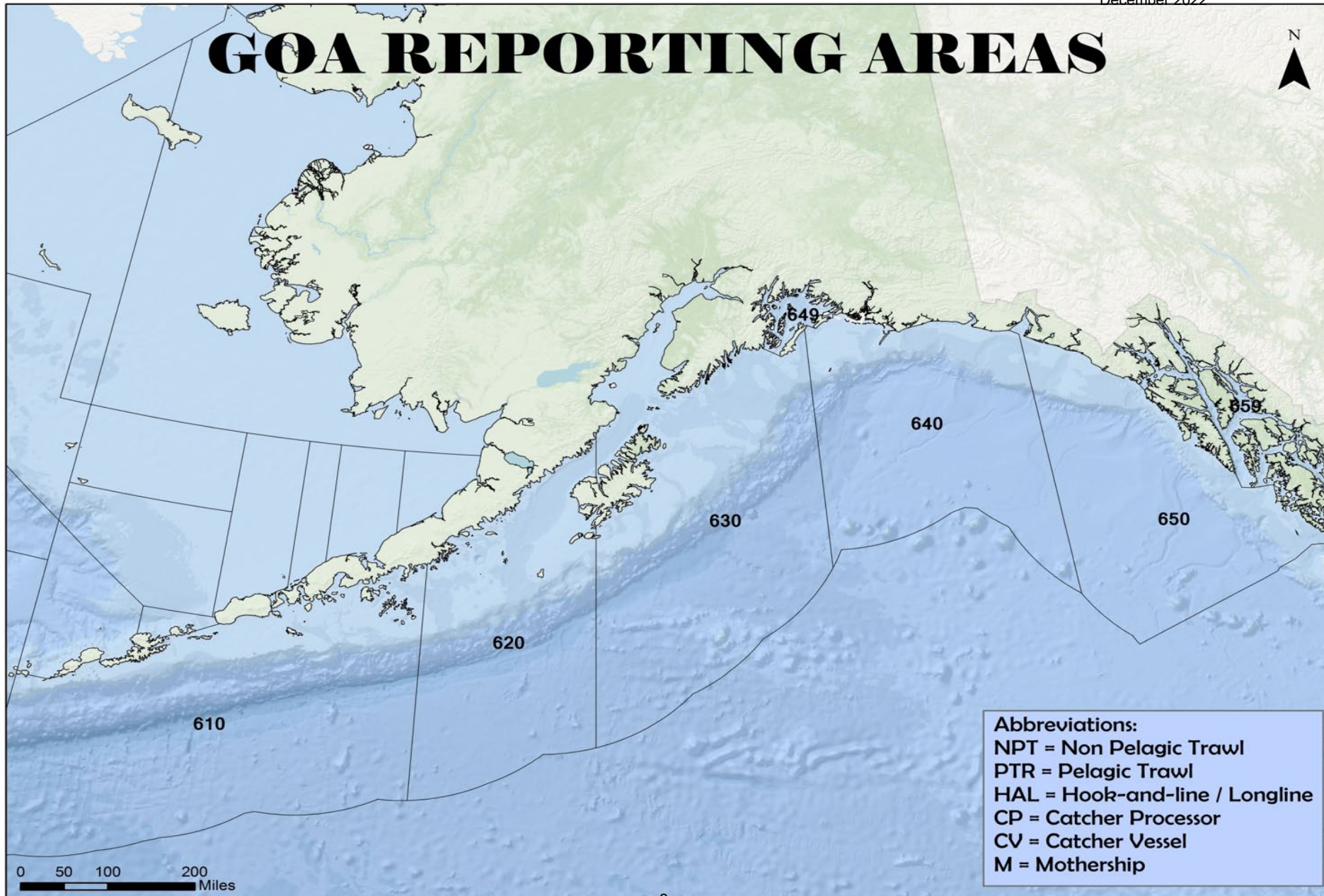

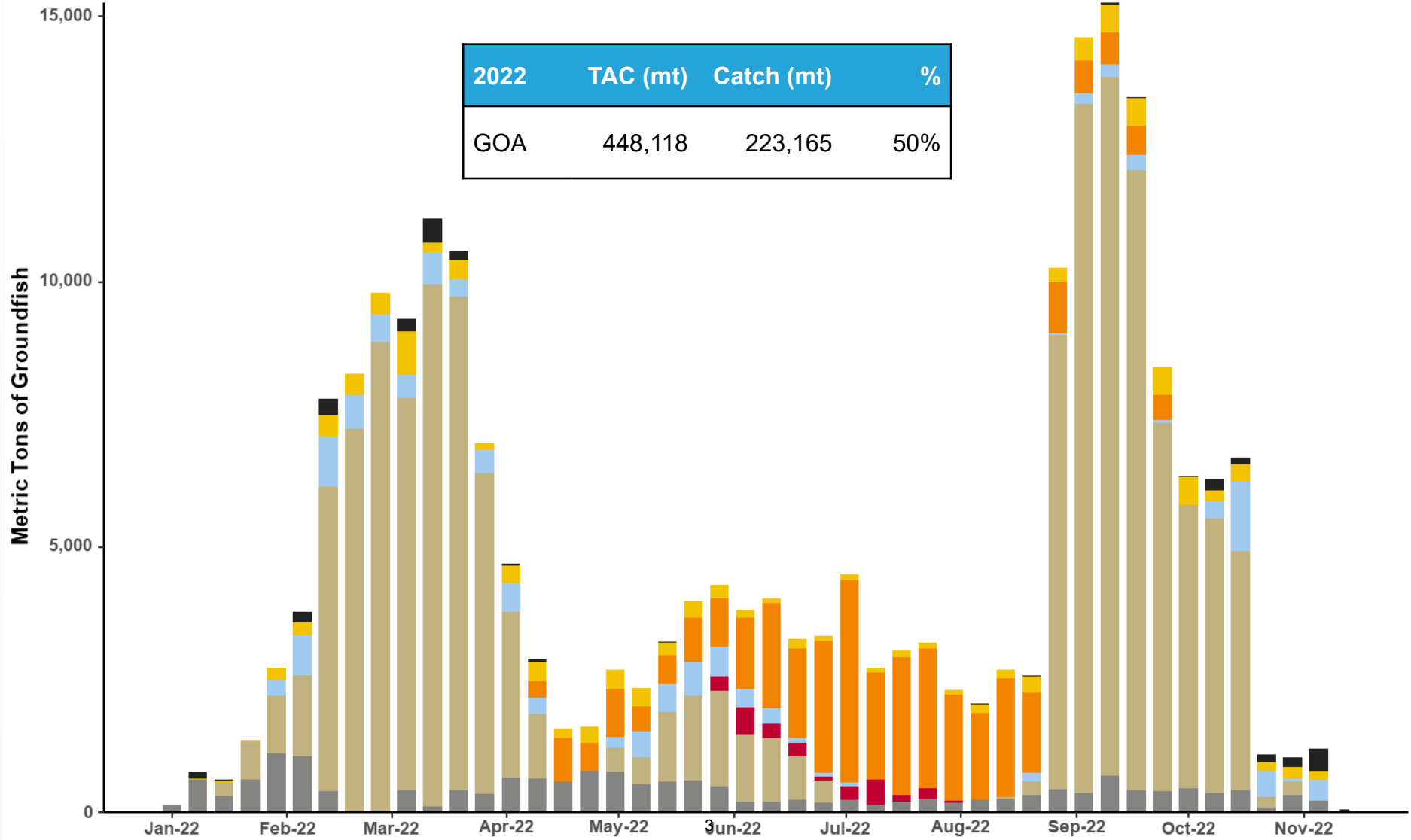

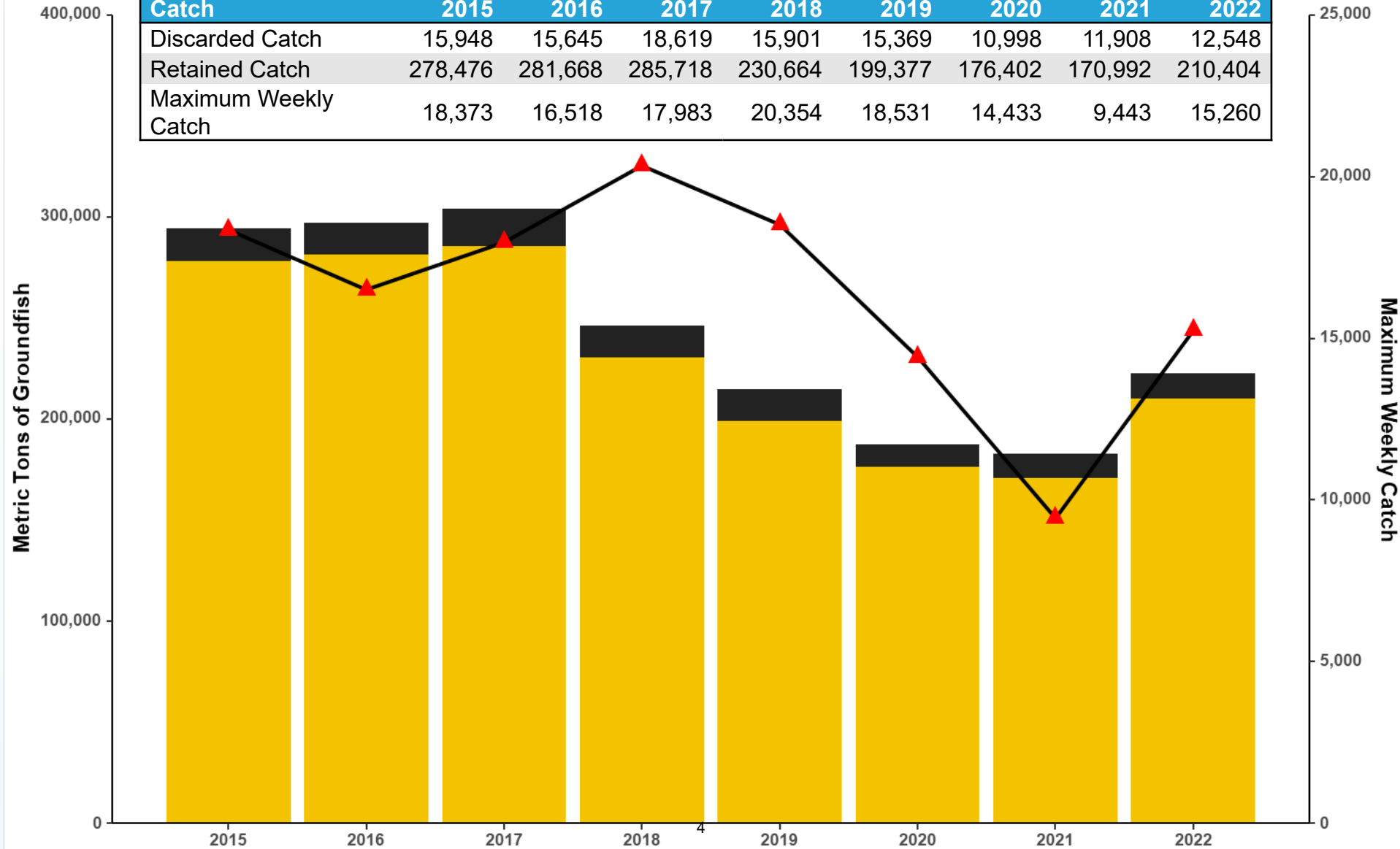


GOA Total Groundfish Catch and Maximum Weekly Harvest

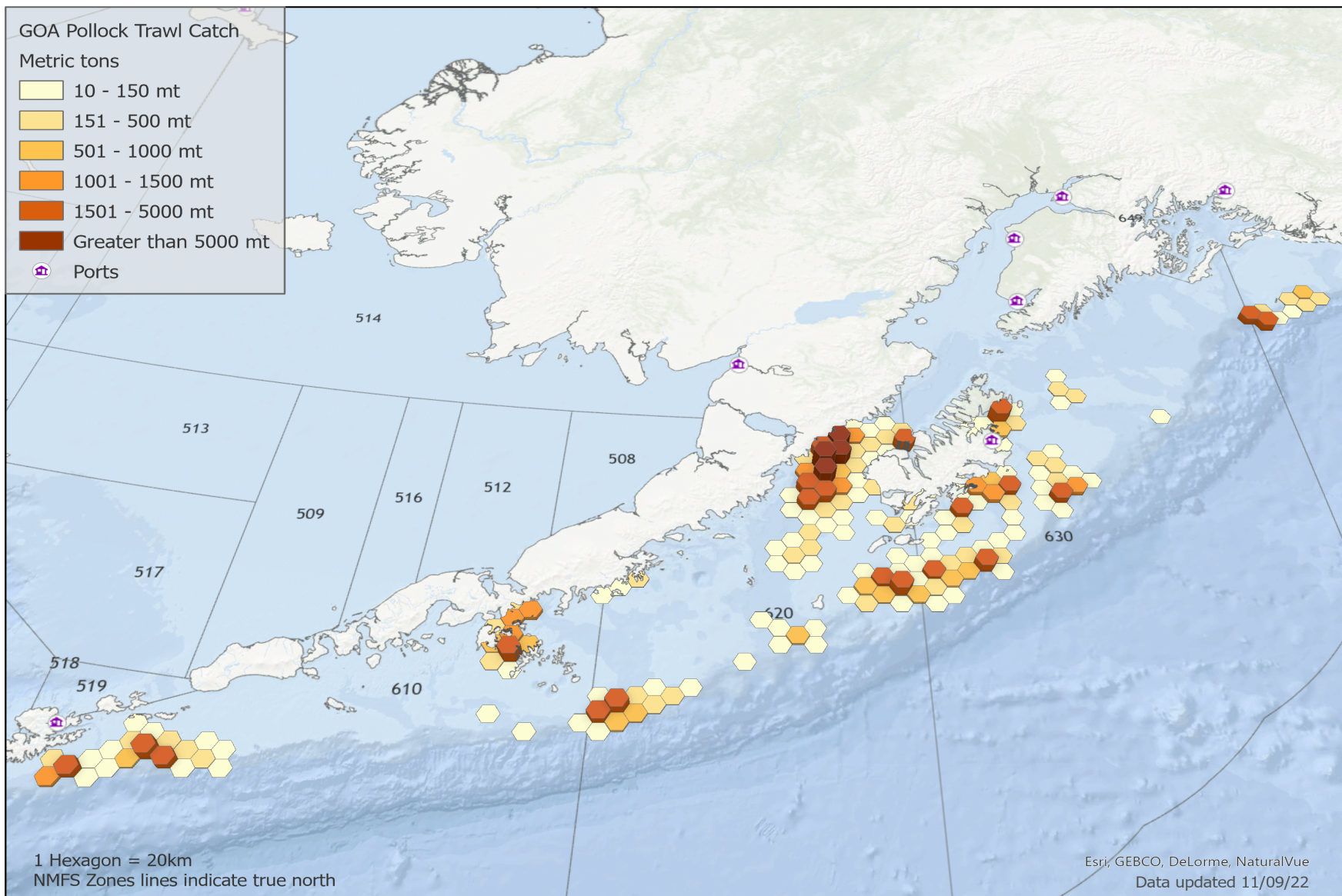

2022 Gulf of Alaska Pollock Directed Fishery

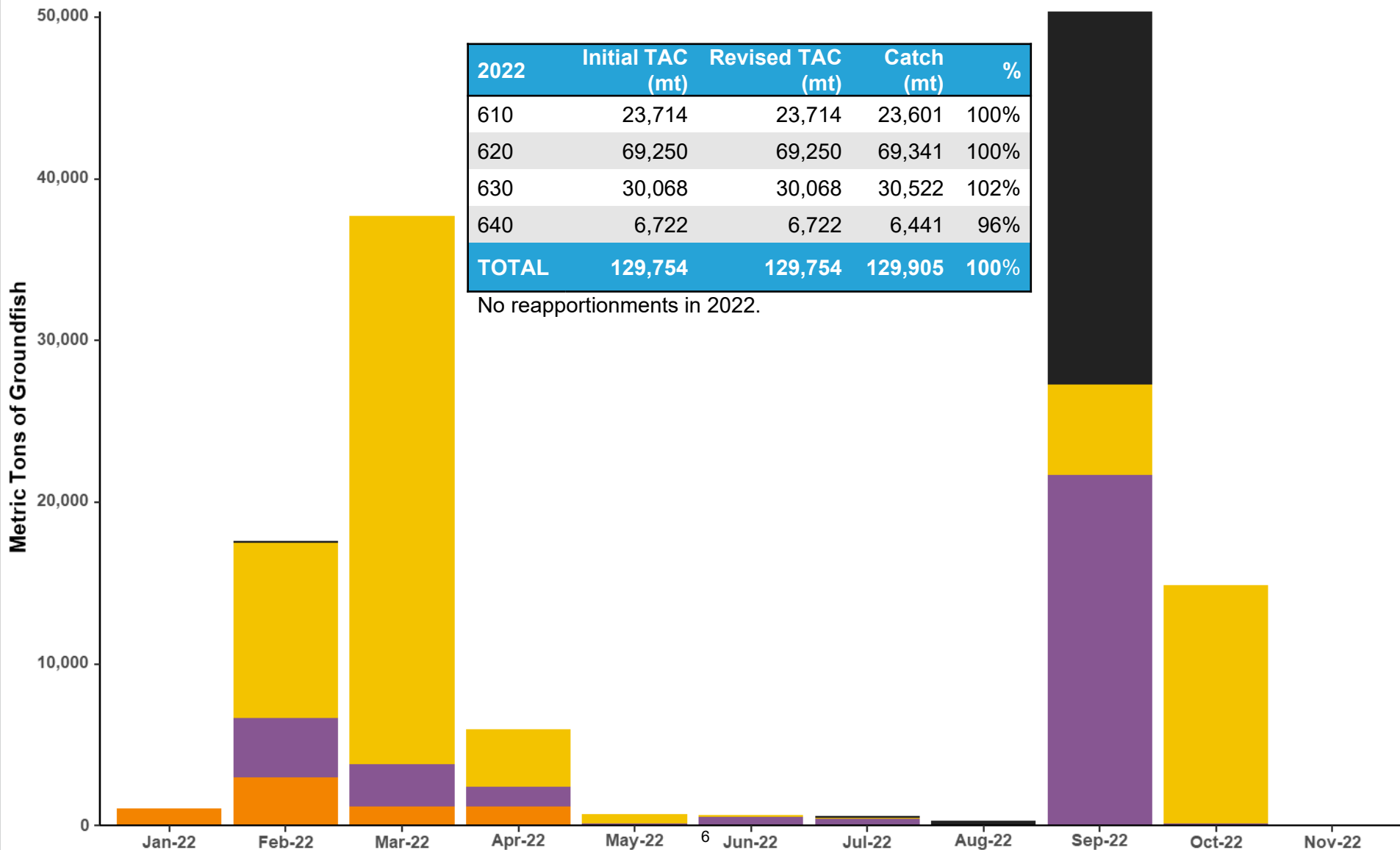

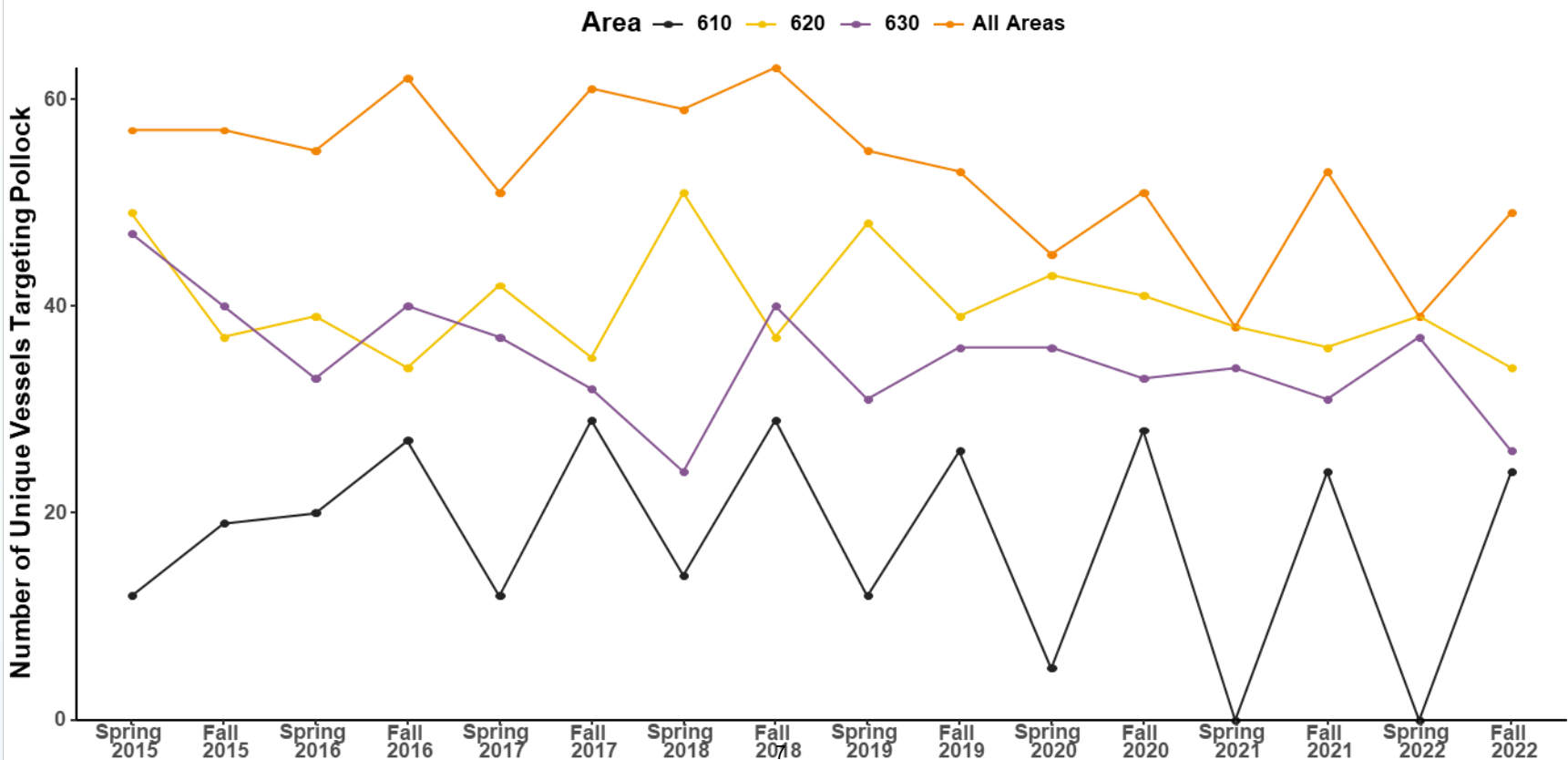

Counts of Vessels Targeting GOA Pollock

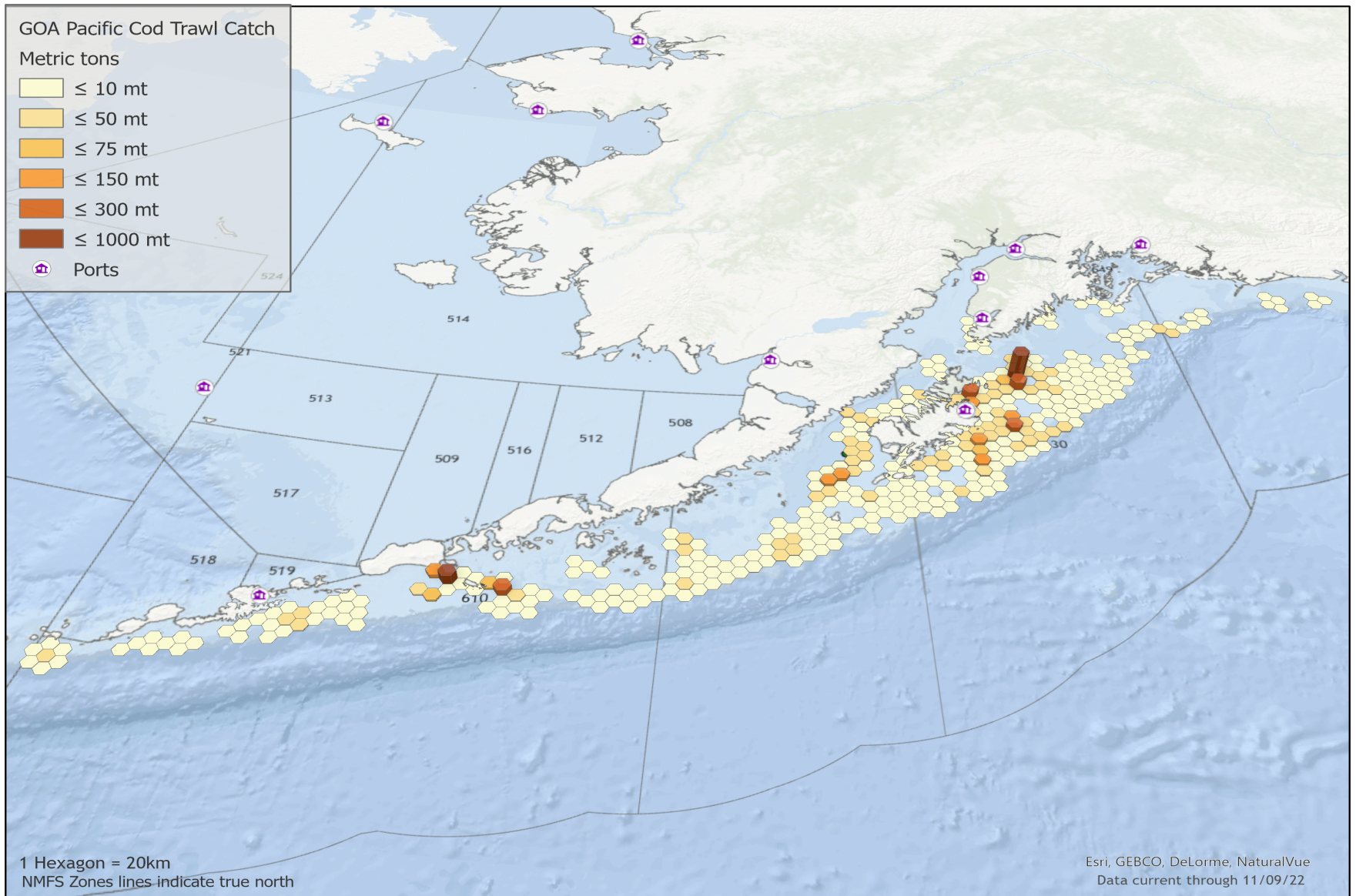

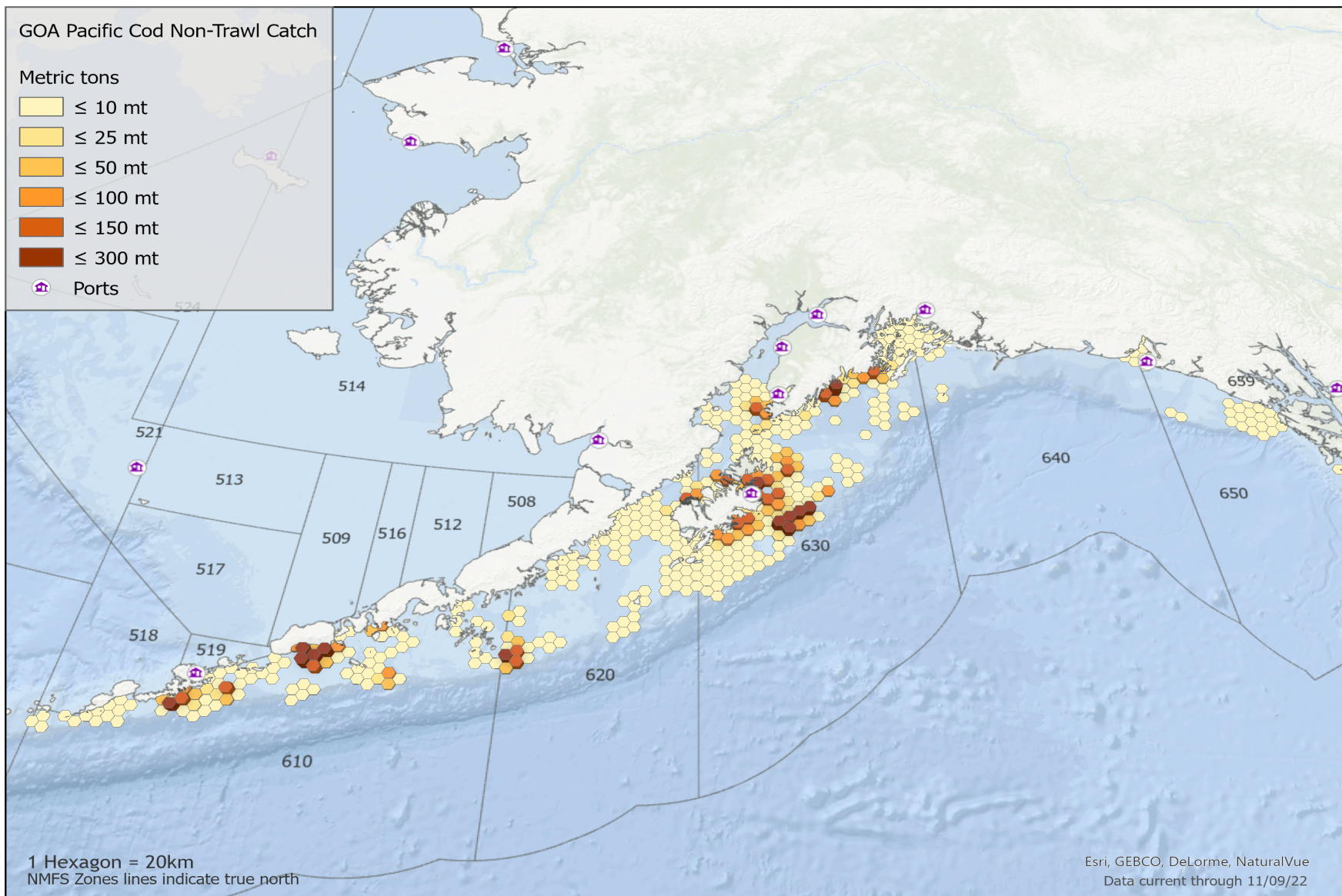
2022 Gulf of Alaska Pacific Cod Catch by Trawl Gear

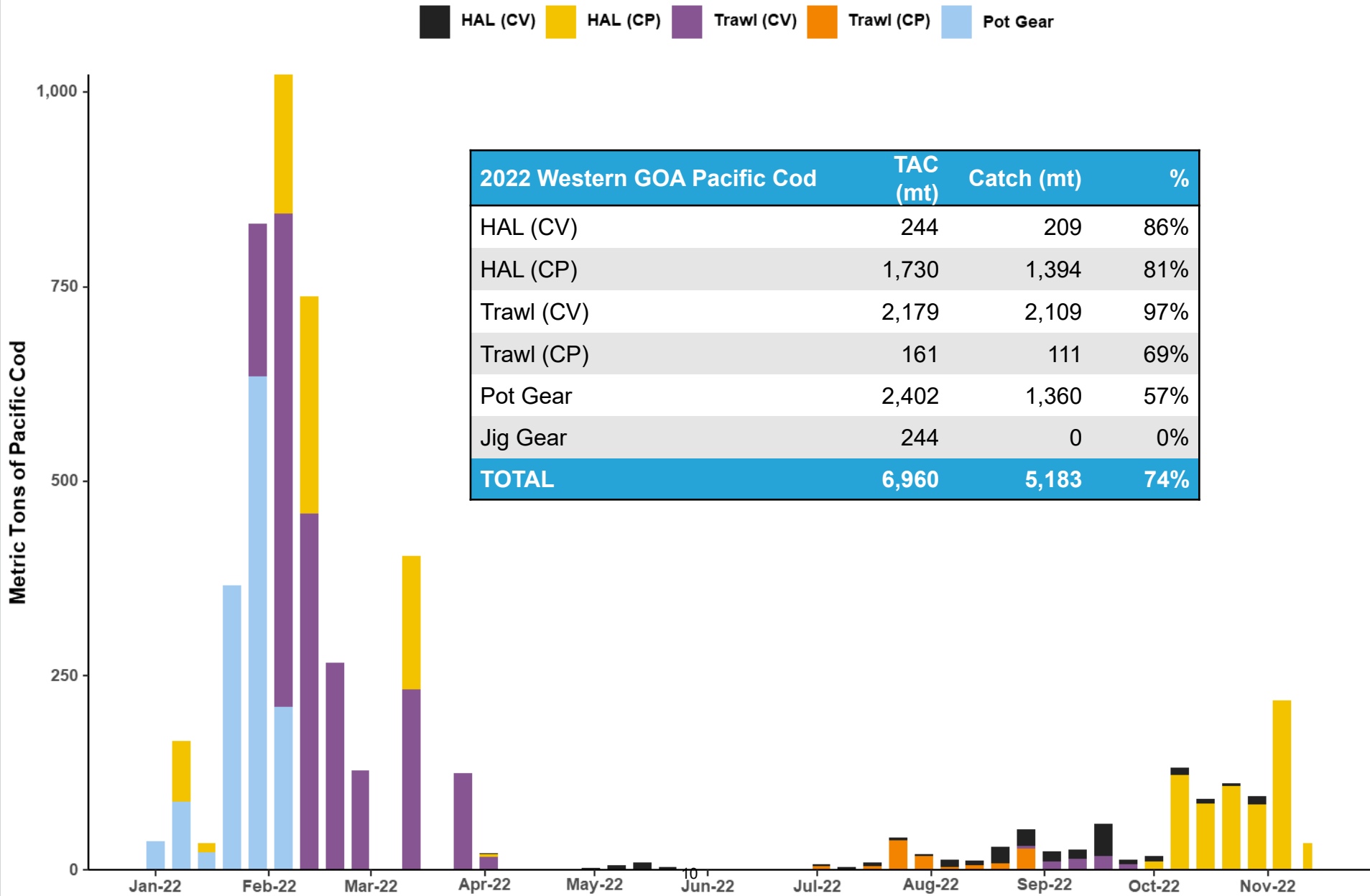
2022 Gulf of Alaska Pacific Cod Catch by Non-Trawl Gear

2022 Western GOA Pacific Cod Catch by Week and Sector

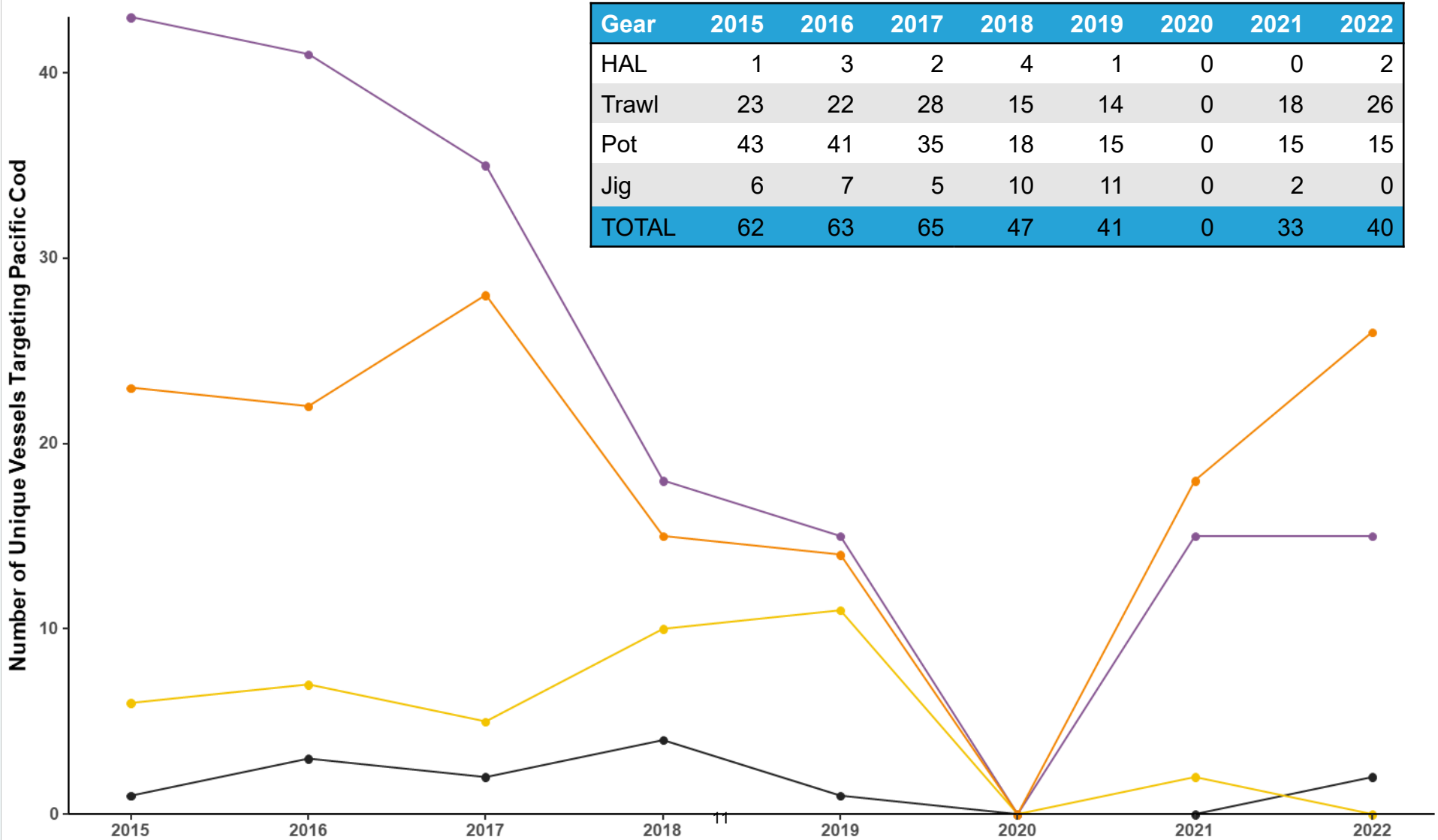

2022 Central GOA Pacific Cod Catch by Week and Sector

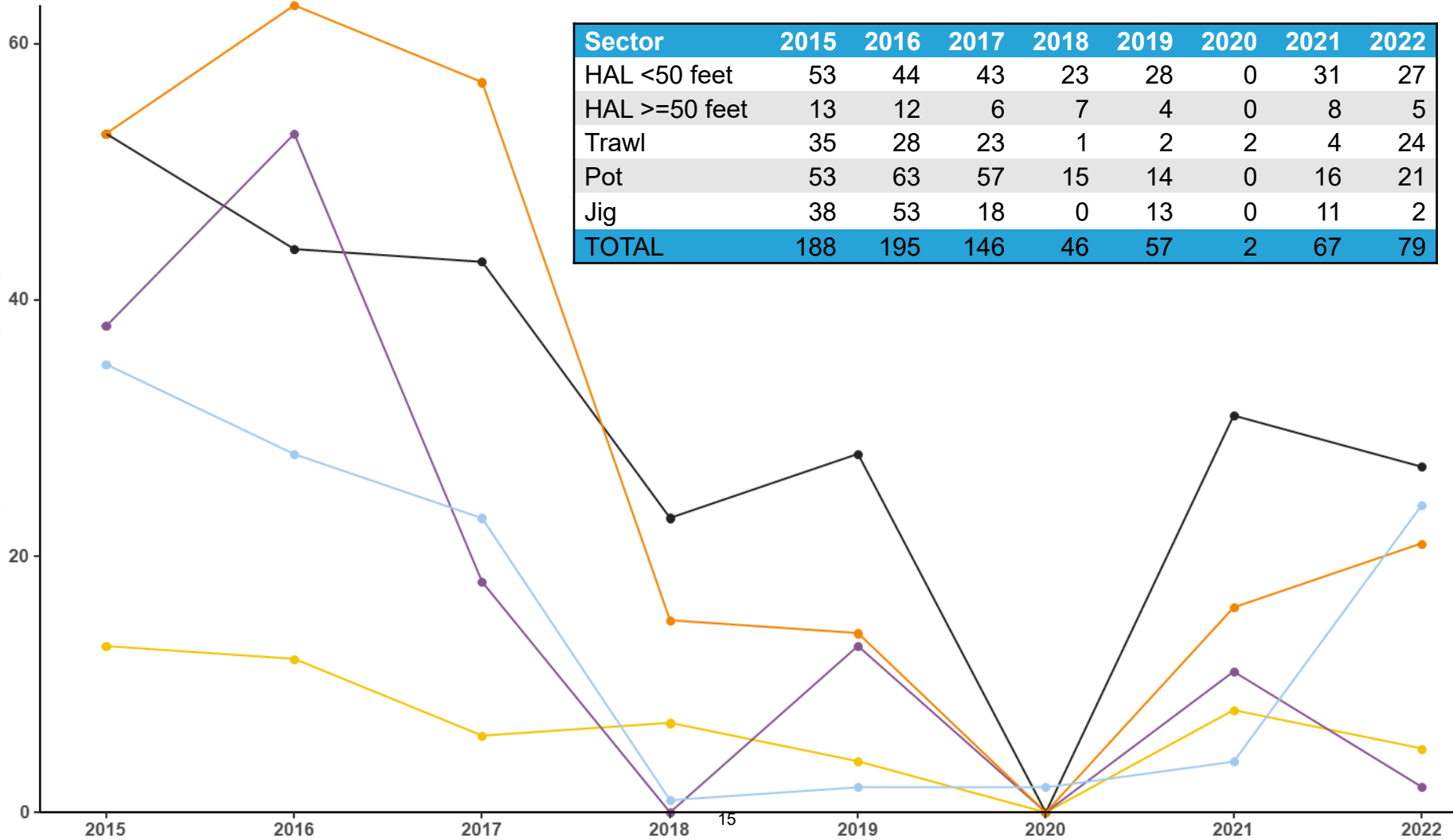

Counts of Catcher Vessels Targeting Central GOA Pacific Cod

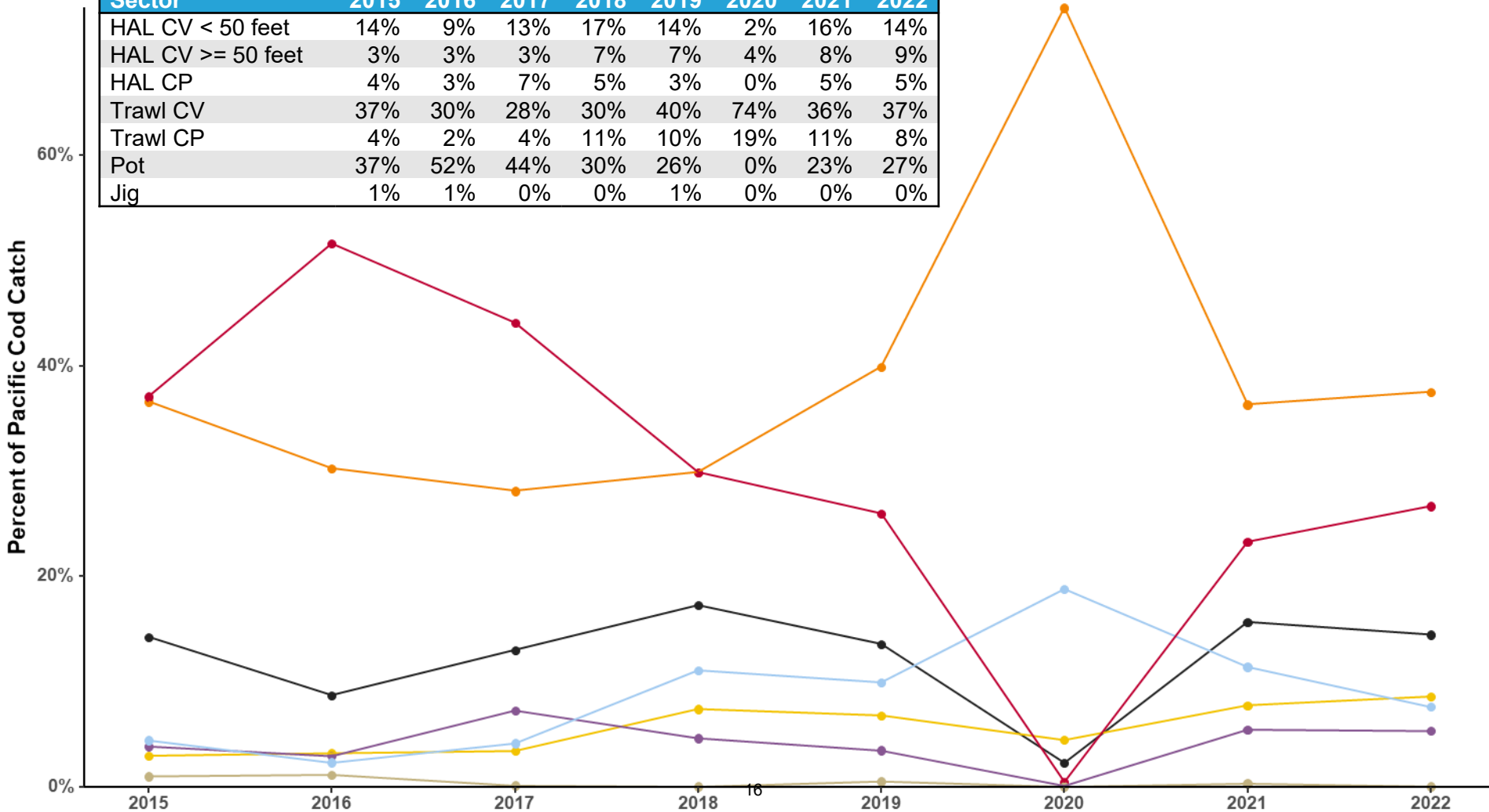

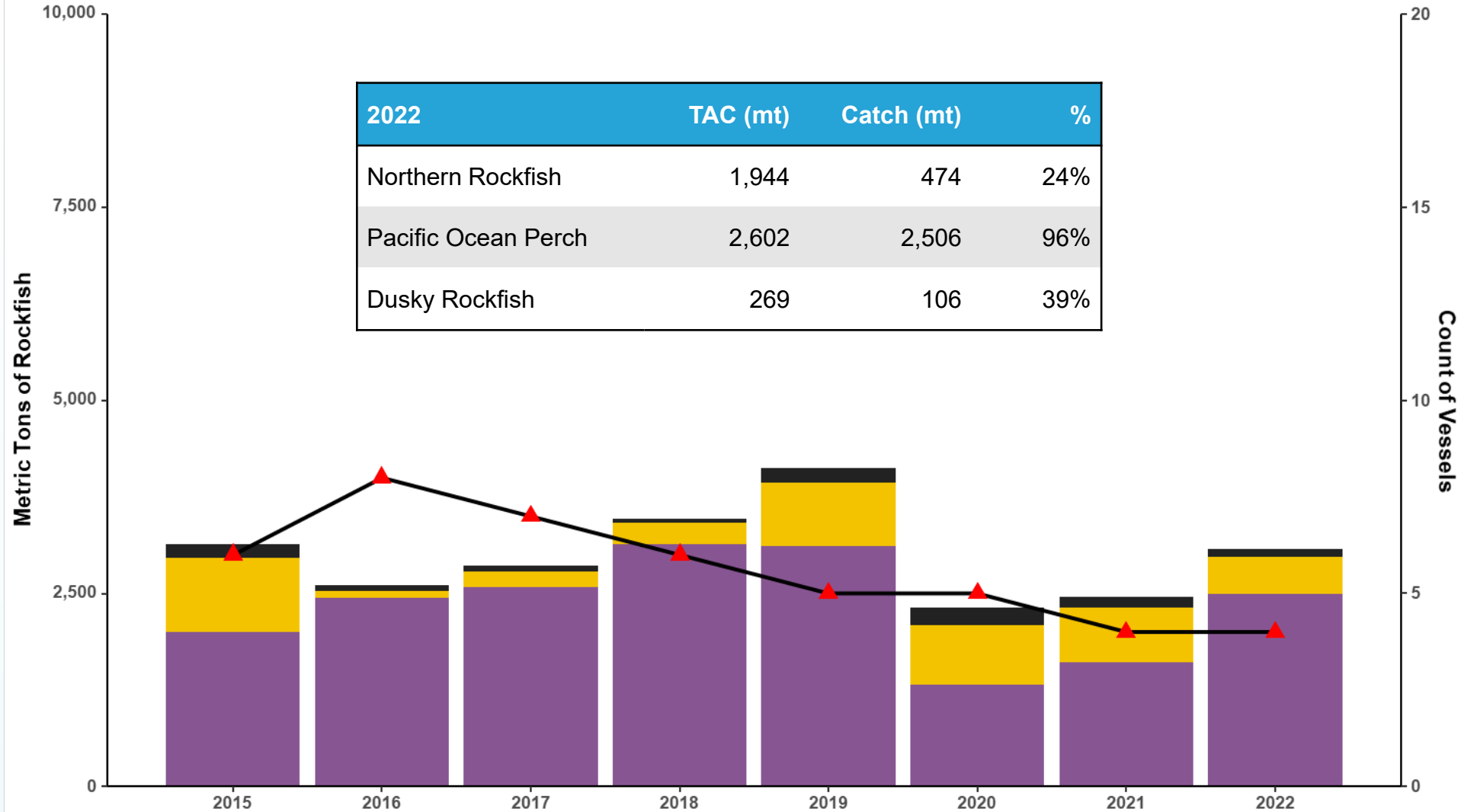

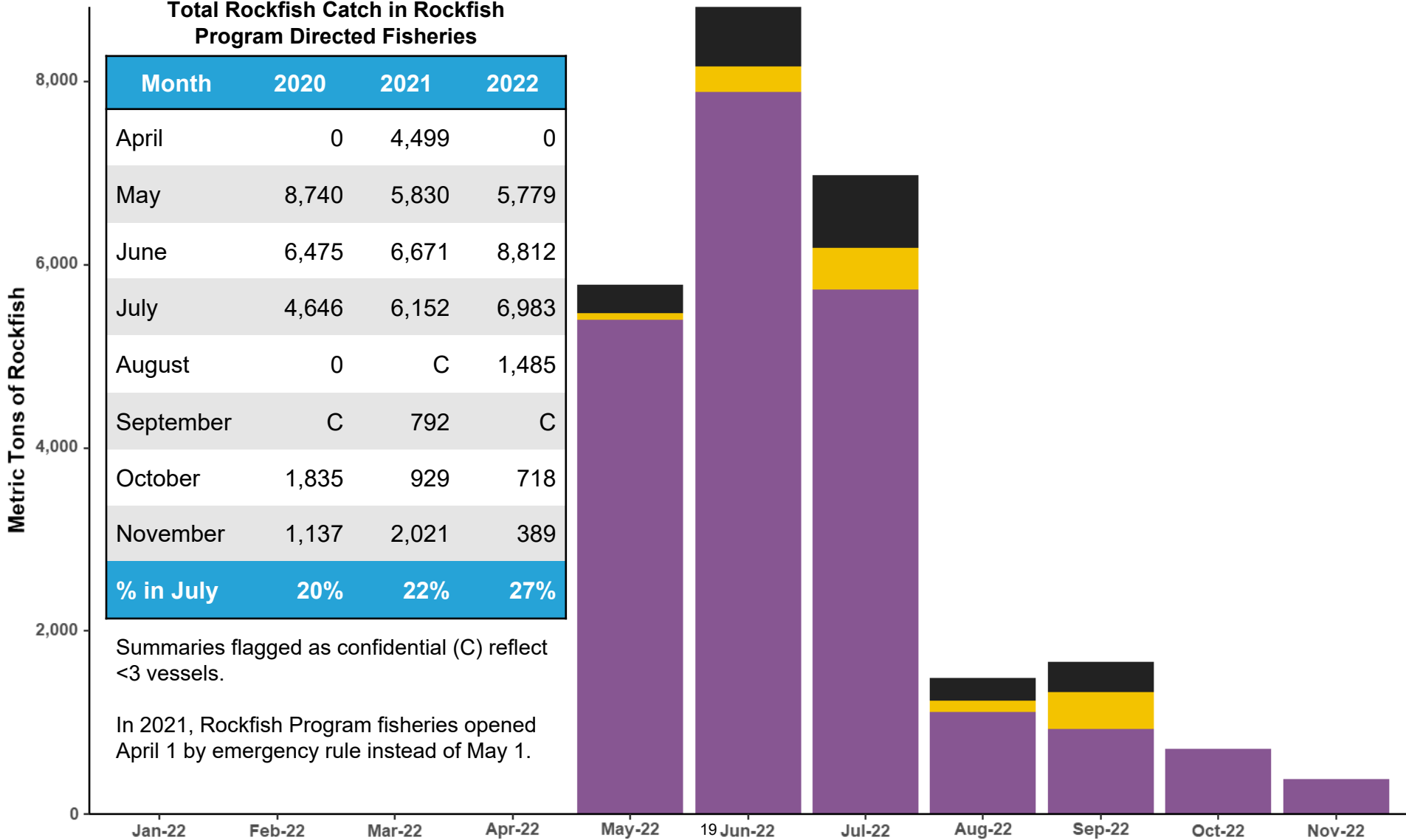

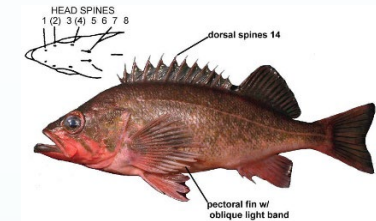


2022 Rockfish Program Allocations and Catch

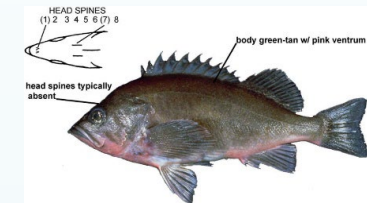

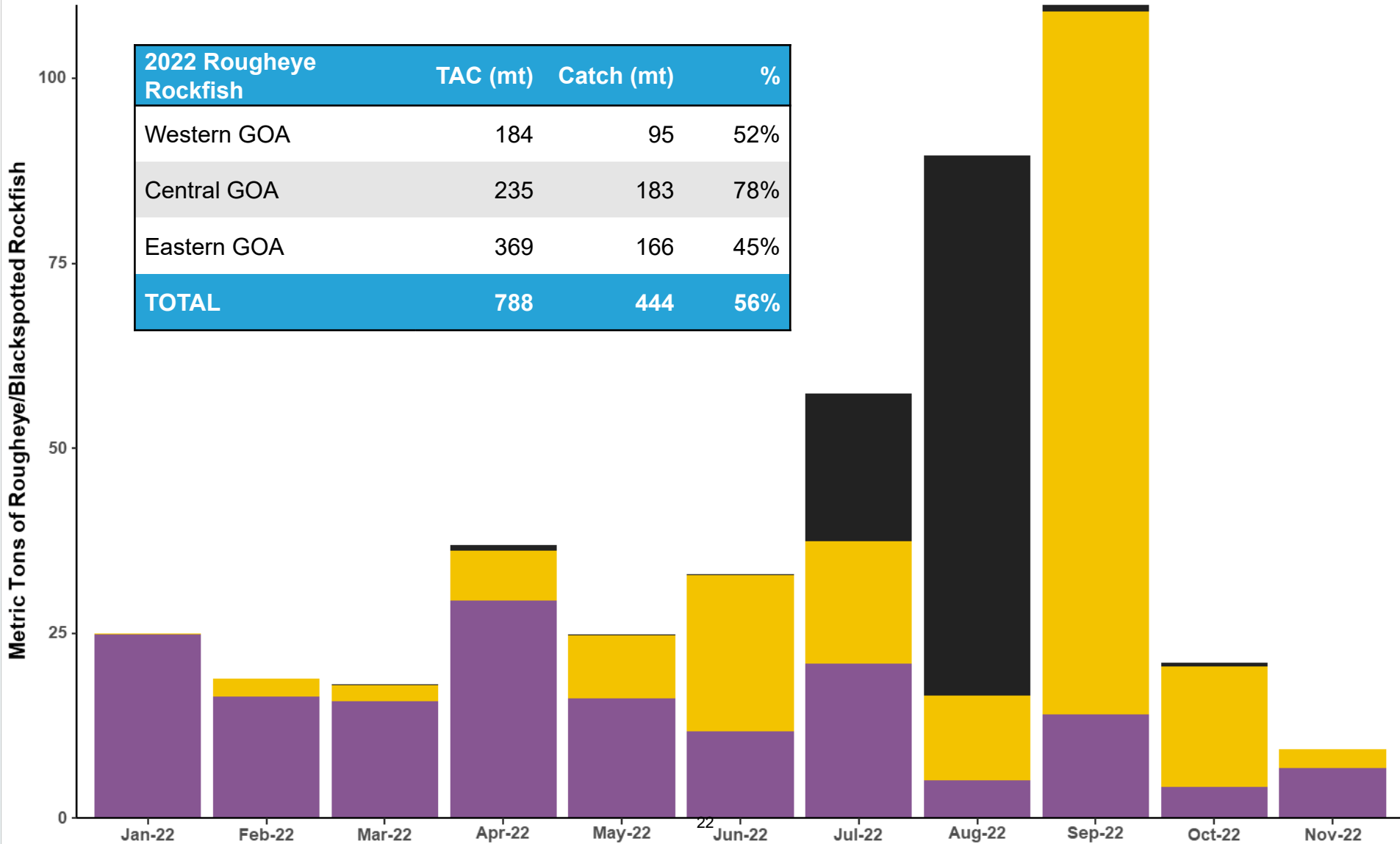

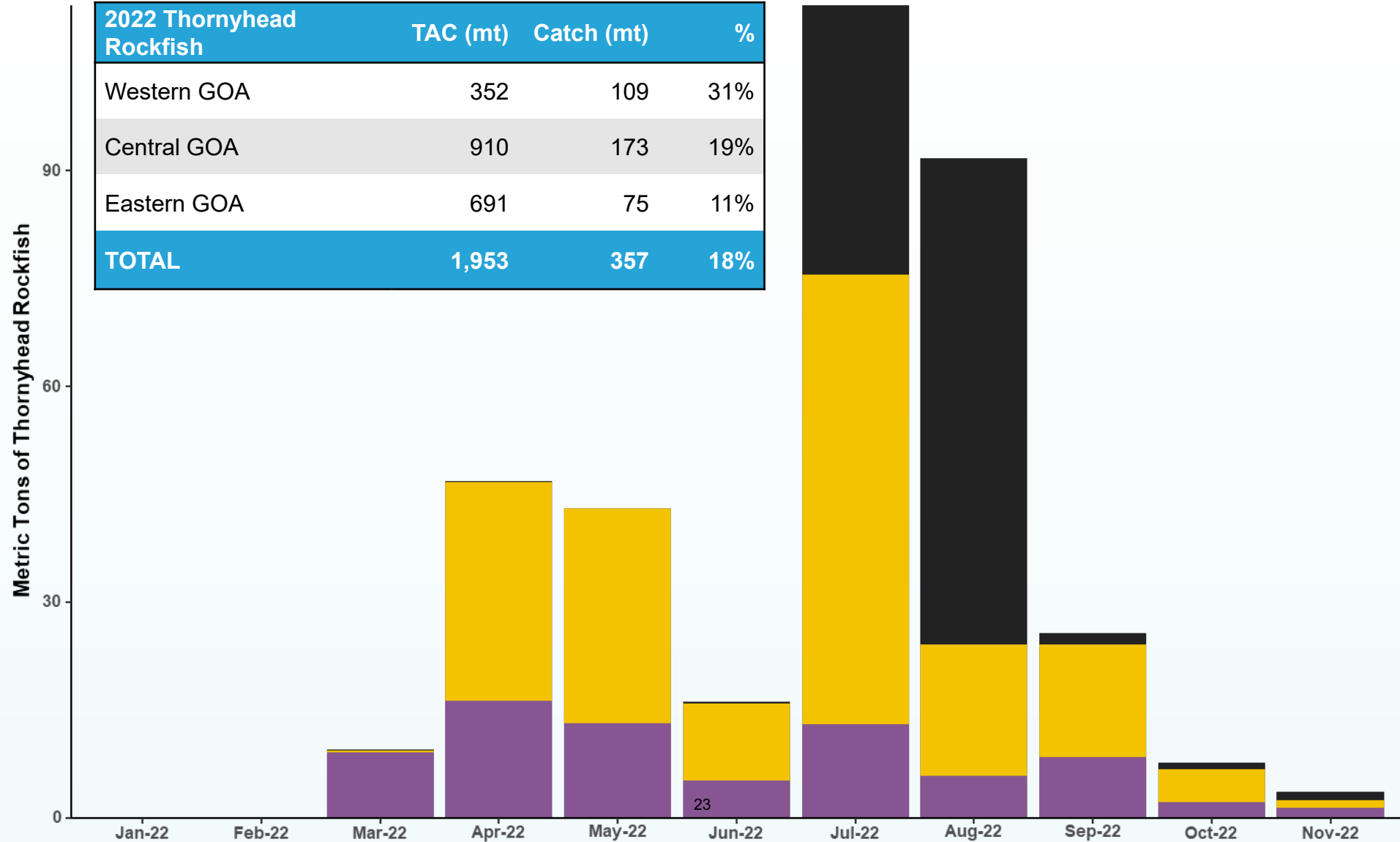

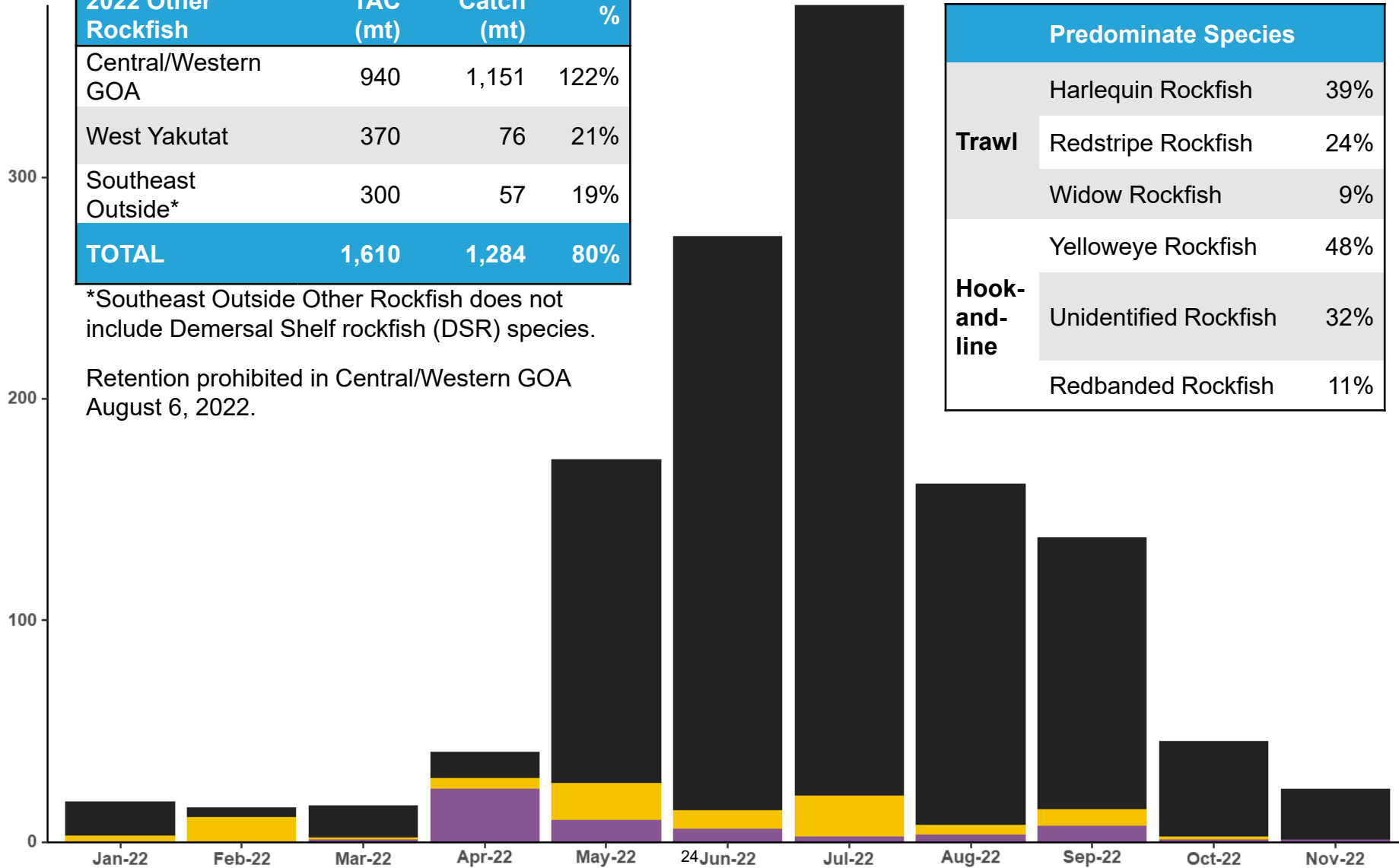

Metric Tons of Other Rockfish



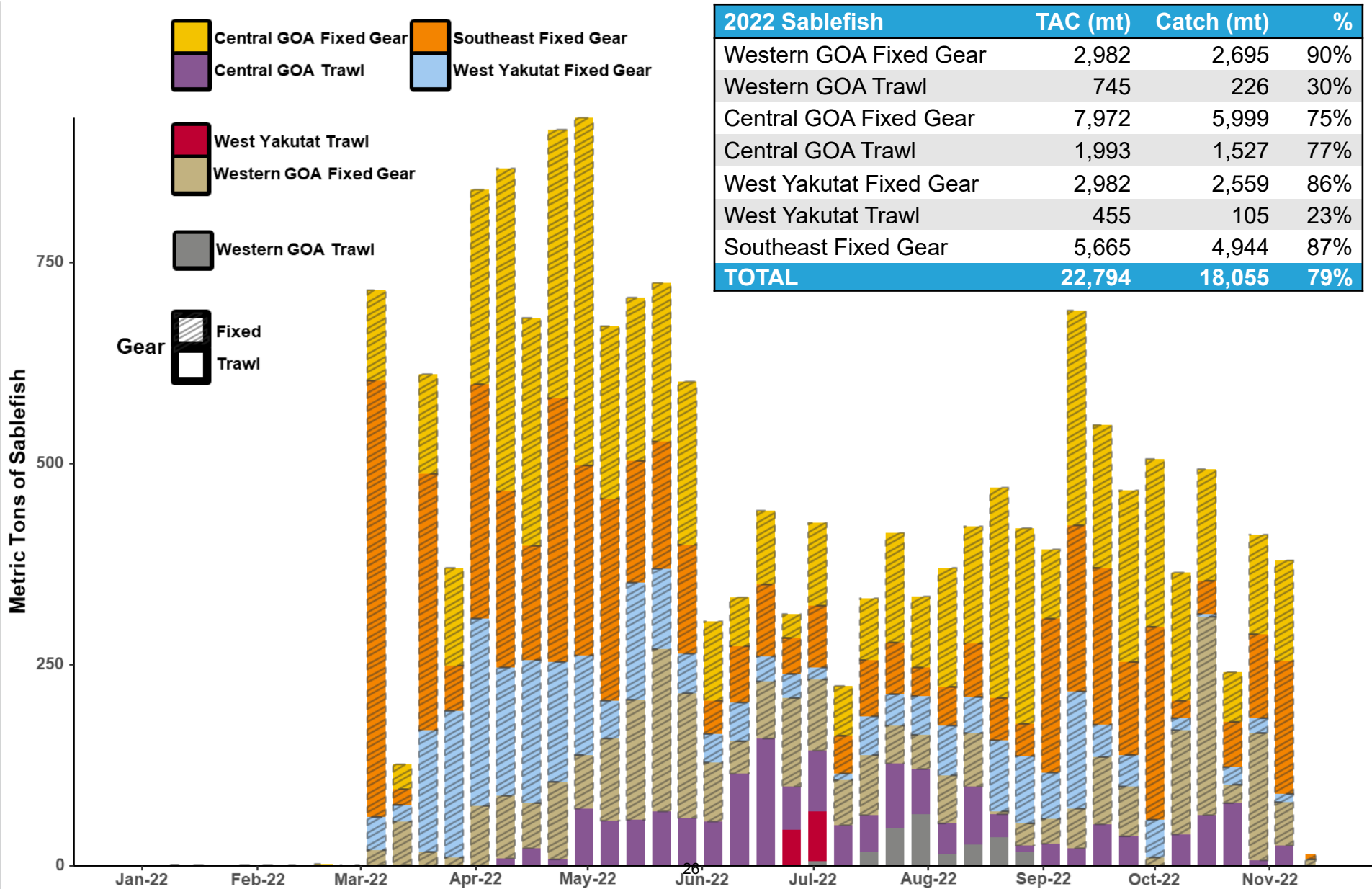

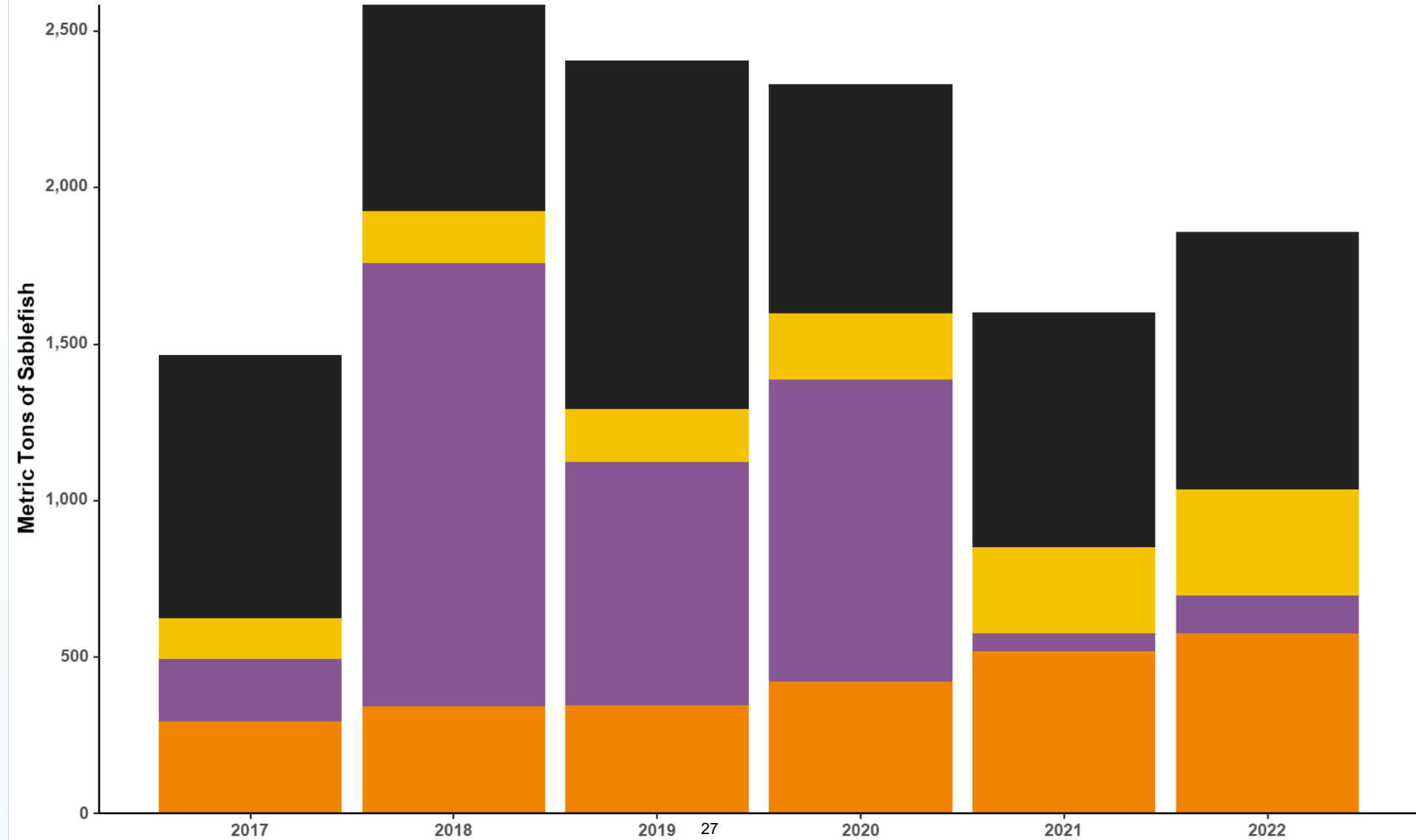

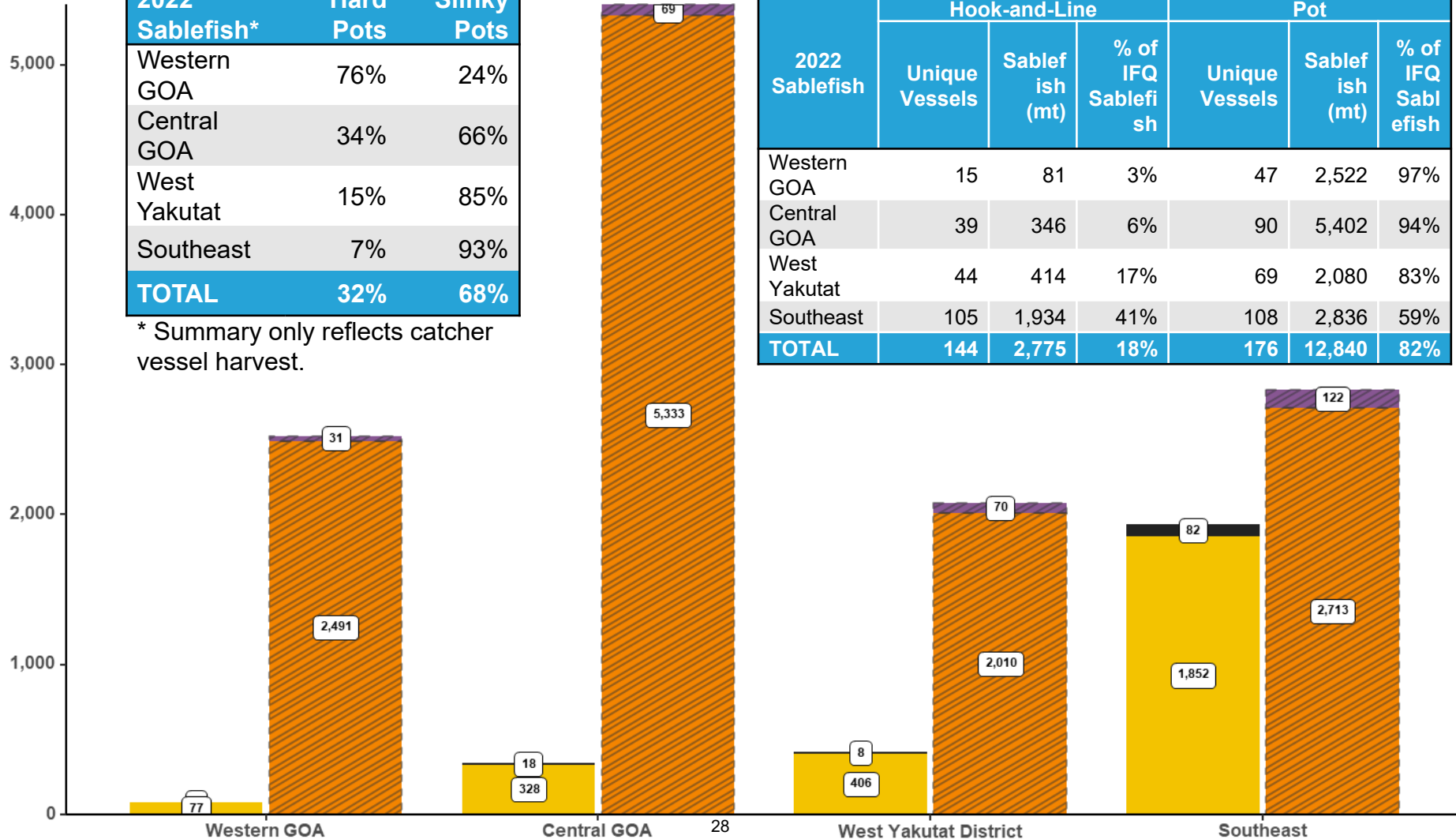

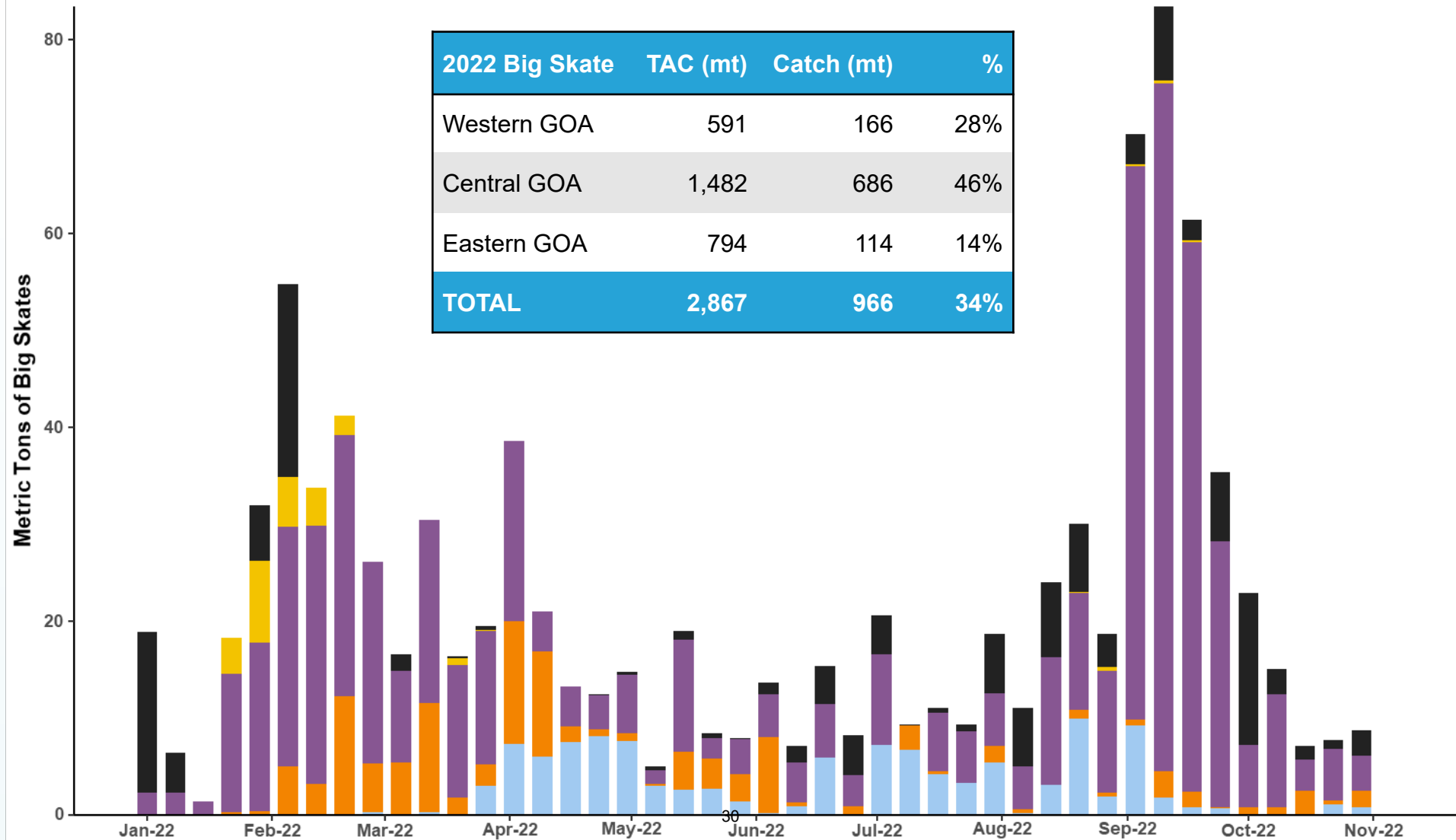

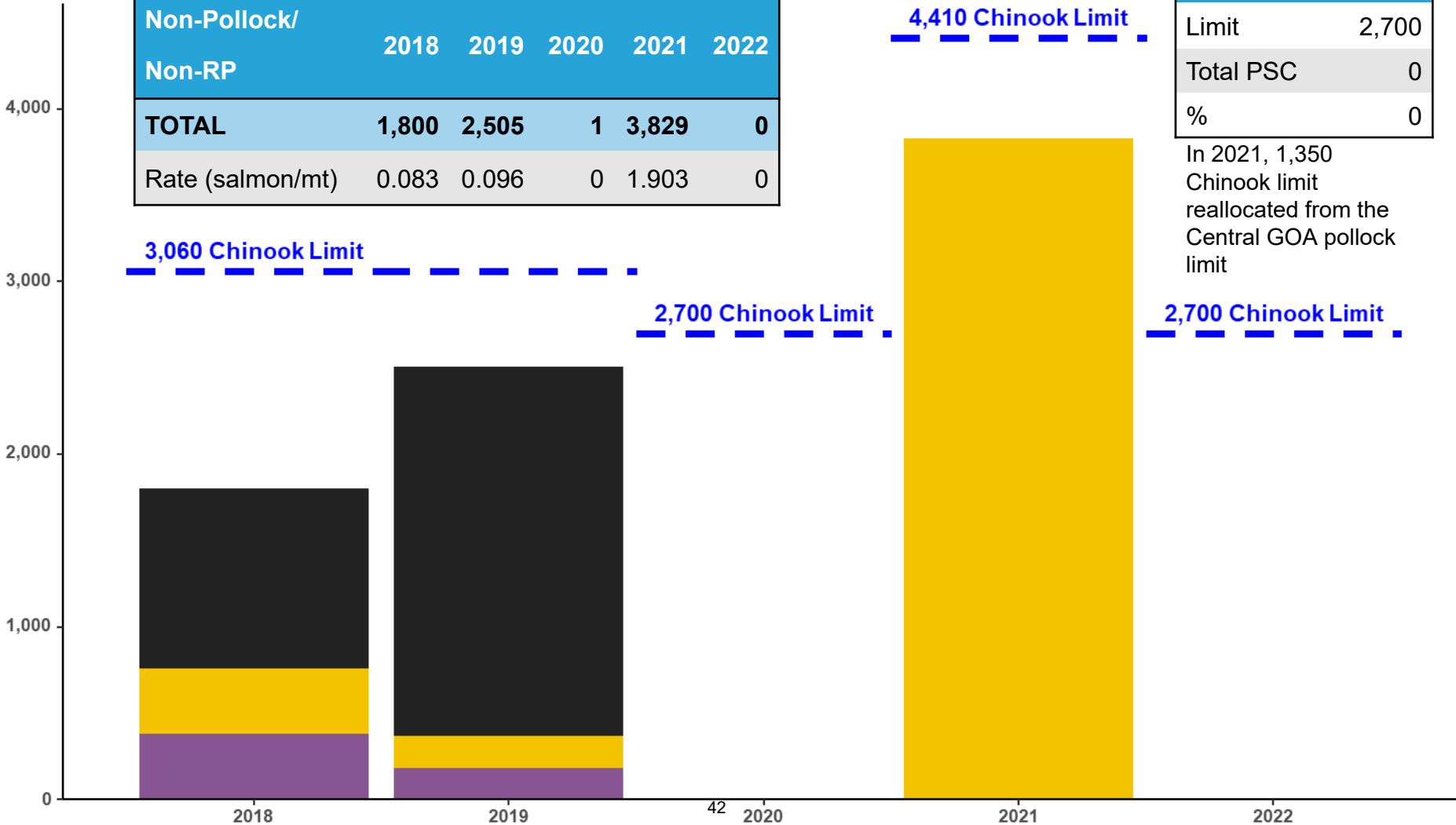

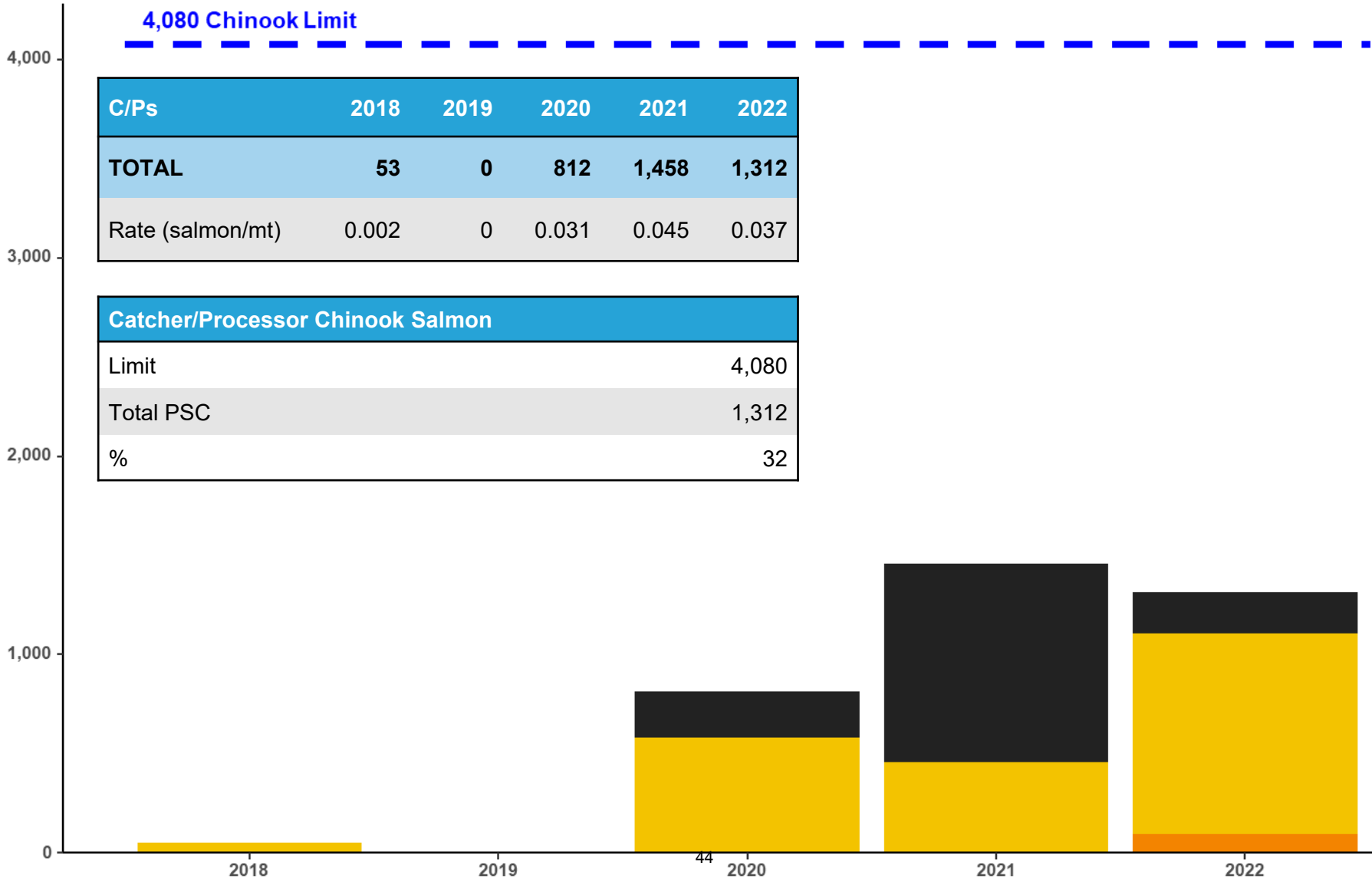
Number of Chinook Salmon

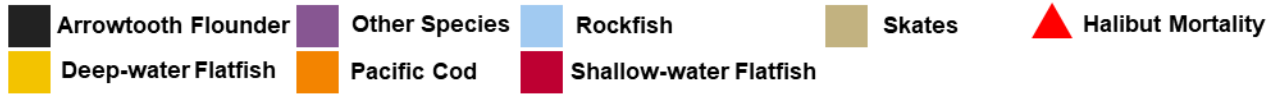

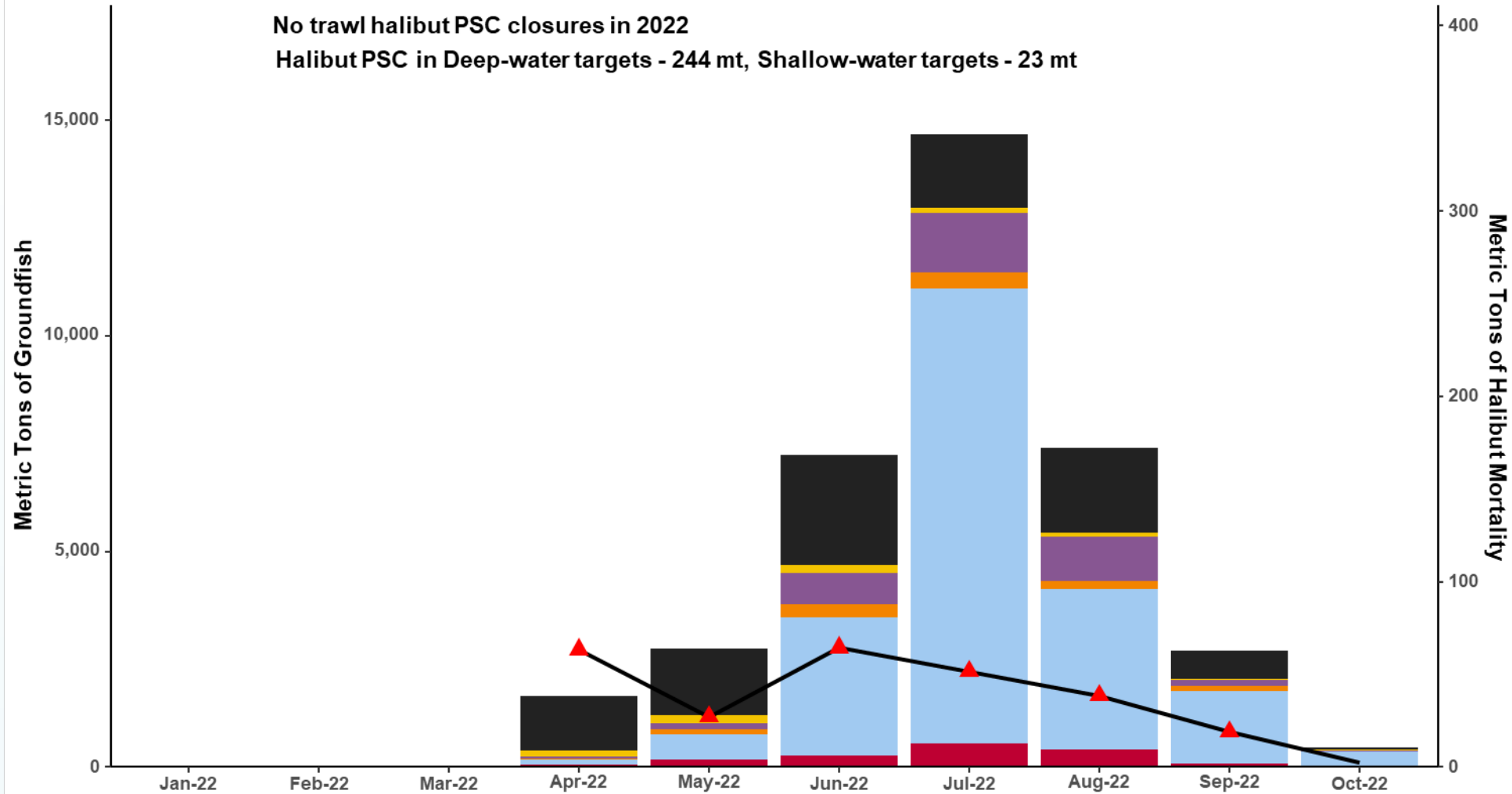

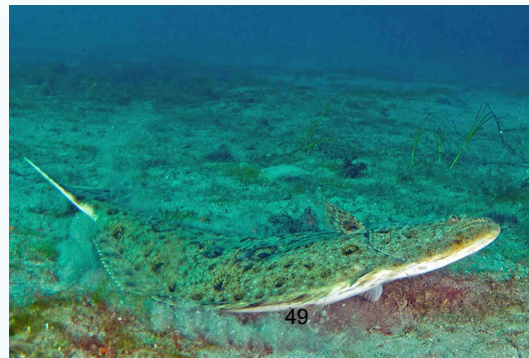
