ENFORCEMENT REPORT FOR THE PERIOD 4/3/2001 THROUGH 5/29/2001

National Marine Fisheries Service Alaska Enforcement Division

During the period since the last Council meeting, the Alaska Enforcement Division has opened 253 new cases. We currently have 405 open cases. The cases have been a mix between observer coverage, IFQ, and record keeping and reporting of groundfish.

Investigative Highlights:

- We continue to examine instances of failure to have sufficient observer coverage.
- We conducted a joint investigation with the Unalaska Police Department concerning an alleged sexual assault of an observer.
- We assisted in an observer misconduct investigation, which may lead to suspension or decertification of that observer.
- One of our special agents had the opportunity to meet with Russian Border Service investigators during the NPAFC's Enforcement Evaluation and Coordination (EEC) Committee meeting in Petropavlovsk, Russia.
- The owners of the Chinese owned fishing vessel MING CHANG requested depositions be held in China. The request was denied, and attempts are being made to conduct the depositions in the U.S. The Coast Guard seized the MING CHANG last year for fishing illegally in the U.S. EEZ. They posted a \$1.5 million bond and were released.

COPPS:


- Regulations that require a minimum distance of 100 yards from humpback whales take effect on July 1, 2001. We have worked with the NMFS Protected Resource office, the cruise ship industry, and charter industry to create a video that demonstrates the process for creating regulations, using this as an example. The video also demonstrates how we will be enforcing the regulation.


VMS:


- Our headquarters office is continuing to work on VMS as a national issue. It would be in our best interests to own the entire system, including the individual units placed on vessels. With current VMS funding, there is enough money to set up the system servers and hire people to run it, but there is not enough to buy each unit for all the fishing vessels that may require it. Outfitting the Highly Migratory Species fleet alone would use about half of the available funding.


Having enforcement buy units for each fishing vessel will probably be looked at on a "first-come, first-serve" basis.





I. High Seas Drift Net Enforcement

Operation Northern Watch, CGD17's HSDN Enforcement Plan, officially started on 14 March when D17 conducted its first patrol of the NPAFC Convention Area based upon information received from the FBS of suspicious activity. No illegal activity was detected.

An Ad Hoc Patrol Coordination Group was established at D17's headquarters in Juneau to coincide with the Canadian CP-140 HSDN deployment out of Shemya, AK during the month of April and the D17's patrols in early May. The NPAFC sponsored group was comprised of representatives from Canada, Russia, and the United States, with a representative from Japan participating via email. The purpose of the group was to improve operations planning and response to sightings of illegal activity. While there was no illegal activity detected within the Convention Area, the Group did develop a comprehensive standard operating procedures document for use in follow-on years.

D17 Coast Guard officers along with a National Marine Fisheries Service Special Agent, met with representatives from Canada, Japan, and Russia in Petropavlovsk-Kamchatsky, Russia from 13-18 May 2001 for the NPAFC Enforcement Evaluation and Coordination Meeting. The EECM was co-hosted by the Northeast Regional Directorate of the Russia Federal Border Service and the Kamchatrybvod and was sponsored by the NPAFC. The meeting included discussions by each party on enforcement plans and resources for 2001, and an HSDN assessment of the effectiveness of patrol efforts and coordination so far in 2001.

On 16 May, all parties participated in the first ever flight of an USCG HC-130 patrol staged out of Petropavlovsk-Kamchatsky. The final patrol sighting was of a trawler converted into a driftnet fishing vessel later identified as the Russian flagged FF/V Sakhfrakt-3. That vessel was observed driftnet fishing 15 NM inside the RS EEZ in an area adjacent to the NPAFC Convention Area. Federal Border Service Ship (FBSS) Dzerzhinsky immediately diverted to intercept the vessel. Upon boarding, the FBS found the vessel equipped for driftnet fishing having on board radio bouys, 5 driftnets with a combined length of 17 NM, processing equipment and shipping boxes. The Dzerzhinsky directed the vessel to recover its driftnets containing 1460 chum and spawning fish. The FF/V Sakhfrakt-3 was escorted to Petropavlovsk-Kamchatsky and charged with multiple counts of violations of Russian law.

II. US/Russian Maritime Boundary Enforcement

The first foreign fishing vessel activity detected on the maritime boundary was on 15 May when a CG HC-130 detected 3 vessels operating within 20NM of the MBL. Activity increased to 15 vessels by 19 May and has remained steady.

Coast Guard C-130's flew 9 sorties totaling 74 hours in May




Figure 2. 29 May 2001 M/B Scatter Plot of Aircraft Sightings

III. Donut Hole

No notices have been received from vessels intending to conduct trial fishing activities and no fishing activity has been observed in the Donut Hole during the reporting period.

IV. IFQ At-Sea/Dockside Enforcement

D17 continued its enforcement efforts both at sea and dockside and detected no significant violations. Overall, CG IFQ effort for the reporting period is as follows:


- 55 IFQ boardings were conducted at sea (77 year-to-date)
- 38 dockside offloads were monitored (82 year-to-date)
- 374.5 hours were spent surveilling ports for illegal IFQ activity (480.5 year-to-date)

There was 1 dockside violation for retention of halibut fillets onboard.

Figure 4. Boardings By Year





Figure 5. Violations By Year

VII. Steller Sea Lion Critical Habitat Enforcement

The CG continued monitoring critical habitat areas with cutter and aircraft totaling 1206 hours. No illegal activity was detected.

VIII. Miscellaneous

1. The National Weather Service and U.S. Coast Guard are partnering to improve the dissemination of local weather forecasts, predictions, and warnings throughout the Southeast, Prince William Sound, and Kodiak regions of Alaska. The project goal is to provide the Alaskan maritime community with accurate, timely and comprehensive weather information by increasing the NWS broadcast footprint using low power transmitters located at selected CG VHF-FM high sites to deliver continuous local weather products. Two experimental sites have been installed and are functioning at Mount Robert Barren in Southeast and Pigot Point in Prince William Sound Alaska.
