


Summary of NMFS Management 1991 (Compiled from FR Notices and News Releases)

- June 21: Retention of shortraker/rougheye rockfish prohibited in Central and Eastern GOA.
- June 17: Sablefish fisheries closed in Central GOA, leaving remaining TAC for bycatch.
- June 13: Pollock TAC of 100,000 mt implemented in W/C GOA, allocated 50-50 between east and west areas (separated at 154 W), and by quarter such that 12,500 mt is available in each subarea quarterly. Carryover from first quarter brings total to 13,000 mt. Sea lion measures also implemented.
- June 10: Sablefish fisheries in West Yakutat closed.
- June 6: Directed rock sole fishery in BSAI ends because secondary halibut PSC is taken.
- June 1: Directed pollock fisheries in Bering Sea will reopen for non-roe season of approximately 605,000 mt. Aleutians will not reopen again in 1991. In Bering Sea, non-pelagic trawls cannot be used unless there is sufficient halibut PSC for the DAP Other Fishery to resume in the Bering Sea subarea outside Zones 1 and 2H on July 1. Reporting area 512 will remain closed to all trawling for the rest of 1991. Area 516 remains closed to all trawling until June 15, 1991 when pollock fishing may resume for all gears except non-pelagic trawls in that reporting area.
- May 25: Sablefish directed fishery with hook-and-line gear closes in Southeast Outside/East Yakutat District of the Eastern Regulatory Area of the Gulf of Alaska.
- May 17: State of Alaska closes northern Southeast Outside District in Eastern Gulf of Alaska to directed fishing for demersal shelf rockfish. Complex includes Canary, China, Copper, Quillback, Redbanded, Rosethorn, Tiger, and Yelloweye rockfish species of Sebastes.
- May 15: Directed fishing for sablefish by hook-and-line gear begins in GOA. All processors must submit daily production reports for sablefish taken in the Central and Western GOA.
- May 13: Greenland turbot TAC in BSAI is reached and becomes prohibited species.
- May 13: Based on implementation of A-16, directed fishing for pollock with any gear is prohibited in the entire BSAI, and directed fishing for Pacific cod with any trawl gear is prohibited in the entrie BSAI. The Bering Sea pollock fishery will reopen to all gears except non-pelagic trawls on June 1. The Aleutian subarea remains closed for all gears for the rest of 1991. Pacific cod will reopen for trawls in the BSAI outside Zones 1 and 2H on July 1, pending availability of halibut PSC.
- May 8: GOA: second quarter halibut PSC for trawl gear, 600 mt, has been taken and bottom trawling closes through June 30 when the third quarter halibut trawl allowance of 400 mt will become available.

- May 6: Vessel incentive program to reduce halibut and red king crab bycatch in specified groundfish trawl fisheries is implemented.
- May 3: Prohibition on retention of Other Rockfish in any fishery in the BSAI.
- May 3: Annual primary halibut PSC taken and Zones 1 and 2H closed down to directed bottom trawling on cod and pollock for rest of 1991. Second quarter halibut PSC for DAP Other fishery taken and BSAI closes for bottom trawling until July 1, 1991 when about 450 mt of halibut bycatch will be available outside Zones 1 and 2H for the rest of 1991.
- May 2: Prohibition on retention of POP in Bering Sea subarea because total TAC has been taken.
- May 1: Flatfish fisheries for yellowfin sole, Greenland turbot, arrowtooth flounder and other flatfish opens in BSAI. Directed fisheries for Greenland turbot remains closed in Zone 1 as there is no halibut PSC apportioned to that fishery.
- April 29: Cannot conduct directed fisheries with any gear for Pacific cod in the Central GOA.
- April 27: Directed fisheries for POP in Western GOA closes.
- April 22: Prohibition on directed fishing on Pacific cod in Zones 1 and 2H because primary halibut PSC reached. Closure is efective until July 1 when the third quarter halibut apportionment for the DAP Other fishery becomes available.
- April 22: Directed fisheries for POP close in the Eastern GOA.
- April 14: Central GOA closed to directed fishing for shortraker-rougheye rockfish group.
- April 12: Lower Cook Inlet closed to pot and trawl gear for groundfish to protect molting king crab.
- April 12: Closed Southeast Outside/East Yakutat District to retention of sablefish taken in trawls.
- April 8: Following fisheries are closed to retention by any gear: Eastern Gulf pollock, Central Gulf Pacific Ocean Perch, and Western Gulf shortraker/rougheye rockfish group.
- April 1: BSAI reopens to non-pelagic trawling for Pacific cod in the DAP 'Other Fishery'. The opening is the result of the second quarter's apportionment of halibut bycatch becoming available. About 950 mt halibut are available because of excessive bycatch in the first quarter. Fishermen were cautioned that the <u>C. bairdi</u> bycatch limit in Zone 1 is being approached.
- March 29: Prohibited retention of Atka mackerel in BSAI for rest of 1991.
- March 23: WGOA Pacific cod closed to directed fishing.
- March 23: AI pollock closed to directed fishing by all gears. TAC is 85,000 mt with 83,000 mt for directed fishery.

- March 21: Southeast Outside (Area 65) demersal shelf rockfish closed to directed fishing. Includes Canary, China, Copper, Quillback, Redbanded, Rosethorn, Tiger and Yelloweye rockfish.
- March 15: Domestic rock sole fishery closed in Zones 1 and 2H of the Bering Sea for rest of year due to primary halibut PSC being taken.
- March 8: Closed DAP Other fishery in BSAI because secondary halibut PSC attained. Will reopen April 1.
- March 1: Closed Western and Central GOA to further retention of pollock.
- February 25: Closed Western and Eastern GOA to directed fishing for shortraker-rougheye rockfish species group.
- February 22: Closed Bering Sea subarea to directed pollock fishing until non-roe season starts on June 1.
- February 17: Closed Zones 1 and 2H BSAI "DAP other fishery" to directed fisheries by non-pelagic gear because primary first quarter halibut PSC (1200 mt) was reached. Fishery will reopen April 1 when second quarter PSC becomes available.
- February 17: Closed Bogoslof District to directed fishing for pollock. Directed fishery will resume on June 1 with the beginning of the non-roe season.
- February 15: Closed W/C Gulf of Alaska to directed fishing for pollock after harvest of 16,500 mt, leaving 1,000 mt of the quarterly interim TAC of 17,500 mt for bycatch.
- February 4: Closed directed fisheries for demersal shelf rockfish in portions of Southeast Outside District: east of 137 West Longitude in EEZ and between 57 13 25 N and 56 40 12 N latitudes in ADFG Central Southeast Outside section.
- February 4: Shelikof District closed to directed pollock fishing.
- January 15: Closed directed trawling for sablefish in W/C GOA.
- January 1: Closed directed trawling for sablefish in Eastern Gulf.

NOTICE OF BYCATCH RATE STANDARDS FOR VESSEL INCENTIVE PROGRAM
TO REDUCE HALIBUT AND RED KING CRAB BYCATCH RATES
IN SPECIFIED GROUNDFISH TRAWL FISHERIES

New halibut and red king crab bycatch rate standards for specified fisheries included under the vessel incentive program will become effective July 1, 1991, according to Steven Pennoyer, Director, National Marine Fisheries Service, Alaska Region.

The incentive program holds operators of individual trawl vessels accountable for their bycatch rate of halibut during their participation in the Bering Sea/Aleutian Islands area (BSAI) Pacific cod fishery, BSAI yellowfin sole/rock sole/other flatfish fishery, Gulf of Alaska (GOA) Pacific cod fishery, and GOA rockfish fishery. Vessel operators are also accountable for their bycatch rate of red king crab while participating in the yellowfin sole/rock sole/other flatfish fishery in Zone 1 (511). At the end of each fishing month, NMFS uses observed data to compare the monthly bycatch rate of red king crab and halibut for each vessel that participated in these fisheries during that month, with the fixed bycatch rate standard specified for each of those fisheries. A bycatch rate for a fishing month that is above the applicable bycatch rate standard constitutes a violation of the regulations implementing the vessel incentive program.

The bycatch rate standards specified for the third and fourth quarters of 1991 are listed below.
