


### 2000 GOA TRAWL DW COMPLEX & SW COMPLEX FISHERIES




DW COMPLEX: Deep water complex consists of Sebastes and Sebastolobus rockfish, deep waterflatfish, rex sole, arrowtooth flounder and sablefish. SW COMPLEX: Shallow water complex consists of pollock, Pacific cod, shallow water flatfish, flathead sole, Atka mackerel, and "other species".

SW COMPLEX CLOSURE does not apply to fishing for pollock by vessels using pelagic trawl gear in those portions of the GOA open to directed fishing for pollock.

At its February 1998 meeting, the Council approved Amendments 52/52 which contained two measures to address management concerns for Western and Central Gulf of Alaska fisheries. The first measure was a 3-day stand down requirement for trawl catcher vessels transiting between the Bering Sea and Aleutian Islands Management Area and Gulf of Alaska (GOA). The second measure would have created an advance registration program for vessels participating in certain fisheries at risk of TAC overages such as the Western and Central GOA pollock fishery.

NMFS proceeded immediately to implement the 3-day stand down requirement by regulatory amendment as we determined that an FMP amendment was not required for this measure alone. However, development of fishery management plan amendments necessary to authorize the vessel registration program was put on hold in the fall of 1998 due to the passage of the American Fisheries Act (AFA). The final rule implementing the 3-day stand down requirement was published in the <u>Federal Register</u> on September 11, 1998 (63 FR 48642).

Given changing circumstances in the fisheries, we no longer believe a vessel registration program is necessary and we recommend that the Council consider withdrawing Amendments 52/52 from further development and consideration. The fisheries of greatest concern when Amendments 52/52 were adopted were the pollock and Pacific cod fisheries of the GOA. However, management of these fisheries has changed dramatically due to implementation of harvest sideboards on AFA catcher vessels and implementation of trip limits and seasonal exclusive area requirement under the Steller sea lion protection measures. These recent actions have all but eliminated the rapid shifts of effort that plagued management of these fisheries in the past, and that were the primary basis for implementing a vessel registration program.
