








The following chart is a historic overview of the total resource hours employed in D17 over the last three years. The actual year to date totals are displayed for 1997, with projected year end totals shown in green.





The following charts show the distribution of resource hours/days between foreign and domestic fisheries for the reporting period.







### US/RU CONVENTION LINE:

Foreign fishing activity in the Russian EEZ along the Convention Line decreased dramatically in mid October. This would correlate with information from RU indicating the close of their major fishing season. As of 30 November, 3 trawlers were working within 30nm of the Convention Line inside the Russian zone. For the reporting period, Coast Guard C130's have flown approximately 52 sorties totaling 404 hours and cutters have patrolled for 49 days monitoring the Convention Line. C130 patrols from Air Station Kodiak have flown both overt and covert patrols at staggered day/night hours. Coast Guard resources, while scaled back to meet the lower threat, will continue to monitor activity on the Convention Line as long as the foreign fishery remains active.

## HIGH SEAS DRIFTNET:

For the reporting period, Coast Guard C130's have flown approximately 13 sorties totaling 97 hours. While on patrol, these flights sighted approximately 160 vessels. No illegal activity was detected. Coast Guard intelligence and surface resources in transit will continue to monitor the HSDN threat area.




No foreign fishing vessel activity was detected in the area during the reporting period. Currently there are no vessels scheduled to conduct trial fishing in the area.

## DOMESTIC FISHERIES

#### GROUNDFISH:

For the reporting period, Coast Guard patrol efforts focused on monitoring Pollock "B", IFQ, and the Bristol Bay Red King Crab fishery. The following charts show the break down of enforcement effort by area for cutter days and aircraft hours during the reporting period.







#### OPERATION ARCTIC SAFEGUARD:

Operation Arctic Safeguard took place from 24 Oct - 10 Nov. It's mission was to provide a Coast Guard presence and SAR response to prevent loss of life in the Bering Sea during the State Bristol Bay Red King Crab fishery. High Endurance and Medium Endurance Cutters were on station in Bristol Bay, along with one HH60 from Air Station Kodiak pre-staged in Cold Bay supported by daily over flights of the area by Air Station Kodiak C130's. There was no loss of life during this fishery.

The following charts show the total D17 domestic fisheries enforcement effort in patrol days and aircraft hours for the reporting period and compares it to the same reporting period last year.





## IFQ ENFORCEMENT:

Coast Guard HH60's and C130's combined to provide over 498 flight hours (429 and 69 respectively) in the enforcement of IFQ. Patrol boats, Buoy Tenders and HEC/MEC's added 113 cutter days to the enforcement effort. The Coast Guard and NMFS continue to share sighting information and at sea boarding results that can be compared to landing information. Also, as a new program for 1997, the Coast Guard assisted NMFS in providing a dockside presence during offloads. In 1997 Coast Guard boarding teams have monitored 142 offloads in 11 ports.

## SEABIRD AVOIDANCE:

During the reporting period, Coast Guard cutters queried and boarded 5 Longline vessels on their use of Seabird Avoidance devices. No violations were issued. Results listed below.



#### Case Summaries:

- 09 September 1997, F/V RONNY, Stepovak Bay: Ran Aground. Vessel salvaged, no POB.
- 22 September 1997, F/V TROIKA, St Paul Island: Vessel taking on water from unk source, crew abandoned ship, Master entered water without immersion suit. Vessel lost, 3 crew safe 1 death.
- 24 September 1997, F/V VICTORIA ANN, Portage Bay: Vessel aground. Vessel lost, 1 crew safe.
- 27 September 1997, F/V TRINA, Perl Island: Vessel taking on water, sunk. 1 crew safe.
- 11 October 1997, F/V SEA GLIDER, Crew abandoned ship to life raft. Vessel lost, 4 crew safe.
- 13 October 1997, F/V ANNA T, PWS: Engine fire, burned and sank. Vessel lost, 3 crew safe.
- 29 October 1997, F/V MEMORIES, Wrangle Narrows: Vessel aground. Vessel lost, 3 crew safe.
- 11 November 1997, F/V ELIZABETH, Metlakatla: Full fish totes on deck, lost stability and capsized. Vessel lost, 4 crew safe.

## ADMINISTRATIVE NEWS:

## Additional CG vessels planned for AK:

The Coast Guard is planning to move two cutters to Alaska. The 213 foot CGC ACUSHNET will relocate to Ketchikan, and a former Navy vessel, the EDENTON, will be outfitted as a Coast Guard Cutter and assigned to Kodiak. The EDENTON is a 300 foot ex-Navy rescue and salvage ship. The ship will be fitted with a flight deck to support helicopter operations. These plans are being developed pending a final decision per the provisions of the National Environmental Policy Act.

## Kursoshima Update:

The 368-foot Kuroshima grounded on Second Priest Rock in Dutch Harbor at 4:28 p.m. on 26 November in heavy seas, with winds gusting from 50-90 kts. Two crew members were killed in the accident when the vessel was overswept by an estimated 35 foot high wave. 16 crewmembers were safely pulled ashore by crewmembers from the Coast Guard Cutter MIDGETT. The Kuroshima is a Panamanian flagged freighter used to carry frozen seafood. The ship was not carrying any cargo at the time of the incident.

## **Environmental Impact:**

- approximately 41,000 gallons of bunker C oil have spilled
- approximately 800 yards of ocean shoreline have been impacted by oil
- 80% of Summer Lake shoreline has been impacted
- about 124,000 gallons remain on board

## Wildlife Impact:

- approximately 10 oiled birds have been observed
- nine dead birds
- one oiled bird is being treated
- seals and sea otters continue to be spotted in the area, no oiling observed
- hazing measures are being used to keep wildlife out of the area

Coast Guard Captain of the Port Anchorage is on scene directing pollution and salvage response. Over 175 personnel are involved.

#### Combined US/RU Convention Line Patrol:

The Coast Guard Cutter STORIS and Russian Federal Boarder Service Vessel DUNAI conducted a combined patrol of the US/RU Convention Line November 13-15. No violations were detected during the operation. After the patrol the DUNAI made a portcall at the Coast Guard Base in Kodiak.

#### Fish Expo:

RADM Cross attended the Fish Expo in Seattle from 20-22 November.

The North Pacific Regional Fisheries Training Center (NPRFTC) conducted training at the Fish Expo in Seattle on changes to record keeping and reporting requirements for the 1998 fishing season. The training was well attended and well received.
