# I. IUU Fishing & High Seas Drift Net (HSDN) Enforcement

Operation North Pacific Guard (NPG) is an annual high seas U.S. fisheries law enforcement operation designed to detect and deter all types of illegal, unreported, and unregulated (IUU) fishing activity, including large-scale high seas pelagic drift-net (herein HSDN) fishing, in accordance with multilateral and bilateral international agreements to which the United States is party. Operation NPG advances U.S. goals for the conservation and management of high seas fisheries resources and is our at-sea enforcement contribution to a multilateral effort by North Pacific rim nations to eliminate IUU fishing activity from the North Pacific. This is in support of the Western and Central Pacific Fisheries Commission (WCPFC), North Pacific Fisheries Commission (NPAFC) regional fisheries management organizations (RFMOs).

CGC BERTHOLF began Operation NPG on the high seas on 01 September. Thus far, CGC BERTHOLF conducted 18 international fisheries boardings, resulting in 30 potential violations that will be forwarded to the vessels' flag state and the representative RFMO for disposition. The Coast Guard will provide more in-depth findings and discussion during the February 2022 Council Meeting.

# II. U.S./Russian Maritime Boundary Line (MBL) Enforcement

Overall the Coast Guard detected an average of 8-9 vessel per day within 20 nautical miles of the MBL. There have been no detected incursions by FF/Vs into the U.S. EEZ this season.

# III. U.S./Canadian EEZ Boundary (Dixon Entrance) Enforcement


Light fishing activity occurred during the reporting period along the U.S.-Canadian EEZ boundary in the vicinity of Dixon Entrance. All Canadian fishing vessels sighted were south of the A-B line, and the Coast Guard detected no incursions into U.S. waters.

# **IV. Marine Protected Resources and Critical Habitat Enforcement**

The Coast Guard monitors more than 151 critical habitat areas around Alaska each month as part of routine cutter and aircraft patrol activity. During the reporting period, Air Stations Kodiak and Sitka completed 9 marine mammal survey flights with embarked NOAA agents. Additional Survey flights are scheduled for October.

# V. Commercial Fishing Vessel Boarding Statistics

The U.S. Coast Guard conducted 354 federal fisheries boardings during the reporting period. These boardings resulted in a total of 12 fisheries violations onboard 9 vessels. Figures 1 and 2 show the historic trends for boardings and violations. Appendix B lists the Federal Fisheries boardings with fisheries or safety violations that occurred during the reporting period.




#### **Figure 1. Fisheries Boardings By Year**

Coast Guard patrols completed 320 boardings on commercial, charter, and recreational vessels targeting halibut and sablefish during the reporting period. 37 boardings were of IFQ halibut or IFQ sablefish vessels, detecting 10 fisheries violations on 7 commercial fishing vessels. 83 boardings were of Charter halibut vessels, detecting zero violations. 200 boardings were of recreational halibut vessels, detecting 2 fisheries violations on 2 vessels.

#### **VII. Forward Operating Locations**

Air Station Kodiak also deployed two MH-60s to Kotzebue on 01 July to support SAR coverage, community engagement, and Protected Living Marine Resources activities.


Air Station Kodiak deployed an MH-60 to Cordova on 01 May to support the increase in fishing vessel activity in the Gulf of Alaska. There is a helicopter crew staged there from 01 May through 30 September each year to increase SAR coverage and support Law Enforcement and Protected Living Marine Resources.

#### VIII. Commercial Fishing Vessel Safety/Search and Rescue Cases

During the reporting period, the Coast Guard detected 43 safety violations on 17 State and Federal fishing vessels. 23 of these safety violations occurred on 11 Federal fishing vessels. A list of violations can be found in Appendix B.

The Coast Guard conducted 4 search and rescue (SAR) cases involving fishing vessels in U.S. waters, resulting in 7 lives saved, 3 lives lost, and 6 vessels lost during the reporting period. Appendix A provides a comprehensive list of SAR cases involving fishing vessels over the reporting period.


### Figure 3. Historical Overview of CFVS Statistics



### Safety Statistics by Year


#### **IX.** Coast Guard Resource Summary

# Figure 6. Annual H60/65 Hours





Figure 8. Jun-Sep Major Cutter Days






