Addendum #2 to C8

Description of Halibut CDQ Seasons Based on Landings from Vessels ≤46 Feet Length Overall October 2014

The Environmental Assessment/ Regulatory Impact Review on the Pacific Cod CDQ Fishery Development describes an option (Option 3) to the Preliminary Preferred Alternative (Alternative 4), that would allow for a small vessel hook-and-line Pacific cod directed fishery outside of the IPHC halibut CDQ season. When the halibut season is not open, the participants of a directed Pacific cod CDQ fishery would be required to discard all halibut catch and a Prohibited Species catch rate would be debited from that CDQ group's Prohibited Species Quota. The analysis discusses the details of the catch accounting process that could ensue should a Pacific cod CDQ fishery occur outside of the IPHC established halibut season established for IFQ/CDQ, which generally ranges from mid-March to mid-November (as see in Table 1).


Since the release of the analysis, representatives from the CDQ groups have conveyed concern about the difference between the IPHC-established halibut season and the halibut CDQ season internally-established by each CDQ group's management. These internally-established seasons are often a truncated version of the IPHC season. This truncation can depend on many factors, for example, weather and ocean conditions, processing availability, and efforts made to plan around the opening of other fisheries. This addendum contains descriptive information on the length of these seasons based on actual landings data from vessels less than or equal to 46 ft LOA.
