Principles Suggested Upon Which to Base the Allocations of Surpluses Among Nations

- 1. It was the view of the Subcommittee that there was no basis for allocating surpluses except according to historical proportion of catch. Such allocations, of course, should be modified by other considerations as indicated in the Law.
- 2. In the case of blackcod, we believe account must be made of present increases in fishing effort by some nations, increases that were discouraged by our officials.
- 3. No allocations made to third parties on these species now overfished.
- 4. Allocations of surpluses to nations should be based on the separate stocks and not by species.
