Subject: Status of the Gulf of Alaska Groundfish Fishery Management

Plan (FMP) -- (A INFORMATION MEMORANDUM)

BACKGROUND

On June 6, 1978, the comment period for the proposed regulations on Gulf of Alaska Groundfish PMP ended. We are now in the process of preparing the necessary comments for your final decision on implementation of the plan. The following information may be useful in your upcoming trip to Alaska.

This plan, which the North Pacific Council had originally anticipated being implemented January 1, 1978, has been delayed for a variety of reasons including negotiation with the Council for last minute changes early this year and further consideration of certain outstanding issues associated with the plan.

We are now preparing an Action Memorandum to you that discusses in detail the decisions which have been made concerning these issues. The memorandum will conclude that we should implement the plan immediately. The Office of General Counsel has not officially cleared the strategy outlined in this memorandum.

REPRESENTATION

There are three options for implementation of this FMP:

- Implementation from September 1, 1979, until January 1, 1979. The FMP cannot be implemented earlier because of the 30-day "cooling-off" period required by the APA after publication of final regulations.
- 2. Implementation on January 1, 1979, for one year.
- Implementation on September 1, 1978, for a period of 3. one year.

The first option could lead to disruption of foreign fishing because of the necessity of forcing subarea allocations into an existing system of TALFF's. The second option has the advantage of minimal disruption of the foreign fishery. However, it further postpones implementation of management measures sought by the Council.

The third option appears the most reasonable under the circumstances. This option involves establishing a new fishing year from September 1, 1978, to August 31, 1979. New allocations (valid until August 31, 1979) would be given to foreign nations. These foreign vessels with valid permits would then be allowed to fish under the new allocations. Permits would be renewed effective January 1979 for nine months, and annually thereafter.

Informal staff opinion is that a one-year implementation is legally allowable (assuming provision is made for annual review of OY and MSY) and is less disruptive to foreigners and administratively easiest to accomplish.

The FMP, which the Council has voted to extend to November 1979, establishes levels of OY and TALFF for 1978. The Council has indicated that the FMP is valid for 1979,

Establishing new TALFF's for September 1, 1978 to August 31, 1979, will involve new allocations (both by country and subarea) that will have to be determined by the Department of State (DOS) (with our assistance) during the 30-day ''cooling off''period.

In order to avoid disagreement with DOS about allocations already made for 1978 under the PMP, care must be taken to assure that each national allocation is at least equal to that portion of the 1978 PMP allocation which that nation could reasonably have harvested during the remainder of 1978.

Tentative discussions with F4 and Council staff have produced favorable comments on this proposed option. There are remaining questions, however, including how (or whether) to consider the 1978 foreign harvest (to date) in making new allocations (see attached memo from Harry Rietze), and how to apportion allocations of various species to enable foreign nations to conduct their traditional directed fisheries, and when to close a subarea to directed fishing by domestic and foreign fleets.

FUTURE ACTIONS

The major items that will be undertaken next are:

⁻⁻Preparation of an Action Memorandum for your formal decision --Preparing responses to voluminous comments received on the proposed regulations.

- -- Rewriting regulations in response to public comment.
- --Preparing information memorandum to the Administrator and the Secretary, and
- --Preparing letter to the Council explaining the actions taken.

We anticipate that the above can be completed so that final regulations can be published by August 1, 1978. There would be then a thirty day cooling off period, and the regulations would become effective on September 1, 1978.

Implementation

On July 20, 1978, the subject meeting was held at 9:30 in Dr. Roland Smith's office. In attendance were:

After introductions by Dr. Smith, Mr. Bribitzer reviewed the history of the plan since January, and discussed the status of unsolved issues (see attached outline). The schedule, with rationale for implementation was discussed.

Agreements were reached to do the following:

- (1) Jim Branson will explain to the North Pacific Council the schedule leading to November 1 implementation and will ask the Council to consider an amendment that extends OY's TALFF's and U.S. capacity estimates through 1979.
- (2) If the Counsil considers and approves such an amendment, NMFS will process and review the amendment so that, if approved, it will be published in the <u>Federal Register</u> August 1. This means NMFS action and transmittal to the <u>Federal Register</u> on July 28.
- 3) The final regulations for the plan, except for the OY's and TALFF's will be published to be effective November 1, as soon as the enforcement agreement is signed.
- (4) GCF will immediately work on the delegation of authority issue, the regulations on mid-season adjustments to OY and the enforcement agreement. All these items are interlocked with the decision to delegate certain authorities to the Regional Director.
