On April 30, 1980 our office was informed that Soviet supporting vessels SANGAR, permit NO. UR-80-0616-B, SOKOLOVKA, permit NO. UR-80-0135-B, SURAZH, permit NO. UR-80-0029-B, STAROBELSKY, permit NO. UR-80-0719-B, SREDNEURALSKY, permit NO. UR-80-0718-B, SVETLODOLINSK, permit NO.UR-80-0629-had ceased JOINT Fishery with american vessels and left for the homeport for repair.

In order to avoid lack of processing, freezing and holding capacity Marine Resources Company and the fishermen associated with the Bering Sea/Gulf of Alaska joint venture ask to substitute these vessels for two Soviet processing vessels;

the NOVAYA ERA, permit NO. UR-80-0065-A, the MYS PROKOFYEVA, permit NO. UR-80-0186-A.

Taking this into consideration I submit herewith request for this substitution. It seems to be important to expedite permits approval for the abovementioned vessels so that to provide american fishermen with timely sufficient processing capacity on the fishing grounds.
