#### Dear Harold:

The National Marine Fisheries Service (NMFS) has finalized amendments to the preliminary management plans (PMP's) for 1978. The final Supplemental Environmental Impact Statements, the amended PMP's and implementing regulations have been published in the Federal Register and are now in final 15 day "cooling off period". As a contingency, we have amended the PMP for the Gulf of Alaska trawl fishery so that an updated PMP will be available in case implementation of the Council's management plan is delayed. Attached is a table which compares the 1977 and 1978 OY's, U.S. capacities, TALFF's and reserves.

In addition to the changes reflected in the attached table we have made other changes as follows:

# Trawl and Herring Gillnet Fishery of the Bering Sea and Aleutian Islands

Reserves of 600 metric tons of sablefish in the Bering Sea and 1,500 metric tons of Pacific cod in the Bering Sea/Aleutian Islands have been established. Foreign fishing for herring is prohibited east of 168°W longitude.

## Trawl Fishery of the Gulf of Alaska

Reserves equivalent to 20 percent of OY of each species except Atka mackeral have been established.

# Sablefish of the Bering Sea and Northeastern Pacific Ocean

A reserve equivalent to 20 percent of the OY of sablefish in the Gulf of Alaska has been established. There is no TALFF for sablefish off southeastern Alaska (south of Cape Spencer). The prohibition against fishing longline gear shallower than 500 meters has been retained throughout the Gulf of Alaska. As mentioned above, a reserve of 600 metric tons of sablefish in the Bering Sea has been established.

NMFS will continually monitor U.S. fisheries, periodically re-evaluate U.S. processing and catching capacities, and as appropriate make changes in U.S. capacities, distribution of reserves and increases in TALFF's. Notices of the incremental apportionments of the reserve between U.S. capacities and TALLF's will be published in the Federal Register within 7 days after the end of March, June, August, and October. Those publications will provide the mechanism for the Secretary of State to allocate to foreign nations those portions of U.S. capacities and reserves surplus to U.S. needs. We will coordinate our actions in this matter with the Council.

There were no changes made to the PMP's for the shrimp of the Eastern Bering Sea and Gulf of Alaska and snails of the Eastern Bering Sea. The final decision on the king and tanner crab PMP is pending and probably will not be made until after the December Council meeting.
