SUBJECT: Small Boat Fishermen Workshop

NMFS will be holding a series of three workshops to discuss commercial "small-boat" fishermen in the U.S. Each of the Workshops will bring together a small group of professionals with experience in dealing with ma-ters associated with small-boat or otherwise small-scale fishing enterprises. The principal aim of these workshops is to produce a better understanding of the activities of small boat or small-scale fishermen in the commercial fishing sector. This understanding in turn will contribute to a determination of whether small-scale fishing enterprises warrant special focus from the viewpoint of federal policy.

The first workshop will be held on October 16 and 17, 1978, at the Woods Hole Oceanographic Institute, Woods Hole, Massachusetts, where the discussions will center on the Atlantic and Gulf fisheries. This workshop will be followed by one to be held on November 13 and 14 at the NMFS facility in Tiburon, California, covering small-scale fishermen of the West Coast and Alaska. A third workshop, on Island Fisheries, will be held in December (site undetermined).

We felt it was necessary to restrict these workshops to a relatively small number of participants in order to assure productive discussions. Consequently, we are trying to hold the number down to around 20 participants. The roster and agenda for the Woods Hole workshop are enclosed. The other rosters have not been completed. We recognize that the rosters may not inlude all those who are knowledgeable or experienced in this area.





However, we feel that the costs, in terms of workshop effectiveness and dollars, outweigh any benefits that may derive from enlarged participation.

We intend to write a report on each of the workshops and in this way communicate the findings to all interested persons. In the meanwhile, we would welcome your comments.
