### BACKGROUND

## Current Council Contracts

79-4: "Analysis of Southeastern Alaska Troll Fisheries Data" (ADF&G, \$54,604)

Latest progress report dated October 28, 1980 was sent to SSC on November 24, 1980. A draft final report is due on January 1, 1981.

80-3: "Feeding Habits of the Walrus of Bristol Bay" (IMS at UA, \$87,220)

The SSC reviewed the quarterly report through September, 1980 at the December meeting. Third quarterly report is due in January, 1981.
