REPORT TO THE NORTH PACIFIC FISHERIES MANAGEMENT COUNCIL  
CONCERNING COAST GUARD FCMA ENFORCEMENT

1. Recent FCMA Infractions. Since the last Council meeting, one report of violation (civil penalty procedure) and twelve citations (written warnings) have been issued. A brief summary of each infraction is as follows:

- a. 30 June - The Japanese crab vessel EIKYU MARU was issued a citation by USCGC MELLON for failure to display IRCS on weather deck.
- b. 6 July - The Japanese trawler TAKACHIHO MARU was issued a citation by USCGC MUNRO for failure to log catch to nearest tenth of a metric ton.
- c. 9 July - The Japanese trawler SHOSHIN MARU NO. 18 was issued a citation by USCGC JARVIS for failure to display proper day shape for trawling and for failure to properly maintain cumulative catch log.
- d. 10 July - The Japanese trawler RYOAN MARU NO. 28 was issued a citation by USCGC MELLON for failure to provide a safe boarding ladder.
- e. 10 July - The Japanese trawler SYUNYO MARU was issued a citation by USCGC JARVIS for failure to provide a safe boarding ladder.
- f. 10 July - The Japanese trawler HOKUTO MARU NO. 5 was issued a report of violation by USCGC JARVIS for failure to return prohibited species to the sea in a timely manner and for failure to provide a safe boarding ladder.
- g. 12 July - The Japanese trawler ANYO MARU NO. 11 was issued a citation by USCGC RESOLUTE for failure to provide a safe boarding ladder.
- h. 13 July - The Japanese trawler YASHIO MARU NO. 11 was issued a citation by USCGC MELLON for failure to log all species by common name and code number.
- i. 15 July - The Japanese trawler ANYO MARU NO. 15 was issued a citation by USCGC MELLON for failure to keep totals as to disposition of each species in cumulative catch log.

- j. 16 July - The Japanese trawler EIBSU MARU NO. 38 was issued a citation by USCGC MELLON for failure to properly maintain cumulative catch log.
- k. 19 July - The Japanese trawler MANRYO MARU NO. 31 was issued a citation by USCGC MELLON for failure to properly maintain cumulative catch log.
- l. 19 July - The Japanese trawler RIKUZEN MARU was issued a citation by USCGC MUNRO for failure to properly maintain cumulative catch log.
- m. 20 July - The Japanese trawler DAITO MARU NO. 55 was issued a citation by USCGC MUNRO for commencing fishing four hours prior to time indicated on check in message.
