SUBJECT: Recusal Determinations for the February 2025 Council Meeting

NOAA General Counsel, Alaska Section has reviewed the North Pacific Fishery Management Council's February 2025 agenda for recusal issues.

Under 50 C.F.R. § 600.225(b)(9)(ii), none of the agenda items for the February 2025 meeting constitutes a "particular matter primarily of individual concern," and none of the Council members is recused from participating on any agenda item under that regulation.

Under 50 C.F.R. § 600.235, none of the following agenda items constitutes a "Council decision" as that term is defined at 50 C.F.R. § 600.235(a); therefore, a recusal determination is not required for any of them:

- C1 Cook Inlet Salmon Review SAFE report, recommend OFLs/ABCs/TACs; and
- C2: Chum Salmon Bycatch Initial Review.

According to the regulations at 50 C.F.R. § 600.235(g), any Council member may file a written request to NOAA General Counsel for a review of this determination.
