I. IUU Fishing & High Seas Drift Net (HSDN) Enforcement

The Coast Guard deployed surface and aircraft assets for Operation North Pacific Guard (NPG) 2024. Both assets support high seas fisheries enforcement under North Pacific Anadromous Fisheries Commission (NPAFC), North Pacific Fisheries Commission (NPFC), and Western and Central Pacific Fisheries Commission (WCPFC) authorities. There were no detected HSDN fishing activities during this period.

II. U.S./Russian Maritime Boundary Line (MBL) Enforcement

During the last three months, there was consistent foreign flagged longline and trawl fishing on the Russian side of the MBL. Coast Guard District 17 continues to prioritize remote sensing and surface and air patrols along the MBL to deter and detect incursions.

III. U.S./Canadian EEZ Boundary (Dixon Entrance) Enforcement

There was light fishing activity during the reporting period along the U.S.-Canadian EEZ boundary in the vicinity of Dixon Entrance. All Canadian commercial fishing vessels sighted were south of the A-B line and no incursions into U.S. waters were detected.

IV. Cook Inlet EEZ Federal Salmon Enforcement

The Coast Guard conducted coordinated surface and air patrols with NOAA OLE in the first opener of the Cook Inlet EEZ Salmon Fishery. The Coast Guard completed 17 at-sea boardings and 05 hours of C-130 patrol. Notably, the aircrew observed one instance of a firearm being pointed in the direction of a deployed net and vectored a cutter with embarked NOAA OLE agents to the vessel for investigation.

V. Marine Protected Resources and Critical Habitat Enforcement

The Coast Guard monitors 151 critical habitat areas around Alaska each month as part of routine cutter and aircraft patrol activity. D17 received no assistance requests within these areas in the reporting period.

VI. Commercial Fishing Vessel Boarding Statistics

There were 87 boardings conducted on commercial fishing vessels by the Coast Guard during the reporting period. These boardings resulted in a total of 17 fisheries violations onboard nine vessels. Appendices B and C list the boardings with violations that occurred during the reporting period.

VII. Halibut and Sablefish Enforcement

Coast Guard patrols completed 414 boardings on commercial, charter, and recreational vessels targeting halibut and sablefish during the reporting period. Of these boardings, 42 were commercial IFQ halibut or sablefish vessels resulting in seven fisheries violations on three vessels. Charter halibut vessels constituted 100 boardings resulting in zero fisheries violations. Recreational vessels targeting halibut constituted 272 boardings resulting in zero fisheries violations.

VIII. Crab Fisheries

Coast Guard units are preparing to conduct shore-side stability and safety inspections on the Bering Sea crab fleet in October. Coast Guard units conducted one boarding of Bering Sea commercial crabbers in the report period.

IX. Commercial Fishing Vessel Safety/Search and Rescue Cases

There were 25 search and rescue (SAR) case involving commercial fishing vessels in U.S. waters during the reporting period. Appendix A provides a comprehensive list of SAR cases involving fishing vessels over the reporting period.

During the reporting period, 71 safety violations were detected on 47 vessels including commercial, recreational, and charter vessels. A comprehensive list of safety violations can be found in Appendix B.




Figure 1. Historical Overview of CFVS/SAR Statistics

Figure 2. Annual HC-130 Hours





Figure 3. Annual Major Cutter Days

Figure 4. Annual H60/65 Hours to date




Figure 5. Annual Patrol Boat Hours to date






Figure 6. June - August Major Cutter Days

Date	Vessel Name	Case Details
6/2/24	FV LYDIA MARIE	FV IDA MARIE was disabled and dragging anchor. The Coast Guard launched a small boat and moored the vessel safely to a pier.
6/5/24	FV VIS	FV VIS reported a collision with an unguided charter vessel and the unguided charter vessel sank. The Coast Guard launched a helicopter and FRC, coordinated with multiple other governmental agencies. One person was transferred to EMS and a second was located deceased inside the submerged vessel.
6/7/24	FV NUKA POINT	FV NUKA POINT reported a crewmember in medical distress. The Coast Guard launched a small boat and transferred the patient to medical services.
6/13/24	FV TAYLOR BAY	FV TAYLOR BAY reported a person in the water, clinging to the vessel. The Coast Guard launched a helicopter and issued a UMIB. A good Samaritan diverted and successfully assisted FV TAYLOR BAY prior to USCG helicopter arrival.
6/18/24	FV LYDIA MARIE	FV LYDIA MARIE reported being hard aground and that 05 POB were abandoning ship. The CG issued a UMIB, launched a helicopter and small boat. A good Samaritan safely recovered all persons before USCG assets arrived.
6/18/24	FV MISS COURTNEY KIM	FV MISS COURTNEY KIM was reported to have experienced a fire and sunk. All 07 POB were rescued by a good Samaritan prior to CG notification.
6/25/24	FV PAMEA RAE	FV PAMEA RAE was reported to have capsized. A good Samaritan rescued all 05 POB and transferred them to emergency services for treatment.
6/26/24	FV CANDI LYNN	FV CANDI LYNN reported being disabled and adrift with 02 POB. The CG launched a small boat and towed the vessel to safe harbor.
7/4/24	FV AMERICAN DYNASTY	FV AMERICAN DYNASTY reported a crewmember experienced an injury. The USCG facilitated medical advice, determined that MEDEVAC was not warranted and monitored until the crewmember reached higher level of care.
7/5/24	FV MONA LEE	FV MONA LEE requested USCG assistance as they were taking on water. The CG issued a UMIB, launched a small boat and helicopter. The CG small boat rescued the 02 POB from a skiff.
7/22/24	FV VICKI RAE	FV VICKI RAE master reported the vessel capsized and sank. A good Samaritan recovered all 05 POB prior to USCG notification.
7/28/24	FV WAR MASTER	FV WAR MASTER was reported to have a person overboard. The CG launched an HC-130, two MH 60s, a cutter, and coordinated an extensive search with the Alaska State Troopers. The person overboard was not found.
7/26/24	FV EXODOUS	FV EXODOUS reported an injured crewmember onboard. The CG launched two small boats and transferred the person to waiting EMS for further treatment.
7/26/24	Jack Bay	A FV in Jack Bay reported a crewmember onboard was experiencing a medical emergency. An underway small boat heard the radio transmission, self-diverted, and delivered the patient to waiting EMS.
7/26/24	FV VIKING VENTURE	FV VIKING VENTURE reported a crewmember was experiencing a medical emergency. The CG launched a small boat and transferred the patient to waiting EMS.

8/8/24	FV SUBZERO	FV SUBZERO was reported on fire. The CG launched an HC-130 and MH-60. Multiple good Samaritans responded and rescued the 02 POB.
8/8/24	FV THE ALASKAN	FV THE ALASKAN was reported to have capsized with all 05 POB being recovered by good Samaritans prior to USCG notification.
8/9/24	FV BAVARIA	FV BAVARIA reported that they were taking on water with 03 POB, the vessel lost power due to water ingress. The CG launched an MH-60 which delivered two dewatering pumps. The dewatering pumps allowed the vessel to regain power and propulsion and it safely moored.
8/12/24	FV FAITHFUL	FV FAITHFUL reported that a crewmember had fallen overboard. The CG issued a UMIB, launched two cutters and an MH-60. The person was not found.
8/14/24	FV PIG PEN	FV PIG PEN reported a fouled jet drive to a passing USCG cutter. The cutter launched its small boat and towed FV PIG PEN to a partner fishing vessel for further return to port.
8/21/24	FV LISA JEAN	FV LISA JEAN reported that the master fell into rotating equipment while underway. The CG issued a UMIB and launched an MH-60. Good Samaritans responded, recovered the deckhand, and assisted the CG rescue swimmer. The master was determined to be deceased and the case passed to Alaska State Troopers for further investigation.
8/29/24	FV ALASKA SPIRIT	FV ALASKA SPIRIT reported that a crewmember experienced an injury. The CG launched a helicopter, which experienced an engineering issue and safely landed. FV ALASKA SPIRIT transited to port and transferred the patient to EMS.
