

#### Roles & Responsibilities in Plan Team Meetings

- <u>eAgenda</u> for all documents and presentations (REFRESH!)
- Conduct- be considerate, respectful, and collaborative
  - Standards of conduct in <u>PT handbook</u> (p6-7)
  - Communicate openly: Discussions about agenda items should be public
- Google drive (September 2025 Plan Team Meeting) for draft PT report, assignments, roles of rapporteur and facilitator, detailed report writing guidelines
- Reminder to public that testimony should focus on scientific evaluation of the issue or analysis, rather than advocating for a particular policy outcome (per PT handbook, same as SSC).

#### Guidelines for Plan Team Report, Writing Deadlines

- Link in Google drive: <u>Guidance on Writing the Plan Team Report</u>
- Generally, short summary of PT discussion.
  - If informational and no recommendations, SHORT (1-2 sentence) summary and link to ppt (in topic header)
  - If extensive PT discussion and/or recommendations, characterize discussion and bold any consensus recommendations
  - Insert sections to google doc after conferring with reviewer/helper and/or author as needed
  - Be clear about models recommended for management
    - How many models were presented/considered, which expected in November?
- Deadlines for compiling Plan Team Report- drafted by COB Friday, will be editing through Tuesday AM, posting for SSC by COB Tuesday
- Authors: Deadline for revised documents COB Tuesday.
