Beginning in 2026, the Groundfish Plan Teams and Council bodies will use new terminology for groundfish harvest specifications. The purpose of this endeavor is to make the following distinction: the ABC (ACL) is specified at the stock or stock complex level, and the overall TAC for a stock or stock complex cannot be set above ABC. ABC is tied to MSA requirements and accountability measures (AMs). Spatial apportionments are based on survey data, fishery data, or a combination of the two data types, and are meant to inform distribution of the TAC across areas. These spatial apportionments will be referred to as Biologically-informed Recommended Distributions (BRD).

OFL = Overfishing Limit

ABC = Acceptable Biological Catch

BRD = Biologically-informed Recommended Distribution

TAC = Total Allowable Catch
