# Stock & Assessment Overview

- 20 non-target rockfish (Sebastes spp.)
- Managed in 3 Tiers
  - Tier 4, 5, and 6
- Update assessment
  - No new data
  - Tier 6: removal of DSR species
- Northern rockfish excluded from Other Rockfish ABC and OFL calculations in the assessment, but EGOA ABC from the Northern assessment is transferred to Other Rockfish EGOA ABC during the November PT deliberations

# PT/SSC Comments- Specific to Assessment

"The Council is considering a motion to change the spatial management of demersal shelf rockfish (DSR), by moving DSR species out of the other rockfish category to a GOA-wide assessment. The SSC supports making this change to the DSR complex in the 2024 stock assessment for implementation for the 2025 fisheries and looks forward to examining the area apportionment at that time." (SSC, October 2023)



This is an **update** assessment to reflect the species membership change in the stock complex (i.e., removal of DSR species from Other Rockfish)


Total GOA catch is ~ 13% of OFL (~30% of TAC)

2024 catch is down ~ 54% from 2023 (1,079 t)




# Catch

- Incidentally-caught
- 89% trawl fisheries
- Highest in Central GOA by the rockfish trawl fishery
- Discards ~ 50%




## Catch

- 95% of total GOA Other Rockfish catch = 5 species
- Variable annual catch → patchy distributions
- Unidentified rockfish grouped with 'minors' & monitored
