OPERATIONS – CANADIAN BORDER A/B LINE


- Participants: OLE, AWT
- June, SE Alaska
 - Including Canadian Maritime Boundary
- Multiple Patrols: 20 Fishing Vessels boarded
- 10 Violations detected included:
 - Fishing without permit in controlled area, Recordkeeping & Reporting, Improperly Marked/Illegal Gear/Too many lines, Improperly licensed
 - SAR/Recovery of person overboard





OPERATIONS - COOK INLET

- Participants OLE, AWT, USCG
- Cook Inlet
- June 20-Aug 15th: 42 Fishing Vessels boarded on 15 openers
- 42 boardings conducted, 46 Federal Violations detected
 - Primarily R&R
 - 5 each no SFFP and no VMS
 - 1 fishing in Fed and State waters in the same day
 - 1 fishing Fed waters on a closed day
 - 10 Chinook retained not reported until after discovery
- Outreach/Education Meetings:
 - 3 outreach meetings conducted with industry and public. Partner presenters were SF and RAM





CASE UPDATES

- F/V Vanguard Owner Vanguard Fisheries, LLC and Operator Per Hesberg were charged jointly and severally under the Magnt Stervens Act with fishing with, and having on board, nopelagic trawl gear in Federal reporting areas open only to pelagic trawl gear; not complying with vessel monitoring system (VMS) requirements; and inaccurate reporting.
- F/V Dark Knight- Owner, Operator, and Permit Holder Dionisy Basargin was charged under the Magnusostevens Act with failing to comply with VMS requirements and under the Northern Pacific Halibut Act with violating IPHC Area 4 clearance requirements.
- F/V America's FinestOwner America's Finest Fishing, LLC, was charged under the MagnusorStevens Act with directed fishing for groundfish with trawl gear in the Nearshore Bristol Bay Trawl Area when that area was closed to trawling.
- C/P Arica— As previously reported, Assistant Cook Jordan St. Martinges was charged under the Magnuso Stevens Act with harassing and sexually harassing two female observers on board a vessel.



OUTREACH AND EDUCATION


Since March 2024, OLE:

INCIDENTS BY LAW/REGULATIONS/PROGRAM




In FY24, NOAA officers and agents opened 1599 incidents.
