 - Other




Industry Questions


- Can change with each season

Current Conditions & Challenges

- Snow Crab:
 - Closed 22/23
 - Closed 23/24
 - Open 24/25 (4.63 mil lb TAC)
 - 21 / 25 vessels completed survey
- Bristol Bay Red King Crab:
 - Closed 21/22
 - Closed 23/23
 - Open 23/24 Smallest TAC on record
 - 2,150,000 lbs
 - 13 / 31 vessels completed survey
 - Open 24/25 Small TAC
 - 2,310,000 lbs
 - 27 / 34 vessels completed survey
- Tanner Crab
 - Two districts
 - Inconsistent seasons
- GKC
 - East/West
 - Long season

Snow Crab 2024/2025


25 individual vessels fished snow crab. 2 additional vessels delivered snow crab during a Bairdi trip (ADFG data shows 27 individual vessels). 21 skippers participated in this survey. One additional skipper has not fished snow crab in over a decade so he did not qualify to complete the survey. These are the vessels that participated:





- Surveyed


BBRKC 2024/2025
