## Membership

Attached is the updated Council committee list reflecting changes since April 2021. In the April 2021 newsletter, the Council issued a call for nominations for a vacancy for a pollock trawl CP representative on the Council's **Fishery Monitoring Advisory Committee (FMAC)**. The Council Chair has appointed Paul Wilkins to that committee. The Council also issued a call for nominations for the reconstituted **Community Engagement Committee (CEC)**, for which the Chair will announce appointments during this meeting.

The Chair of the Council's **Partial Coverage Fishery Monitoring Advisory Committee** (PCFMAC) has advised that there is an opening for a partial coverage observer representative on the PCFMAC. The PCFMAC provides the Council with stakeholder advice and recommendations related to the partial observer program and electronic monitoring. The **Trawl EM Committee** chair has also advised of a resignation on that committee, and interest in soliciting for a vacancy for an additional EM service provider.

## Ecosystem Committee report

The Ecosystem Committee met on 20 April, 2021 and 27 May, 2021, via AdobeConnect, to receive updates on EFH, discuss the Council's motion on other effective areas-based conservation measures, discuss the Bering Sea Fishery Ecosystem Plan Team and the Climate Change Task Force reports (reported separately under agenda item D3), receive an update from the State of the Ecosystem workshop planning team, and to prioritize proposed ecosystem committee agenda topics and agenda schedules. The two Committee reports are posted.

## Planning for October 2021 meeting

A separate attachment discussing considerations for the October 2021 meeting is posted to the eAgenda for your review. As previously reported, we have been planning for returning to in-person Council meetings, and have been evaluating all the factors that form part of that decision, including opportunities for remote participation (for example, testimony), and potential accommodations for COVID protocols. We are looking for discussion and feedback to inform our planning. Dates of the October meeting will vary depend on whether each meeting is held in person.

#### **Public Comment**

The Council has received several written public comments, including a number of letters from stakeholders associated with the Eastern Aleutian Islands golden king crab (EAG) fishery. The letters ask for the removal of the EAG facility use cap in order to provide a live crab market opportunity for independent processing quota holders through custom processing arrangement as well as for more crab harvesters. Council staff will be including some background context on the history of the facility use cap as a supplement to this staff tasking action memo.
