D-2 Local Knowledge, Traditional Knowledge, and Subsistence Taskforce report

April 10, 2023

The Council supports and commends the work of the Local Knowledge, Traditional Knowledge, and Subsistence (LKTKS) Taskforce. The Council approves releasing the draft LKTKS Protocol and associated on-ramp recommendations from the LKTKS Taskforce for a 50-day public review period.

The Council approves an additional LKTKS Taskforce meeting to review Council analytical staff input, the SSC and Council's April input, and the public comments received from the 50-day review period, and to recommend any modifications for final review by the Council. At final review, the Council also requests information about additional capacity and resources that may be needed for successful implementation of specific onramps.

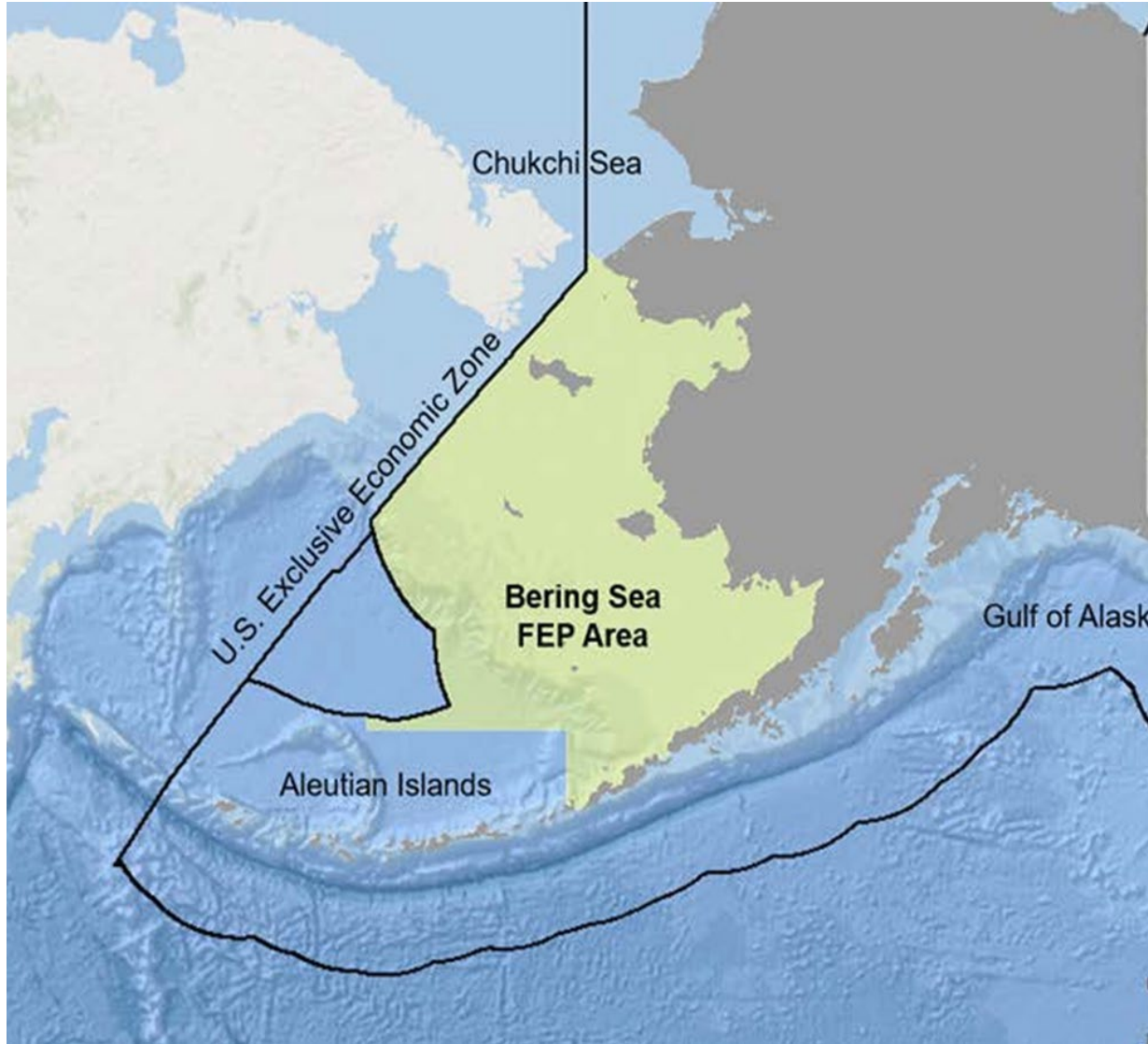

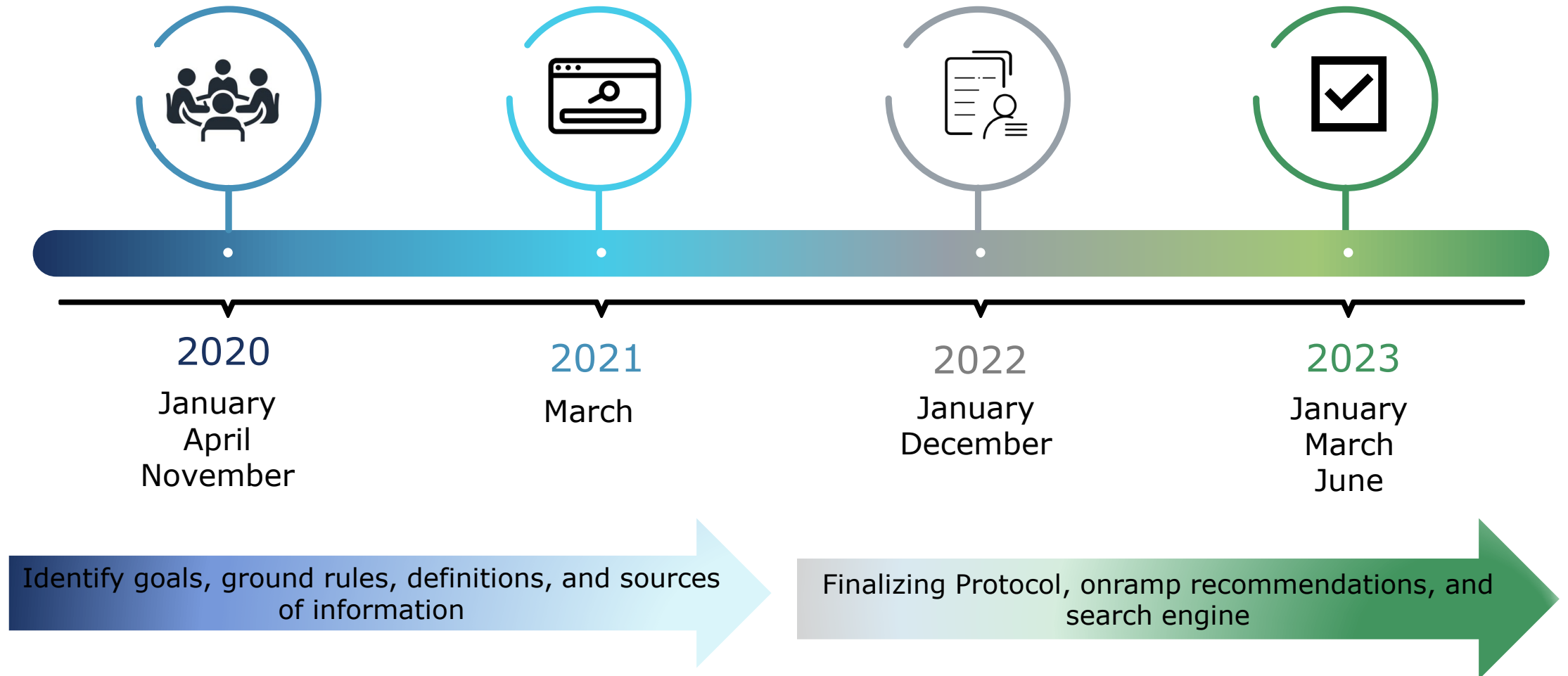

3. Overview of materials and recent edits in response to Council requests



Local Knowledge (pg. 7)

Reminder – no changes to definition

General background:

- ❖ Develops from the observations and experiences of people living, working, harvesting, and processing in specific places
- ❖ Knowledge systems evolves over time

Identifying knowledge holders:

- ❖ May or may not be Indigenous Peoples
- ❖ Includes people residing in communities, commercial fishermen, subsistence gatherers and more
- ❖ One does not necessarily need years of experience to hold LK



Traditional Knowledge (pg. 8)

Reminder – no changes to definition

- ❖ Dynamic knowledge system that can grow, change, or be lost over time and held by Indigenous Peoples
- ❖ Discussed, shared, and practiced throughout communities across generations
- ❖ Should be engaged with and understood as a process not as static information
 - ❖ Knowledge production is a social process
 - ❖ How knowledge is practiced and produced means it is closely linked with experience and cultural meaning
- ❖ Elders are knowledge bearers, language bearers, and cultural bearers



Subsistence (pg. 9)

Reminder – no changes to definition

- ❖ Subsistence encompasses subsistence uses including hunting and gathering activities which are deeply connected to history, cultural, and tradition
- ❖ Subsistence practices and TK systems are inseparable
- ❖ TK informs where, when, how, and why people practice subsistence activities that are central to sharing as well as food and water security
- ❖ The continuation and applicability of TK systems for subsistence depends on ongoing opportunities for people and their communities to practice their traditions as part of their subsistence way of life



Eight protocol guidelines contain the main content (section 4)

1. Demonstrate respect for LK and TK systems
2. Understand and use the appropriate concepts for LK, TK, and subsistence
3. Appropriately and accurately identify LK and TK holders, the social science of LK and TK, and subsistence information
4. Engage in early and frequent communication with relevant entities.
5. Adhere to local and cultural protocols that entities have established for sharing and communicating LK, TK, or subsistence information
6. Acknowledge and account for differences in capacity among relevant entities
7. Build appropriate capacity for working with LK and TK systems and subsistence information
8. Understand how to navigate multiple knowledge systems



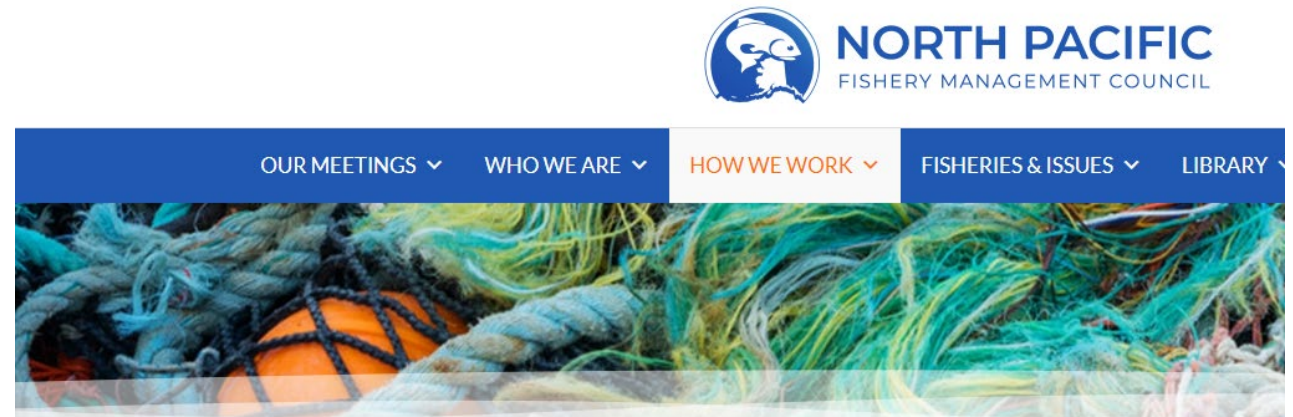

LKTKS policy statement (section 5 of the Protocol)

- Guidelines would become a short and accessible 'LKTKS Policy' statement available on the Council's Management Policies webpage
- Defines the Council's approach to working with LK, TK, and subsistence information
- Does not erase the full Protocol
 - Protocol provides the necessary background and context for understanding the policy statement



MANAGEMENT POLICIES

Management Philosophy and Policies

In addition to meeting various legal requirements, the Council has adopted several important policies to help guide and define its approach to cons: Consultation Policy, Groundfish Fisheries Management, Groundfish Management Objectives, Habitat Areas of Particular Concern, Spatial Mar



Background information on the onramp recommendations

- ❖ 11 onramp recommendations for the Council to consider
- ❖ Different opportunities to incorporate LK, TK, the social science of LK and TK, into the Council's decision-making process
- ❖ Presented as individual recommendations to provide the Council with a highly flexible approach
- ❖ Together the guidelines and onramps are how the Council could achieve its goals of identifying, analyzing incorporating LK, TK, and subsistence information.

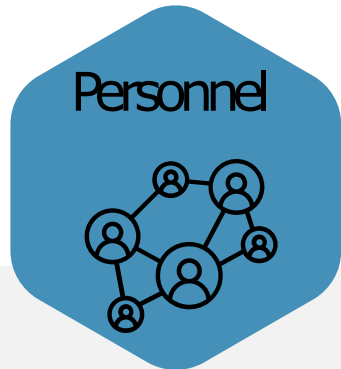

Considering analytical workloads, Taskforce discussed the importance of time

Discussed tradeoffs



Formal partnerships such as a Memorandum of Understanding

Data sharing agreements

Take two to three months at the start

Key for incorporating knowledge systems into analytical documents, scientific/research capacity for new and ongoing projects at AFSC, future workshop planning, and more

The level of resources required for implementation varies by onramp

Analytical staff time

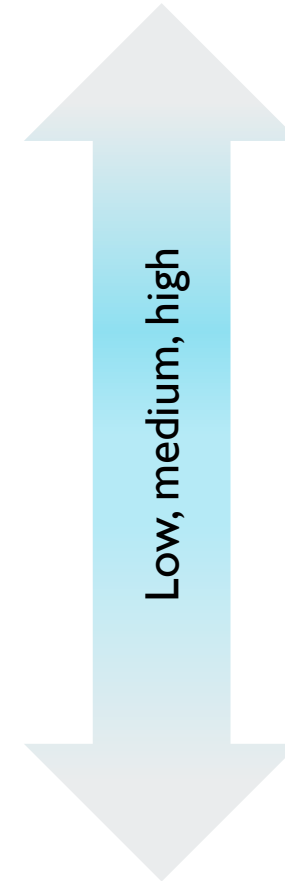
Estimated amount of time required from analytical staff to complete implementation

Council agenda time

Some onramps that require additional work from analytical staff would require additional time on future Council agendas; Council may consider how it wants to balance priorities

Time invested from the public

Some onramps would require additional time invested from members of the public to understand and provide input on how the Council's process could change

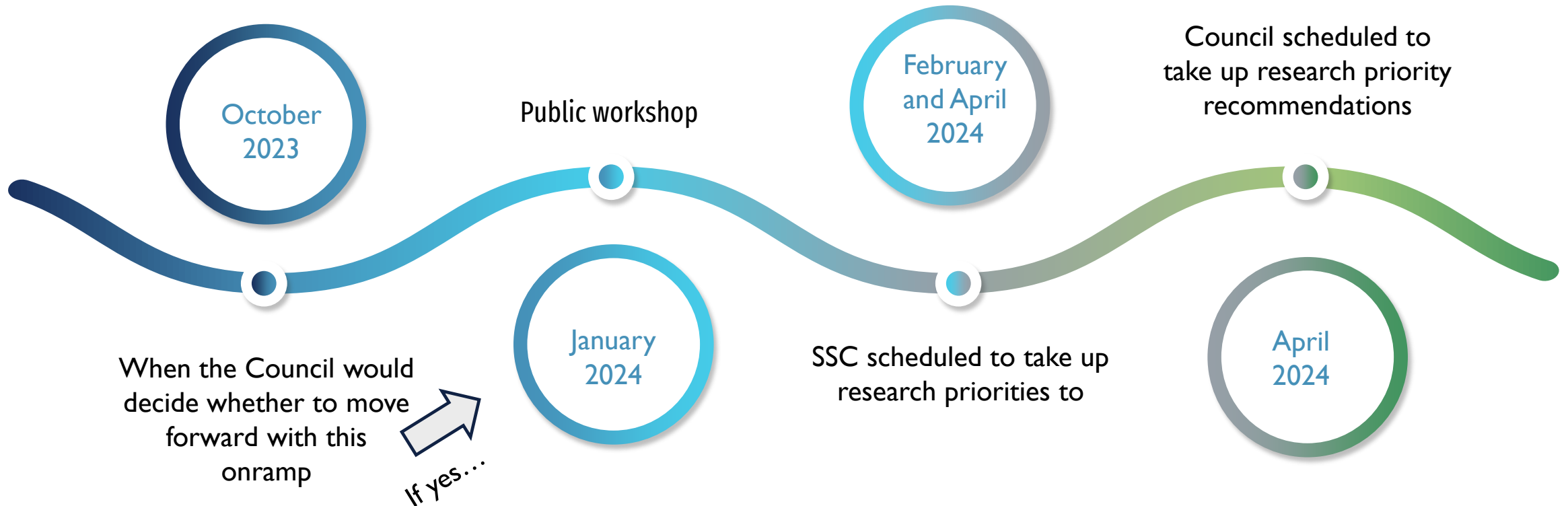

There is a mismatch in timing for the 2024 research priorities cycle and the Taskforce's onramp recommendation



Insufficient time (October 2023 – January 2024) to plan workshop
Recommended that the workshop be used in the next cycle in 2027



The Council directed the Taskforce to discuss public comment procedures

- Would standardizing the public comment time limit across the SSC, AP, and Council to 5 minutes for all testifiers address the taskforce's recommendation for allowing introductions to not count against the oral testimony time limit?
- No
 - The Taskforce did not see this change as meeting the intent of the onramp recommendation to start the timer after introductions are finished
 - Support for standardizing the public comment time limit



How can respect be demonstrated when LK/TK and western science disagree?

Guideline 8

- Common with all forms of data
- Document, cite, and explain these differences when they occur
- Consider factors contributing to different observations
- Council rationale
