1. U. S. COAST GUARD ENFORCEMENT EFFORT FOR 1986. U. S. Coast Guard enforcement efforts for calendar year 1986, through 10 March, have totalled 57 cutter days and 232 aircraft patrol hours. These patrol efforts covered more than 2.3 million square miles of ocean. Combined enforcement efforts have resulted in the issuance of 10 reports of violation and 5 written warnings. Most of the infractions detected have been violations of new regulations, both for foreign and domestic fishing vessels, which were implemented at the beginning of this year. Additional patrol effort analysis is provided in the enclosures.

2. Thus far in 1986 the Coast Guard in Alaska has maintained a level of fisheries enforcement activity equal to about half of the effort provided during the first three months of last year. The outlook for the remainder of the year is that due to budget restraints, we will continue to provide MFCMA enforcement but at a lower level than in previous years.

3. MFCMA INFRACTIONS. The following summarizes the major infractions and enforcement activity to date in 1986.

a. In January, CCGDSEVENTEEN JUNEAU (oil) issued written warnings to the Polish stern trawlers INDUS and TATRY for failure to submit the required activity message twenty-four hours prior to beginning/ceasing fishing operations within the U. S. Fishery Conservation Zone (FCZ).

b. 3 February. USCGC YOCONA issued two reports of violation to the South Korean processor No. 29 TAE BAEK HO for: (1) failure to log product recovery rates (PRR) on a daily basis; and (2) failure to accurately maintain their Daily Joint Venture Log.

c. 11 February. USCGC SHERMAN issued a written warning to the Japanese longliner ANYO MARU No. 21 for failure to accurately maintain its Daily Catch Log.

d. 11 February. USCGC SHERMAN issued a report of violation to the Japanese longliner ANYO MARU No. 22 for discharging oily water over the side.

e. 12 February. USCGC SHERMAN issued a report of violation to the Japanese longliner SHINTOKU MARU No. 25 for failure to have on board an accurate set of vessel plans.

f. 18 February. USCGC SHERMAN issued a written warning to the South Korean stern trawler DONG SAN HO for failure to have on
