#### **Progress on Rulemaking**

#### **Consultation with the Council on Changes from Proposed to Final Rules**

NMFS anticipates publishing a final rule for Amendment 31 to the King and Tanner Crab FMP, Amendments 100/91 to the BSAI and Gulf of Alaska (GOA) FMPs, and the final BSAI and GOA 2015/2016 harvest specifications between the February 2015 and April 2015 Council meetings. Consistent with past practice and our requirements under section 304(b)(3) of the Magnuson-Stevens Act, we are consulting with the Council before publishing final rules that may make revisions to the proposed regulations. NMFS has not identified any substantive changes that would be made between the proposed and final regulations. We note that these rules are still under review, and we will consult with the Council if there are substantive changes.

#### **Emergency Rule Petition**

On December 18, 2014 NMFS received a petition for emergency rulemaking from the State of Alaska co-signed by all six voting members on the Council from Alaska. The petition asked NMFS to "promulgate emergency regulations to reduce the BSAI halibut prohibited species catch (PSC) limits for the North Pacific groundfish fisheries by 33 percent in 2015." The petition stated that "data indicate that a reduction in the BSAI halibut PSC limit by 33 percent, which equates to about 20 percent reduction in actual BSAI bycatch from 2014, would result in an Area 4CDE catch limit of about 0.96 mlbs [960,000 pounds]." Area 4CDE corresponds to a large area of the eastern and northern Bering Sea.

The International Pacific Halibut Commission (IPHC) recommended an Area 4CDE catch limit of 1,285,000 pounds at its 2015 Annual Meeting that concluded on January 30, 2015. NMFS is in the process of reviewing the emergency rule petition in light of the recent IPHC recommendation for Area 4CDE catch limits in 2015.

The review of petitions for emergency rulemaking are governed by section 305(c) of the Magnuson-Stevens Fishery Conservation and Management Act, 16 U.S.C. 1855(c), and the National Marine Fisheries Service's (NMFS) Policy Guidelines for the Use of Emergency Rules (March 31, 2008). NMFS promulgates emergency regulations only in extremely urgent, special circumstances where substantial harm to or disruption of the resource, fishery, or community would occur in the time it would take to follow the standard rulemaking process. NMFS must consider whether circumstances warrant forgoing consultation with the Council, advance notice, public comment, and deliberative consideration of the impacts on all participants in the fishery. NMFS is in the process of reviewing the request for an emergency rule and will provide a response soon.

# **Tribal Consultation Update**

On December 9, NMFS held a tribal consultation with representative from the Tanana Chiefs Conference and the Association of Village Council Presidents. These tribal governments had requested a consultation to discuss the Council's salmon bycatch management measures before the Council meeting. On January 8, 2015, NMFS Headquarters staff held a tribal consultation with representatives several different tribal governments from the community of St. Paul, Alaska. NMFS Alaska Region staff attended. These tribal governments requested consultation with NMFS Headquarters staff on issues related to halibut bycatch in the BSAI groundfish fisheries and the importance of the directed halibut fishery to these communities. NMFS Headquarters staff has the lead on providing a report of that consultation.

# **Staffing Changes**

Karen Palmigiano will be transferring from the Alaska Region Sustainable Fisheries office to the West Coast Regional Office in Seattle on March 5, 2015. During her time in the Alaska Region, Karen worked on a number of BSAI Crab Rationalization Program rulemaking projects and served as the project lead to develop and implement the cost recovery program for the AFA, AI Pollock, Amendment 80, and CDQ programs. While we will miss Karen as a member of our staff, we are pleased that she will continue her career with NMFS as part of the West Coast Region team.

Sustainable Fisheries published a recruitment announcement for two fishery management specialist positions from January 7 through January 20, 2015. These positions could fill a variety of analytical and rule making roles within Sustainable Fisheries depending on the specific expertise of the applicant. These positions could fill gaps we have in both our Catch Share Branch, Ecosystem Branch, and in our vacant Observer Program Liaison position. We hope to complete the hiring process in the next month and have the new staff members on board as soon as possible.

#### **Inseason Management Report**

#### **Bering Sea and Aleutian Islands**

#### **Bering Sea and Aleutian Islands Pollock**

NMFS reallocated 1,900 mt of CDQ Aleutian Islands pollock TAC to the CDQ Bering Sea pollock TAC. The Aleut Corporation has stated that it plans to have vessels fish their Aleutian Islands pollock TAC. At this time, NMFS does not plan to reallocate Aleutian Islands Aleut Corporation pollock to the Bering Sea subarea.

#### **Aleutian Islands Pacific cod**

Nine vessels have reported 1,439 mt relative to 5 vessels reporting 23 mt in 2014. NMFS is setting a 2015 non-CDQ Pacific cod directed fishing allowance around 6,400 mt. In 2014, NMFS closed the Federal Aleutian Islands Pacific cod directed fishery on March 16, 2014.

#### **BSAI Hook-and-line catcher/processors**

This sector has similar catch rates in 2015 relative to 2014.
