Subject: Advisory Panel Membership, End of Two-Year Term on December 31, 1978.

At the October 1976 Council meeting in Juneau, the Advisory Panel Membership was formally approved for a two-year period. The Advisory Panel's charter, however, was not approved by Washington until April 1977, but the Council has chosen to use the first effective meeting date of December 1976 as a starting point for the two-year term.

At this time, it is appropriate to consider all nominations for the next two-year appointment to the Advisory Panel. These nominations should include those who have submitted their names previously, as well as those on the Advisory Panel wishing to continue.
