Preliminary 2023 IFQ Vessel Cap Information

February 2023 Council Meeting

The Regulatory Impact Review analysis posted for agenda item C3 includes IFQ vessel caps through 2022. Final 2023 IFQ allocations and vessel use caps have not yet been calculated and will be published on the NMFS website¹ when available. The following tables represent preliminary estimates calculated based on 2023 IPHC fishery regulations.² Table 1 reports the commercial fishery landings limits published by the IPHC and calculates estimates of IFQ allocations by area (subtracting CDQ allocations of 4B 20%, 4C 50%, 4D 30%, 4E 100%). Table 2 displays these 2023 annual catch limits and the vessel cap calculations (1% of 2C halibut IFQ TAC of 3.41 million pounds for 2C; and 0.5% of all halibut IFQ TAC of 17.806 million pounds for all areas) in a time series beginning in 2013 (an update of table 4 included in the analysis).
