# Background

# February 2018 Council Motion

### Problem

"Some quota share holders hiring a vessel and crew to harvest their IFQ while they are onboard but not actively participating"

- Inconsistent with objective of owner-operated fleet
- Uneven distribution of rents between the "walk-on" and vessel
- Exacerbating lack of access for second generation fishermen and new entrants

# February 2018 Council Motion

### Problem

"Some quota share holders hiring a vessel and crew to harvest their IFQ while they are onboard but not actively participating"

- Inconsistent with objective of owner-operated fleet
- Uneven distribution of rents between the "walk-on" and vessel
- Exacerbating lack of access for second generation fishermen and new entrants

#### Proposal

Explore eligibility requirement based on *recent* participation in any US commercial fishery

- 30, 60, or 90 days over fixed 3 or 5 year period
- Applies to prospective and existing quota share holders

# **Current Eligibility Requirements**

### **Transfer Eligibility Certificate (TEC)**

- 150 days as harvesting crew
- Any US commercial fishery
- Any time period
- Self-reported, reference required
- Public notary



Those persons applying to receive Quota Share (QS) or Individual Fishing Quota (IFQ) by transfer must submit this application to the Regional Administrator, to obtain a Transfer Eligibility Certificate (TEC).

# **Outstanding Decision Points**

- Future eligibility requirements (after qualifying years)
- Procedure if fail to meet eligibility
- Scope of eligibility requirements
  - Individuals leasing IFQ
  - Non-individual QS holders

# Ability to Achieve Objective

- Could incentivize active fishing or quota sales
- Self-reported sea days/activity
- Qualifying years in future allow strategic behavior
- Difficult to enforce specific activity while onboard a vessel
- Limiting QS holder onboard but not participating vs. not onboard

# Potential Impacts

Increase active fishing days

- Safety issues
- Displaced crew

Relinquish/transfer quota

- Loss of fishing identity
- Financial impact
- Impact to entire operation
- More active QS market, ↑ supply/ entry opportunities, price changes





Figure 1. Days fished by individual listed as "delivered by individual" on IFQ trips 2014-2018 and 2016-2018 total and by IFQ species landed (note different y-axis).<sup>8</sup>

 Distribution of days for "delivered by individual" on IFQ trips (Figures 1-5)
