Introduction

- Given the MSA program review requirements and NOAA allocation review requirements, the Council workload for meeting these requirements are becoming increasingly challenging

Program Review


- MSA Section 303A requires regular reporting and evaluation at 5 years after implementation and thereafter every 7 years to ensure the goals of the Program and MSA are being met
- Catch Share Policy 01-121-01 (2017) provides a comprehensive and targeted approach to conducting program reviews
- Guidance outlines general approach, scope, and use of standardized approaches
- The review should not be restricted to a specific length and should provide sufficient background info to understand the analysis contained in the review
- Workplans for program reviews should be included as part of the program review
 - SSC has made extensive comments concerning the importance of workplans



 Provide transparency and allow the public to provide input during the planning stage

Allocation Review

- In 2016, NOAA issued Fisheries Allocation Policy Directive 01-119 which describes the mechanism for ensuring fisheries periodically reviewed
- Directive established three step process
 - We are focused on step two
 - Ensure transparency
 - Review of FMP objectives
 - A clear articulation of how the objectives are or are not being met
 - Clear rational on relevant factors considered



Council's Approach to Allocation Reviews

- Since establishment of the allocation review triggers in 2017, the Council has completed 3 allocation reviews
- During review of the CGOA Rockfish Program/Allocation review, the SSC noted there are two approaches for addressing allocation review requirements
 - 1 the scope of the allocation review is addressed within the program review
 - 2 for allocation reviews that are stock specific TACs (BSAI & GOA Pacific cod for example), a separate allocation review would be needed
- As a tool for addressing stock specific allocation reviews, the Council has since narrowed in on dashboard metrics as primary methodology for these reviews
 - Since the development of the first dashboards (BSAI Pacific cod), AKFIN has since formally developed annual dashboards for BSAI Pacific cod allocation
